**UNOPPOSED MOTION BY THE VICTIMS FOR EXTENSION OF TIME
TO FILE REPLY IN SUPPORT OF MOTION PURSUANT TO RULE 21 FOR JOINDER
IN ACTION**

COME NOW Jane Doe #3 and Jane Doe #4 (also referred to as “the new victims”), by and through undersigned counsel, to file this unopposed motion for a short extension of time to file their reply in support of their motion for joinder in this action.

On January 2, 2015, the new victims filed a (corrected) motion for joinder in this action (DE 280). On January 20, 2015, the Government filed an opposition to the new victims’ motion (DE 290). The opposition raised several complicated issues, including issues surrounding a heretofore unmentioned statute of limitations: 28 U.S.C. § 2401(a). Counsel for the new victims wishes to carefully research issues related to the statute of limitations, as well as coordinate an additional filing that is related to the statute of limitations. Given counsel’s schedule, concluding this research and preparing the additional filing will require additional time. Accordingly, the new victims seek a nine-day extension of time to file their reply until Friday, February 6, 2015.

Jane Doe No. 1 and Jane Doe No. 2 support this motion. The Government does not oppose this request.

Accordingly, the Court should grant the new victims an extension of time to prepare their reply.
