Congrats on being able to gain experience through such a case!

Attached is the 'Contact Report' from VNS. VNS is the Victim Notification System which allows us to meet our legal obligation to notify and provide rights to victims of federal crimes. The system is tied to FBI, USAO, BOP, USPIS and the Marshalls. Victims only need one login and password to track the entire legal life of the case.

The **contact report** shows all the information that is currently recorded in VNS. The **TOTAL VICTIM** list is from SA ██████████ and contains all victims that have been identified. The **review** is what I was working on, on the high side. The details I need are on the high side email I will send you shortly after this email.

Our goal on the victim services side is to make sure all victims are in VNS and that ██████████ has worked her magic with them. The 'math' is the **Total Victim** sheet (all victims) minus **contact report** victims (already in VNS) equals the **review** spreadsheet (still need to be added to VNS, and has missing data).
