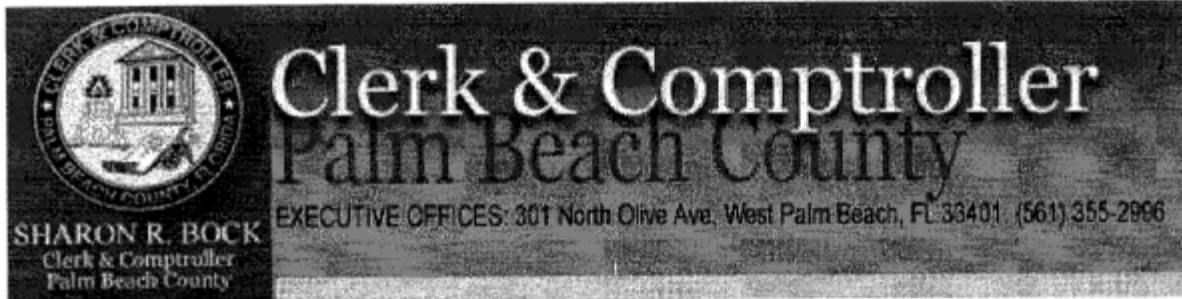
I have attached a comprehensive report which did not show any negative information. He is a licensed pilot.
