I reviewed the layout and comments fro= our 4/14 conference call with Tom. Attached are two options for the=living room layout. We will model this in 3D for your review, but I want to address the location before we do that.<=span>

Option H2-1 is our recommended layout.=/span>

\* = The pool has been relocated based on the=survey.

- \* = The living room is centered on the pool.
- \* = There is not enough room between the living room and pool for the floating square stair, so added a stair connecting that area down to the north terraces.
- \* = To avoid having a "canyon" between the living room and office, we added a restroom below the west planter. We also added a storage room below the planter on the east side.

Option H2-2 is just to show the impact of we add the floating stair. It puts the living room 8'-10" off center from the pool.

Please let us know if you have a preference, and we will complete the 3d model of this area (will take about 1 day once we have a direction).
