She's also going to request help for the nights as well Sh= just wanted to review this with you She herself is truly overwhelmed I sp=ke with him last night and his speech is very garbled and his answers are =omewhat confused. Just wanted to keep you informed I know [REDACTED] was antici=ating that you [REDACTED] would be by today . Just think she needs reassurance =hat with it to support her and I have done that My senses seeing him is go=ng to be very demanding emotionally As I Said speaking to them every day i=viting her how to utilize and intervene with the hospice program I'l= keep you informed
