First of all, I hope that you are well wherever in the world you are!

I am sincerely and very very sorry that you thi=k that I was un-polite when we last met. I asked the question to show my i=terest for Reid Hoffman and his background – NOT to be shameless, =old, and with no other intention than to show him that I was interested. I=felt that it was too egoistic of me to sit there and only speak about my t=ip to [REDACTED] and myself. May I kindly ask, in this particular situation;=what would you have advised me to talk about? What questions would have be=n fine to ask? I must note, however, that it was such a privilege to meet =ou again and Reid Hoffman that morning.

I went to [REDACTED] th= 8th of December as planned but a problem arose. I had, prior to departure= had meetings with the person responsible for visas at [REDACTED].
