Please see the below figures which show the estimated cost per tree delivered to LSJ using BIG N

If we purchase 100 trees it will come to about \$ 333 per tree and if we purchase 200 trees the cost will be \$ 308 per tree.

The only missing piece is the docking fee at the Port (I have left several messages to the Port Authority to get this information and have not heard back as of yet)

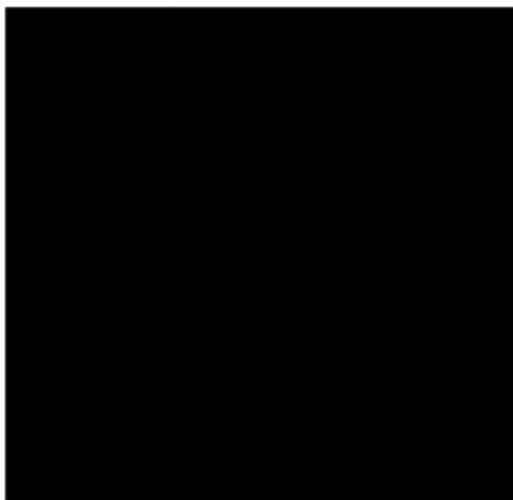
