I've proposed the following plan to Jeffrey:

- 1) He swings by my house in Noe Valley and picks me up at 10:30 tomorrow morning. I live at [REDACTED], near the corner of [REDACTED], in the Noe Valley part of San Francisco (which is very near the freeway entrance).
