Dear Mr. Davis:

First, your response to Peggy Siegal that you left a number of messages for me that have not been returned is simply false. I carefully reviewed my detailed databases and found absolutely not even one message.

More importantly, Peggy, a single woman in her mid sixties with no support, and who relied upon you to take care of her, asked you to review her business because she believed that she was being taken advantage of. You, Peggy and I agreed more than six months ago that you would undertake, immediately not a full audit, but a full random sampling of both past and recent billings to determine how much money Peggy was owed. Afterwards, a revamp of her current tenuous circumstance driven by your suggestion was to take place. Yesterday, during our conversation, which I have memorialized, you made it very clear that you have done nothing that you said you would.
