While on site before your visit, Laura Lyn from Vintage Piano Workshops, noted some issues with the piano. She found a number of the hammers where sticking and as she mentioned to you last year, tuning pins where loose. She was unable to tune the upper register to the level she really wanted and recommended that work needed to be done

I asked if she could forward an estimate, which is attached. It is quite hard to read, hence what follows is a breakdown

<i>Replace loose timing pins - 6 hrs @ \$100 per hr.</i>	<i>\$600.00</i>
<i>Action Keys - Rebush Front - as needed</i>	<i>\$200.00</i>
<i>Rebush Balance - as needed</i>	<i>\$200.00</i>
<i>Recondition etc Hammers</i>	<i>\$400.00</i>
<i>2 Trip Charges @ \$100 each</i>	<i>\$200.00</i>
<i>Tuning</i>	<i>\$250.00</i>
<i>SubTotal</i>	<i>\$1,850.00</i>
<i>Tax</i>	<i>\$112.16</i>
<i>Total</i>	<i>\$1,962.16</i>

The Timing Action is to be removed, once in the shop there are frequently additional repairs that need to be made. Therefore the estimate cost may be as much as 20%

If anything major is found the owner will be notified before any additional work will be completed

Please note this work will take approx. 3 to 4 weeks
