Daphne,

JE just stopped me with a few request. Please find below:

- 1) Replace busted washing machine. (tired of chasing parts) - Please forward the Make/Model
- 2) Order 40 more coconut palms. Chris to tag. Wants to plant trees at top of hill before road work. ASAP - Chris will be travelling to PR on Monday, September 16 to tag - Ingrid has been contacted
