Dear Dr. Nikolic,

Parasight Ltd was founded two years ago in Israel in order to develop a platform technology for blood analysis and parasite detection. During this time, Parasight has focused on developing an innovative device for the accurate, rapid and inexpensive diagnosis of Malaria, suitable for POC and labs in Malaria-endemic countries as well as blood banks everywhere. The device is based on the latest technologies in the field of machine-vision together with breakthrough advances in sample preparation and staining.

Following Mr. Barak's communication with you, we are proud to present the official report describing the results of our first clinical trial, which was conducted recently in India by the National Institute of Malaria Research. As the report indicates, our clinical accuracy is on par with PCR, but with ease of use and cost commensurate with RDTs. Additionally, I am attaching an executive summary describing the

company. Our goal is to introduce Parasight's technology to the Gates Foundation in hopes of advancing the project and reaching the target population.
