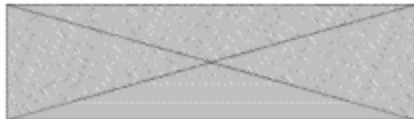
Currently you have 2 Mid Continent Control video switching modules (MCC P/N 103004-1), composite video, controlled through the CMS switch panels.

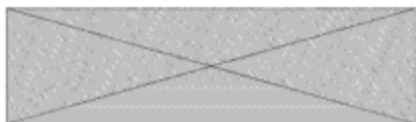
