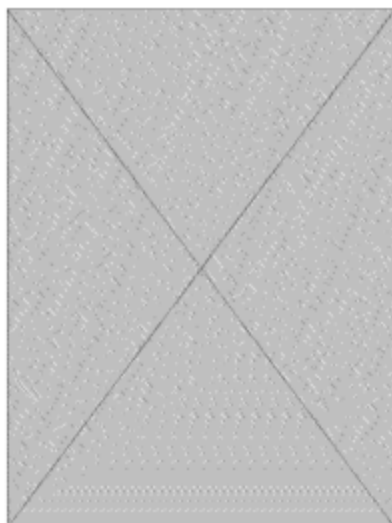

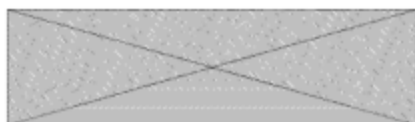

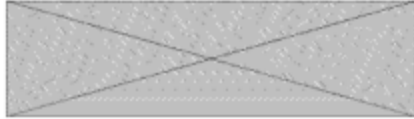
Three (3) 1.0" scoops will be formed into the underside of the fwd table leafs (exposed when leaf is folded on top of the main table) for pens, glasses, etc.

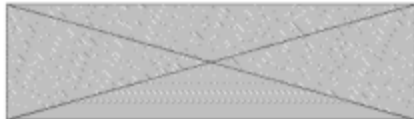
