hunter has multiple models and this is the white like the existing one you like for inside

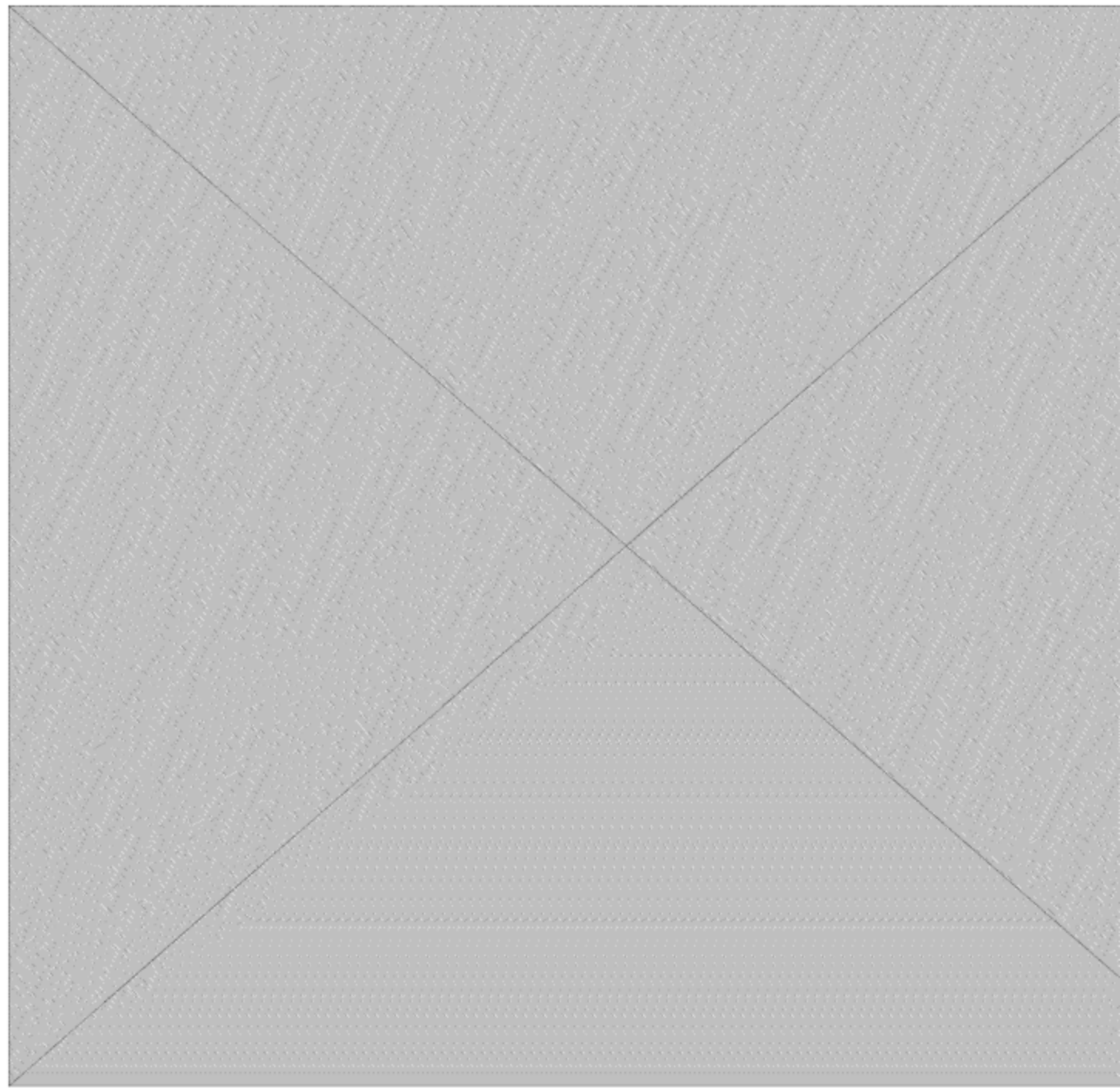
It is not made for exterior .their web site has several white fans but none match,when you have a sec. you might look at their site and pick the one you like.we can get 3 speed remotes for them as well
