7.5 was my initial amount asking amount, less at the time because I didn't at the time see how bad this was. I had to adjust this amount.

The rest was spent on setting things up, including the philipines team, the hacking team, survey, servers, cost of my initial designers for the template, which I don't use any more.

Their were separate payments to stephanie and other hackers but I don't remember the exact dates or amounts because they don't give receipts but I'm reasonably sure they were part of the initial funding round. I do know there were several passes with the hackers because of all the wikipedia crap we were having to overcome. I will try to sort it out with al when I reach him.

Sorry I wasn't clearer. Here's my recollection....there was a bunch of money in the beginning that went to various people to help get this project off the ground....

stephanie was one of the people working for Al setting up the links in the beginning. I'm not sure the exact amount she received but I'm pretty sure it was more than \$2500. She is also no longer working for us.

Additionally, there were other people in the beginning who were paid to do the initial survey, program the sites, my hackers, al's hackers. Out of all of this my initial payment (my cut) was around \$7500 or so...the reason I recollected as a few thousand was because most of my cut went to get my best friend caught up on her rent.

Sorry for the messy accounting, will try and touch bases with Al later today to clarify.
