At TED when we met and discuss first time, I did tell him that Bill committed around 100M. And that if makes sense I can invest in various company in science and tech.

His 25M previously undisclosed investment at the same discounted valuation made me look like an idiot and it triggered bgi to look into more details.

I told bgi that there is no more investment coming in (until a large one from Goldman that would increase valuation to 2.2 or so) and that we are the only one to get this valuation at this time point.

I ended up looking naïve and stupid.

I do not know what Kleinier told bgi re Hosain.

I just know that Kleiner did very poor diligence – please note that they entered in the higher valuation of 1.5B!
