3100€ (Robinson R44 for 10Aug Patmos to Athens, flight time 1h 30mins), **USD 3885**

Total Cost: 4800+2250+3100 = EUR 10150 (all incl) / or 6016\$+2820\$+3885\$= USD 12'721
