# THE HIDDEN ASPECTS

For many ages investigation and research have been primarily centered upon the plant and animal kingdoms in pursuit of the energies and healing qualities contained therein. However the mineral kingdom of nature has not been brought forward nor understood in all that it is or all that it can be utilized for. Mostly this kingdom has been totally ignored or there have been centered around it, myths, misconceptions and other facets of human nature such as glamour and greed. Only a handful of persons have attempted to peel way some of the aura of mystery which surrounds the earthly dominion of the Celestial Gem.

Let us begin here by saying that since all things are of the One Universal Energy, everything that physically exists is an external manifestation of an energy form, or vibratory rate, or combination of rates. The mineral kingdom manifests the lowest vibratory rate on the third dimensional Earth plane. Therefore the mineral kingdom is the building block of which all things on the physical plane are made, be it vegetable, animal or human in nature. This can be equated with the body framework that holds the flesh, muscles and other necessities sustaining life together.

With this understanding, we can then see that our physical vehicle or body is a compound form of organic mineral. Since the Earth and all of us are one, for we are of the Earth and of the elements of the Earth while here, the Earth itself is like a physical body made up of the same elements which compose every other manifested form. It **therein** has a network of veins and arteries leading to the "heart **center**" and other key areas of the Earth body. These veins and arteries are made up of large collections of minerals such as are found in mines and lead deep into the Earth. The various crystals found in rich mineral veins can be likened unto the individual corpuscles that travel or transmit upon those arteries.

Each mineral crystal has its own special individual influence, function and vibration. Inherent within the evolution of the mineral kingdom exists the vibratory rates that heal, energize, attune and uplift the spirit of our very inner beings. There are no two crystals alike as indeed there are no two atoms that are identical. Each gem or mineral is a crystallized sound vibration which emits its own unique individual musical note. This can be "heard" by discerning ears especially in the proximity of large mineral collections.

Before we can go on to bring forward the physical, or what is popularly called the healing qualities of the **genstone** field, it is important to emphasize just how and why this would be so in the first place. We can start by saying that no gemstone works directly on the physical body although the frequency and magnetic field that surrounds and **emenates** from a particular mineral will affect the physical vehicle of man. However, just because one touches or rubs a certain stone does not mean that it will cure or change anything immediately.

Their energy patterns or wave lengths do serve mankind in multiple ways, some working from the non-physical levels downwards into the physical plane, some working from the physical plane upwards and yet others never entering the gross physical level at all. Some frequencies are conducive towards meditation, -inspiration, reflection and so on, while others affect our bodies physical health as stabilizers, balancers, etc, and still others serve as **attunements** that in some manner can reflect past life experience needed for special purposes. All evolved gemstones do make their necessary contribution to human development but some do so on a more conscious wavelength. Unless a gemstone emits a negative forcefield that might become too absorbative and overdo a virtue, none of the gems in this work except for a few noted exceptions could harm a living human being.

This does not mean that superstitions and old wives tales do not have a basis for being. But it is time to bring these myths out of the darkness of ignorance and into the light of reality in this and several other kingdoms as well. A good example is the concern over unlucky stones vs lucky stones which drags people into emotional retardation of their thinking. The only facet of this that has realistic background is that a **persons** thought forms can and do impregnate mineral and gem matter, which can rebound back upon the sender in much the same manner as the law of cause and effect on all levels. Therefore what makes a gemstone unlucky are the unfortunate thoughts of the unfortunate owner of the particular stone in question, as no gem holds or emits its own diverse and malignant intent.

Mans thought forms of a greedy and vicious nature that surround the more glamorous and sensational gems, and even the lesser gems to a lesser degree, need to be dissolved and replaced with understanding of the true significance and purpose of the mineral kingdom. This is what in actual fact validates this book, else everyone who is simply interested in wearing the most spectacular gem that they individually can afford would not be truly interested in investigating this kingdoms ability to communicate on its own level with humanity.

A gem does hold an intrinsic potential which will be described and ascribed to in many ways and levels, but how this potential is fulfilled depends to some extent on what you, as the creator in this elemental kingdom, put into it. The mineral kingdom as an evolving entity has, as other kingdoms also, an affinity for man who is also a higher force field of vegetable and mineral particles of matter. Therefore the more highly evolved gemstones that are at mans disposal are just as much his responsibility as are the plant and animal kingdom, if at no other level, then at least the level of his thinking about it.

There is no such thing as dead or inert masses of matter in this or any other universe. A gemstone is a living, vibrating, essence of molecules just as man is but without the power of locomotion, speech, etc, yet what it can accomplish in its own sphere is just as wonderful as what man can gain in his.

In truth the mineral kingdom is waiting to be exploited by the imagination and positively motivated thought processes of man, because the benefits to be derived from these sources are indefatigueable. They are not only self-contained but essntially everlasting as there is no disintegrative process involved here. A gemstone that one wears or is in tune with is there to be tapped for as long as the need, as a gem does not have the disadvantage of wearing out.

We are then on the threshold of showing to the consciousness of man in general the great reservoir that can be utilized in ways and manners not recognized yet by modern man. In the ancient kingdoms of mans evolutionary spiral the natural orders were more in use and respected for their potential properties. Modern thinking and hope is heavily centered on the scientific laboratory. What is made and devised by the mind of man in his clinical and sterile workshops is wonderful and **marvelous** to behold, but in the final analysis cannot compare or compete with what is being devised and set into physical manifestation by the inner logos of cosmic creation. This thought needs to be kept in mind when this treatise is being read.

When a gemstone is subjected to a critique which discusses its attributes and potential properties, one must also remember that unless otherwise specified these properties are subject to development of resulting effect by the minds of those involved with the making and wearing of any item indicated.

## BLACK MAGIC — VOODOO

To understand the mineral kingdom is analagous to understanding the process that energizes the universe, this one and all others, and to recognize the lack of inertness that this and other kingdoms are credited with. We are bringing to the attention of the minds of those who are fascinated with this subject the unlimited scope of all the kingdoms that nature offers to unfurl at ones feet, including human understanding as well.

In recognition of the fact that man during his development has always tried to manipulate the energies and forces, seen and unseen, a certain amount of information concerning this aspect of gems and minerals seems advisable so that perspective is gained in the total circumference surrounding this very mystifying but much neglected area of the employment of gemstones.

Again noting the paragraph where lucky and unlucky stones were mentioned, there were and still are areas of the world that purposely create magnetic forcefields around certain gems and pieces of jewelry for the express purpose of creating personal domination and imposition of ones will over anothers will in whatever form or manner it is wished. This subject is popularly known as Black Magic, Voodoo, etc, which is nothing more then prostituting the same positive energies and denigrating them to personal use for selfish motives.

What is possible to do at an extremely high level of altruistic endeavor may also be degenerated by the minds and level of the user. In reality, this is what constitutes the difference between manipulating a gem to heal and to energize ones potential creatively for the highest good, or what it means to take and use something that belongs to another and turn it to the users advantage in a parasitic way.

As an example, it has been referred to in various metaphysical works that many who lived in Atlantean times used energies for illgotten ends. To amplify this, there did in fact exist a level of the priesthood that had much knowledge of operating natural laws in unnatural channels. Towards these ends they used some very finely faceted crystals with tremendous electro-magnetic frequency power. Now in manipulating mens minds with these crystals much evil was created, but to reverse this example, there were also great benefits accrued from the medical and surgical techniques developed utilizing these identical crystals as laser beams through which great amounts of healing and progress were accomplished. Some of these same methods will become uncovered once again.

We as instruments of greater power than any object of nature in the universe, aside from those beings past us in their evolvement, can direct our thoughts and beam light waves of energy to create greater miracles than the scientific laboratory declares to be the ultimate in the now. It is the potential of mans mind that has been so vastly under-rated. Therefore when we begin to discuss the various potentials in healing properties of a grouping of gems and minerals, remember that what lies at the basis for the magnification and the transmission of healing powers from that gem to the subject remains the strength and development of the transmitter.

#### HIGHER GUIDANCE

A horticulturist knows that a flower will grow in one form of ground, or mineral deposit, and not in another. Certain other minerals and their vibrations must be added or subtracted to allow proper growth and expression. So it is that we, who are but flowers in the garden of Earth, on occasion find ourselves in need of a certain vibration which we are missing that would benefit our growth. Thus we are led by our own inner higher guidance, consciously or unconsciously, to seek some form of vibrational additive which in many cases can be supplied by the presence of a gem or mineral.

Without prior consideration many individuals have experienced the desire to have a gemstone in their possession, perhaps to wear, or to carry in their pocket, or even to fondle a gem carving of their own. In most cases there is a need for that particular gemstone vibrational additive of which the idea is being projected by ones own higher aspect with the desire being a response to this intunement.

Another way one can experience guidance is in the example of selecting a small quartz crystal from a box full to have one to carry. During handling one may seem to "feel" right for ones own reasons. Though no two crystals are alike, many crystals would do with perhaps the one selected being the optimum for fulfilling the prevailing need.

In general we have been guided to live in the geographical location of our daily **existance**. As required, we are led to move towards or away from areas with high mineral content as their vibrations are a constant additive to our auric field. Sometimes the doctor is inspired when recommending a change in scenery which is a change in vibrational environment.

Let it be made clear that there are no "bad" vibrations coming from the mineral kingdom in any form. It is merely a matter of each individuals complex vibrational makeup showing balance, specific shortages or overabundance which in turn reflects all that is added or subtracted from it. This is always a fluctuating condition as we exist in a state of constant exchange with our personal environment.

#### DETERMINING YOUR GEMSTONE

Many who are well in tune with their own higher guidance have no problem in determining what gem or selection of gems they need to wear or to have in their presence. There are others who feel that they would like to wear a gemstone but are unable to decide which one or ones to acquire. It is then that they turn to others for guidance which can come through inspirational ideas from family and friends, or from one who specializes in gemstone intunement.

To attune oneself to the needs of another is an art that only one who has developed insight into the multitudinous levels and layers of human existence can deign to enter. This is a requirement here or in any category where human assistance through spiritual insight may be gleaned and shared. Individuals qualified to engage in this form of healing art are extremely few. Without conscious understanding modern day persons who work to manifest wearable articles of a gem nature serve only a fraction of the purpose that is actively necessary for the balanced welfare of mankind. There are, however, many developing young people that are previously programmed and trained to fill this gap in human need and it is held that this work will help ferret out future potential qualifiers in this ongoing, up and coming art form which is a humanistic contributor to raising the general level of mass consciousness that will continue to multiply far into the coming age of Aquarius.

#### **GEMSTONE EFFECT**

There are many ways in which gems can affect the wearer but the mechanism that elicits response when a gemstone is worn anywhere on the body is the etheric web that lies outside the field of vision. The **etheric** web is the grade of matter that lies closest to the physical particles of matter and serves man as a bridge or link between his higher bodies and the physical level. It picks up the wavelengths or frequencies of the stone and pulls these vibrations into whichever of the force center vortices that are open and absorbing within the individual. This is like a place of departure or jumping off spot from where the individual qualities and attributes of the gem will make their way up the vibrational scale into the mental, intuitive and soul levels, or down into the gross physical matter that man is bound up in.

The supposed necessity of having to wear the gem in direct contact with the skin in order to gain its benefits, as has been taught in the past, is passe for the most part today as both the gemstones and modern man have greater receiving and transmitting power of that which is placed into the auric field. Openings on the body side of a worn gem object will make it more efficient especially when light refraction can be amplified such as when using transparent or translucent stones. There are always exceptions to the general rule, of course, and there still remains circumstances where taping a gem to a specific area for therapeutic value will benefit, though more so with direct guidance.

There is no instant change caused by gem contact, but those who are **sensitive** can feel changes in body activity immediately upon wearing certain stones. Others gradually observe a strengthening back to normal within themselves. Looking at just the physical aspects, the gemstone vibrational additive, when applied to a **deficient** body, can induce the resump-

tion of normal function to a lagging organ or area. By adjusting glandular activity, pathology can be reversed when caused by lack of applied vibration.

There are also **vibrational** frequencies that can initiate activity in development and spiritual **unfoldment** as each individual readies himself or herself for additional receptivity.

In the not too distant future when man comes into higher **conscious**ness and more specific healing information is known of the various minerals, the thoughts and understandings given with a **gemstones** application will go far towards helping to raise or transmute the senders vehicle as well as the receivers. Guidance will be given as to how to instill special creative thought forms into crystals when broadcasting through them. Those individuals who work with gems and minerals are aware of this to some degree already.

## SYNTHETIC GEMS

The simulated gem crystals with their simulated energies that are being grown in the laboratory today are an entirely new concept that man *is* experimenting with in order to attempt to emulate and attain the same, if not superior, control of the natural elements of nature. This, you must understand, is in reality a temporary phenomena which will come to naught in the long run as the frequency that man places into these crystals are impregnated with his own imperfect thought forms and limited ideations. These enter somewhat into the astral and desire realms which are in actuality much inferior to what is produced by divine or natural, guided evolution through pressures and upheavals in a kingdom that no man, no matter how finely attuned or evolved, would ever truly want to manage, manipulate or alter.

This conclusion, of course, will be a long Earth time in coming for the basic structure of the blockages and congestions that form the scientific ego in this day and age of supposed scientific advancement must be cleansed, elevated and understood in proper perspective. A synthetic gem however finely crafted serves only those whose frequencies are attuned to those who manufactured them. As far as this treatise on gems is concerned, synthetic gems are worthless for the purposes of therapy that one may be striving for.

#### BIRTHSTONES

Much erroneous information regarding the wearing of **birthstones** continues to be circulated for the convenience of the commercial jewelry trade. Confusion prevails as there are no two lists of birthstones available in all of literature that agree in entirety.

The esoteric meaning and relationships of minerals to the twelve signs of the zodiac are lost to all but a few higher **intuned** individuals. Birthstones are not at all a personal messenger of good fortune but are conductors of equilibrium through the doorways and gates of **vibration** that each cycle and season of the twelve earth months brings towards man. The original concept was to have twelve different gemstones, one for each sign of the zodiac, so that one might wear the gem that would be the most harmonious and complementary to the particular zodiacal configuration affecting the Earth planet with its vibrations at that moment. The twelve zodiacal energy patternings are significant to each individual to a different degree, for each human being has within them various degrees of all twelve energy patternings.

This is not to say that everyone should have twelve **genstones** of different types around them at all times, but by utilizing the listings shown herewith each can come to his or her own conclusion regarding the **suit**-ability of many gems **as** regards their own person and **moreso**, the realization that no person is limited to only one alleged birthstone belonging to **ones** birth month.

Because stones of gem quality transmit so many different kinds of energy patterns it would be rather limiting and foolish to presuppose that we are not allowed or permitted to wear or utilize a particular gem if we are drawn to **such**. Recognizing this factor, more and more individuals are being drawn to having an assortment of minerals and gems to wear, handle or carry as they feel directed from within.

The **gemstone** interchange seen in the various headings of the assorted charts presents to humanity one of the key triggers in uniting his lower principles with the higher. They contain clues yelling loud and clear that man cannot be treated as a fragmented being for a physical ailment when the mental and emotional factors are quite attached as well.

The supportive external reasoning behind having only a selective one or two of anything that is strictly on a personality bias, will become defunct because of the integration of the energies that are working together to cohesively bind and create whole reflections.

We as man who wish to understand on a more total level can see that nothing indeed is separate, any more than man is separate from his eternal source. Unity through diversity will be more truly comprehended and the reason for the great variety for individuals to choose from will be understood for the inner values as well as the outer ones.

## PRECIOUS vs SEMI-PRECIOUS GEMS

Originally and far back into the mists of time as we know it, jewelry was much more than mere adornment. It was symbolic, mystical, healing and well known as a transmitter of energies. The precious stone category as outlined by fashion and jewelry experts is mostly set by the supply in relation to the demand. This is so today but is now becoming more flexible and less rigid in its standards than was the case even just ten years ago.

In actuality, there is no such thing as a semi-precious gem. All stones that have passed a certain level in their own evolution are precious, no matter how common they are classified. This includes the enormous Quartz family along with its agates and jaspers that have for so long been held in disdain and as step children by many in the jewelry profession. The great influx of lapidary hobbyists doing professional quality work has been a tremendous turning point in recognizing beauty and power and this is greatly affecting Earth residents.

#### **EVOLVING vs DE-EVOLVING MINERALS**

Another primary subject to be touched on briefly is that as the human kingdom evolves on the spiral of perfection and growth, so too does the animal, vegetable and mineral kingdoms in their fashion. Each gem and mineral continues to evolve by altering its structure and molecular activities thereby serving the Earth planet in different ways in each phase of its growth. Existing minerals that have already served or fulfilled their planetary purpose are in the process of being phased out of existence, yet they too are utilized during the various phases of their de-evolvement.

Just as, at this moment in Earth development, the Diamond is the most powerfully evolved mineral gemstone from the standpoint of pure light refraction, so too will there arise and come into existence other gems of like vitality even more highly advanced. At the end of Earths planetary cycle, after **un-imaginable** lengths of **measured** time, there will stand seven dynamic gems of perfect responsibility at least as powerful as the Diamond representing the seven basic energy rays to the heights of their development. Just so will man advance in his understanding and in the development of his hitherto untapped sixth and seventh sense abilities just now beginning to be felt by some. Hence, this current "occult explosion syndrome".

#### COLOR SPECTRUM AND COLOR THERAPY

It is worth mentioning that each individual has a particular color spectrum that they are working with for the major portion of an embodiment. As an example, one may have chosen to work along strong transmutational lines in many of their waking and sleeping activities. The predominant portion of their "personal color spectrum" to infiltrate their auric field would be from the ultra red to ultra violet with golds and oranges in between. One who is powerfully aware and drawn to these colors, who has them strongly around them in their daily routines, could also find a needed element from the opposite spectrum to maintain both physical and inner balance. Consequently you will find many persons requesting gems and jewelry actually outside the orbit of their own organic force field.

This again then becomes a matter for understanding and justification as we realize that the birth sign or energy pattern and planetary rulership can become greatly insignificant in what is needed by a person during their temporary earthly sojourn.

Regarding Color Therapy, clarification is needed on the whole matter, for though the colors of gems are an inherent part of their function, actual color therapy does not always require that gemstones be used at all. Gem therapy is a different consideration entirely as apart from color therapy though both serve *as* ample tools. Neither does the job of the other nor replaces the other and it is to be understood that they are not always interchangeable. Color therapy can be handled in many ways with apparatus rigged to receive light waves in the energy pattern required for the subject. A gem either has the correct tone or color factor needed or it would require another kind of gem altogether.

#### CUT GEMS vs UNCUT CRYSTALS

There are differences to be found in the effectiveness of gem crystals cut and polished as compared to their natural state. However this varies with the mineral content and evolvement of said gem and what it is going to be used for. There are some gems that need to be cut and polished to bring out their qualities, others serve well both cut and uncut, some serving two different ways cut or uncut, and still others who function best in their raw state.

Generally speaking the gems vibratory rate will transmit better when polished, yet if a gem compound exists to create atmospheric stability it is best left as a natural mass. The uncut stone will often supply the optimum amount of needed **energies**. Not cutting or polishing an Amethyst, for example, will lessen the transmutational qualities stepping them down accordingly for whomever desires it in that state. On the other hand, a Garnet is unique in that it is highly effective when cut while almost an inert blob of matter when in its raw state.

#### GEM CRYSTALS UNDERGROUND

There are many large deposits of crystals of any gem material laying unexposed within the ground of Earth which are a part of the **foundational** material that this planet wears as its body corresponding to the force centers or chakras of man. These deposits have their charge of doing and serving a purpose **un-heralded** and mostly unknown to the majority of mankind. They hold intrinsic and powerful forcefields of magnetism geographically throughout the planet holding energies, releasing them and grounding them wherever necessary, etc, so that even if never mined, polished or utilized individually by man, the gem world serves quietly and forcefully, working on levels unsuspected by man in his ordinary conceptions of how and why the planetary gravity patterns remain steady and active.

There are a growing number of sensitives who have experienced astral visitations to these underground deposits where they have, seen, enjoyed and worked with fantastic mineral beauty.

## FORCE CENTERS OR CHAKRAS

Man has the macrocosm within him as a microcosm that handles all the cosmic, extra-terrestial bombardments, etc, that humanity presently is becoming more aware of daily. Man has seven key areas or force centers located throughout the body, specifically at the crown, brow, throat, heart, spleen, solar plexus and sacral areas. These seven chakras act as buffers, sensitizers, radio receiving and transmitting stations and they also reflect the state of personal soul development and experience.

These force centers affect everything that comes into and goes out of each individual person. Just as herbs and the like affect the health and the balance of the various centers so does the gem and mineral kingdom have its own specialized and generalized affects.

The many well defined books readily available about these centers forces us to mention little more about them in this work except as they are allied with various gems and stones within this orbit.

## MOTIVES CAUSE GEM REACTION

Bringing forth the thought that when mankind has come up out of the dark age of superstition surrounding those fabled and infamous gems of dubious reputation, all heads can eventually clear and be educated to the theory and application of frequencies and energies that operate throughout the mineral kingdom. Of which the most sought after gems are the divine representatives and messengers of many attributes, both positive and negative and good and bad, depending upon what the individual is like and what is projected into the maligned gem, powerful though it might intrinsically be.

Gemstones have an automatic, inherent "boomerang" affect in that they return to the sender equal ratios of good or bad thought projections. When greed and negativity is emitted and returned **karmically** to the sender, it does so on the physical levels obviously but also on some of the mental and emotional levels and layers of consciousness more subtly. Yet one does not hear about dramatic stories or extraordinary deaths as the majority of people in this day and age feel ashamed that a supposedly inanimate mineral can instigate such a happening.

Fortunately there are only a few in the rather large spectrum of these gems that can have the impertinance of doing such a disservice unconsciously to greedy minded persons.

## **GEMSTONE RESPONSIBILITY**

The responsibility or magnitude of application of any individual gemstone here on this planet is a matter of the particular gems degree of evolution, or just how evolved a stone has become through its process of transmuting from a particle of dust into a mass of hardened density, becoming continually more refined in its molecular structure, etc, plus of course what combination of planetary and cosmic energies are to be its expression.

In this solar system where man is growing up, the single most responsible frequency that bears its imprint on every kingdom in physical manifestation is the Lord of all, Saturn. All other planetary energies are subservient in some manner to Saturn except that of the Central Sun of this system. Much as the king and queen rule as the balancing poles of duality so Saturn is the king and the Sun is queen in this solar system.

A listing of the twelve gems of highest responsibility appears below. Note that regardless of what the alleged **rulership** of vibratory rate may be, if it is included in the list of most responsible gems there is and must be, an undercurrent of saturnian ray energy pulsating through the gem in mind, even though its basic aspect may be that of an entirely differently countenanced polarity of planets.

In alphabetical order: 1. Amethyst, 2, Carnelian, 3. Diamond, 4. Emerald, 5. Lapis Lazuli, 6. Moonstone, 7. Opal, 8. Pearl, 9. Ruby, 10. Sapphire, 11. Topaz, 12. Tourmaline.

#### **INTER-REACTING MINERAL ELEMENTS**

As mankind grows in understanding and begins consciously applying himself to the task of cleansing, transmuting and purifying his own body, and thereby the elements which make up the body, man in essence is affecting all of the elements as they inter-react. Within your body a part of you is also screaming as an outcry is made from another kingdom, for the cell that corresponds within you is also a cell in the elements of nature. Man must be at peace with nature for as we become more sensitized to our bodies so shall we know the imbalances and literally feel the destruction that must be righted without.

This can no better be pointed out than in the environmental pollution of all the physical, earthly elements so prevalent in todays transitional and transmuting world cycle of existence, for just as man becomes in tune with the elements within and without and can constructively utilize the perfection of the planetary sphere itself, then harmony can reign in the densest **particles** of matter. For no planetary sphere wherever found that is colo**nized** by any life form is ever out of balance. Otherwise it would not **present** a suitable field of growth for the life forms evolving upon it. It is the symbiotic organisms that have permission to sustain themselves that have a direct responsibility to bring their outer forms into inner polarization with the Earth!

#### **RAISING GEM FREQUENCY**

Using minerals to treat or remedy a human affliction on whatever level means to raise the frequency level or vibratory rate of the gem being utilized at that moment. This will enable it to more easily penetrate the human aura or sheath and filter it down to the business of working with the existing difficulty by realigning or absorbing it, thereby neutralizing it to whatever degree that the **karmic** limitation of the person allows it to become affected. This is basically the same method that is used by herbalists when they triturate those elements into homeopathic remedies, except that it is the thought processes of the healer or transmitter that can vivify this process through the gem.

Now when we speak of raising the vibratory rate of the frequency of a gemstone, it is not that one is tampering with the gems evolutionary status. It simply implies their amplification with the filtering quality opened up, so to speak, for transmission to become facilitated. This is the end result obtained regardless of how it is accomplished, be it through the power of the suns rays, the power of visualization meditation, or whatever else is suggested. The Suns rays, because they are of the essence of the germ of all life and vitality within and around this planet and many others, will whenever placed directly into and within any substance, plant or mineral, according to its basic structure, react by opening its molecular structure allowing extra particles of pranic life force to enter it. At the same time it causes it to become a two way street for the receiving and transmission of powers and energies. The molecular structure gets bent, as it were, giving more slack in the lines of energy. This work that the Sun does for man operates on every level that the inert matter can respond to also, which means the amplification created by the rays of the Sun will proceed to carry the energies all the way to the highest level of a gems possible potential. The Sun can and should be understood to be an eternal battery off of which man and all of natures kingdoms can draw.

When charging a gem with a prism you are putting into it the etheric and astral tones of color rather than magnifying the dense earthly tones and are raising up the power of function of the individual color rays when utilized **therapeutically**. The prism separates each color tone and allows the color therapist to concentrate on any hue needed which is then thoroughly, properly charged, while if the Sun is used without a prism it is the vitality that lies within the gem alone that is amplified. To use gems with their color frequencies is a definite art and should be encouraged for the more than marginal benefits that they can confer upon those who are thusly attuned. It will be up to the individual therapist to be guided in this newly opening field of gem force-field therapy. Aside from the color in gems the therapist also has planetary energies contained within plus the elemental affinity and its zodiacal counterpart, plus the inherent and unique mineral combination within the physical structure. So a gem can become an amazing form of life-giving alternative if used intelligently and with scientific acumen.

#### THE SEVEN RAYS

Alluding to the major seven life stream energies known by many as the seven rays, though these in truth exist, the preoccupation by man the aspirant has so far only confused and obscured these categories. Therefore whenever a ray energy is spoken of in conjunction with gemstone, it holds to the understanding that these energies have always been an integral part of the plan of human evolution and are still so, but to pick at it for personality gratification has thus far not seen helpful results.

Each man uses several rays and undergoes initiation and understanding of the purposes of each as he progresses upwards towards perfection. These seven basic energies are utilized by mans different personalities as well as his essential essences or soul matter. The myth should be exploded that each man has only one tone or sound emenation, for this is not so. Not only is the ray subject to alteration with each cyclic experiencing, but so too the inner and outer levels of ray usage which may utilize several different energy lines or anchors in one incarnating cycle. Again at certain critical points in development, even the "soul" ray can switch or change so there is not the permanency here as man so comfortingly might wish to have it.

Therefore, gems are in themselves an indication of the senses that man is straining to use and to perfect here. In that the gem kingdom is subject to the spontaneity of the seven different life streams of energy, they are not free to travel over or about these frequencies and charges. This is because gems of a particular vibrational attunement are evolved specifically to attend to the needs of one or more of these seven life streams.

#### **ENDOCRINE GLANDS**

The major transition on the earthly plane of mans existence is transforming the mental center of the concrete mind into a flowing, fully functioning correlated unit going between this and the higher levels of consciousness or the intuitive mind. To do this requires basic, major revisions and alterations of the whole endocrine system of present day mankind. Much of the symptomatic distress associated with the most vicious "killers" of man such as diabetes, heart disease, cancer, etc are in reality all signals of a rapidly changing and highly reactive physical organism that is being altered so as to withstand higher particles of finer matter and energies.

The endocrine balance is at the central core of the transformation being achieved and this is why the most vital and important gems and minerals reinforce and assist these enormous and multi-faceted changes. The physical key to mans spiritual attainment lies in the endocrines and no one will be able to get away from the awesome and oftentimes radical effects occurring especially in this nuclear age of bombardment, almost literally speaking.

#### RADIOACTIVITY

Radioactive isotope forcefields and other similar nuclear fallout procedures and processes bombarding this planet are causing a heightened stimulation to every cell tissue and molecule in mans body on all levels. This stimulus can cause abnormally fast cellular growth in the weakest areas of the physical vehicle resulting in symptoms of mans widely publicized and feared "killer" diseases that he is constantly trying to rise above. These symptoms that affect mans lifestyle, destiny, and so forth, operate through the karmic aspects and genetic tendencies falling due that correlate with the various categories of human frailty and weaknesses responding on the individual level of each unique human organism.

If, and this is a big If, mans endocrines were capable yet of withstanding the impact of these higher frequency discharges given off, the cell growth that now results in a malignant melanoma or what have you would not manifest as such at all. Rather, it would re-define and create normal if different avenues of development within mans physical sheaths.

Man is actually an atomic organism and the atomic age of nuclear fallout that is so spoken about should in reality be taken in mans stride as the next phasing of his adjustment to external conditions that result in internal alterations as well as external ones eventually. The fears raging so paramount in the now are understandable from a limited viewpoint, but clarification should be made as the fear itself is conducive to retarding much benefit from all of these advances that are unstoppable in any case.

This is not to advocate centers that give radioactive "baths" by any means, but merely to point up the incredible and foolish paranoia presently existing over our environment.

#### INTERPLANETARY TRANSPLANTING

There are upon the Earth certain minerals that did not originate on this planet but were transported here from other planetary realms. These mineral transplants or mutations as they might be called, are first altered in nuclear and basic atomic structure to conform with the lightest particles of matter available in the atmosphere of inner space. This then becomes teleported of its own apparent volition and by cosmic fusion travels a beam of directed light sent by the cosmic being overshadowing the Earth entity, as it were, to its selected place of evolvement on the selected solar system and sphere whether of this galaxy or another for service in that given area.

This process of teleportation is quicker, faster and more direct than anything that can be described, for it is carried much as a spore encased in its own protective sheath while in transit and until it is released in the lower atmosphere of Earth or whatever planet it is being seeded to. Then this protective sheath explodes and the essential core is allowed to take root deep within the bowels of the crust and layers of matter of that particular planet. This creates the construction of new crystalline or other formations that will seem to be indigenous to that planet.

All of this is directed by the devic orders who are in charge of this

kind of work on the inner planes where man cannot yet penetrate due to the differences in their evolutionary paths. These devic forces are of course directed by the inner government that **creates** galaxies or universes and oversees the development of matter in the kingdoms of elemental nature.

## **NON-PHYSICAL ARCHETYPES**

There are gem **crystals** of many types and classifications that are anchored in the **etheric** realms affecting Earth though not seen in the physical dimension. This realm is of a higher frequency vibration that inter-penetrates all other planes surrounding Earth. Some sensitives have enjoyed experiences working with these crystals on the inner planes and being **shown** their function and relationship to the physical plane.

These crystals are archetype which have not yet manifested into earthly matter but are utilized by those who are investigating into the third and fourth dimensional light worlds of higher illusions. All archetypes from the logos concepts begin on the very highest levels and filter down into the grosser or denser realities as their usage nears and time barriers are ready for removal. Such lies in part the secret of much of the evolution of all Kingdoms of nature as ideations of archetype resulting in the eventual manifestation thereof, and this works according to immutable, universal laws that function regardless of conscious understanding or not.

#### NEW AGE EQUIPMENT RESEARCH

Each gem and mineral has untold qualities far beyond our needs at this time. As more becomes necessary, it naturally shall be uncovered until each **gemstone** is placed in the complete awareness category. New Age healing equipment, which is beginning to appear on the scene, awaits trained research sensitives who will be able to look-see into the framework of the dense physical bodies and beyond in order to measure and see the effects that certain gems have upon these bodies. Then they **could** tabulate and bring forward extensive findings to corroborate and confirm that which is being given here on a minimal level. With this work accomplished we would have the tool of an exact vibratory aid for all the body organs, the auric field and their alignments with the higher bodies.

This is directly related to the newly burgeoning areas of the medical field now being opened up fractionally. When this research can be implemented and developed another important **aspect**, mankinds proper relationship with all kingdoms, can undoubtedly be achieved upon Earth.

# ASTROLOGY Planetary Influence

All inter-galactic and inter-planetary energies that exist in inner and outer space permeate the universes with their charges and counter-charges. These filter down into and through the various layers of stratosphere, atmosphere, etc, to each globe or planetary body enervating, vivifying and sending it a pulsation of its own form of vibratory energy. Each body of light and sound, as an extension of the solar logos, contributes a seed to promote the well being and understanding of every atom that resides on a particular body in any galaxy. All of these frequencies pervade each and every one of us just as they do the most microscopic grain of sand.

So when we enter the mineral kingdom and we see how aeons of evolutionary time has helped to formulate an object of beauty such as a Diamond, it no more can be considered a dead object than the leaf of a flower or the embryo kitten in the womb. Mans ideation of animate and inanimate requires a point of enlargement which in turn will give perceptions into other necessary dimensions of time and space.

Taking the Earth planet as a specific example, the energies of light and sound that travel downwards into the earths atmosphere, cutting through the density of ozones, etc, before descending, visit what one could call a celestial parlor with a party of diverse and many sided visitors shifting around and changing their positions according to the cosmic dance of the hours. This *is* called the Zodiac and is also known as the constellations.

As the orbiting energies pierce through existing space they land in this divine parlor of Earth giving off of themselves radiations which energize these different visitors giving each of them a peculiar character of their own, but always the interplay seems as though it creates infinite varieties of possibilities within a possible combination. This of course is quite true for when this combined force of energies converge upon one globe of light, in this case the Earth, the life on that globe will reflect these twelve major sitting room guests plus any "crashers" that happen by.

These combinations of **extra-spacial** forces make every particle of this planet what they are in the infinite variety of form, sound and texture that one sees in physical manifestation. Only when one gets to a certain point of departure on the evolutionary arc is there voluntary understanding and cooperation in the selection and diffusion of certain energy patterns for experience of growth.

To get on with things, a general statement should be made to the effect that as our knowledge of the universe and the solar system is yet rather incomplete, as is our knowledge of Astrology, so is the material and information on gems yet limited. Nevertheless, bearing these limitations in mind we may proceed to engage our attention to what can be made known and try to fill in the gaps as far as possible in this present Earth cycle.

When planetary rulerships or zodiacal affinities are spoken of, one needs to re-define these analogies, for otherwise it would limit the worth and the application of any significant and precious gem variety. These planets and signs are part of the universal energy patterning setup of this cosmos and because these minerals are living pressurized elements themselves, they partake just as every other kingdom and are affected by these frequencies. But it remains important not to attempt to deify or to restrict or constrict any gemstone because astrological analogies have been and are being given.

Astrology is only part of the greater whole that is just beginning to be understood for what it is. In the following pages we shall attempt to bring an updated, general understanding of the influences of each planetary body, well known and lesser known, that affect mankinds temporary base of operation, Earth planet.

#### SUN

The Sun is the vitalizing factor within the central solar system of the Earth, energizing every other planetary body which it circumscribes, giving it the necessary impetus in order to operate on its own level and combine with others levels to harmonize or create conflicts with different planetary bodies. It is the integration factor that holds our present section of the galaxy together.

However the Sun that we of Earth are familiar with is not the main Sun, but it is a major nerve ending emenating from the central Sun that exists in the very heart of the entire system that we are a part of in this chain of universes.

Within the microcosm, or the individual human being who is receiving the solar energies that reside within a particular gemstone, this creates again on a much more minute scaling a necessary energizing influence in the heart regions leading towards full circulatory action within the blood stream itself. This action upon the bloodstream results in determining the extent that the physical organism is capable of responding to the solar energies that correspond and reflect the ray of will through the Father.

#### MOON

This planetary body is a reflection and objectification of the principle of the sub-conscious, or the emotional, instinctual nature of a human being, animal, vegetable or mineral gem. It exemplifies **un-conscious** reaction to the flowing energy patterns of the logos or creative intelligence within all universe structures and acts almost of itself without influence of human intellect.

As the Sun represents the positive polarization of the will and is the "yang", or male in activity, so the Moon becomes the negative, feminine basis, the "yin" of personal and inter-personal relationship whether of a concrete form or an abstraction. The Moon is a holding vessel for the thoughts, feelings and the conditioning patterns which tend to crystallize

ideas **within** the individual being as within a structure built of stone. Instead of being a releasing body, it operates on the holding, binding and nurturing principal adding **cohesiveness** to any structure if not carried to the length that can turn any energy process inward on itself.

#### STARS

There are significant energy patterns issuing from the various Star bodies. However at the present time, Stars per se, are not an applicable influence to this solar systems evolutionary arc and cannot be considered in isolated patterns converging on the Earth planet as there is not sufficient response from the levels of the mineral kingdoms focus.

#### SATURN

It is here that we find the seat of the inner planetary government of this solar system and as such brings to Earth the stabilizing and judicial influence necessary to maintain a foundational structure on the earth plane at all required levels up to the monadic or **unmanifested** essences of mankind. Broken down for individual consumption, this reflects as wisdom, responsibility and obligatory experience. This is the energy manifestation that calls the law of cause and affect into activity throughout the universe for it is the balance that brings order to chaos and direction and purpose to the evolutionary plan, whether of an individual, a nation, or a planet.

It is the arm of the law, the director of the schoolroom of Earth, the Dean of education. It is all pervasive to the individual consciousness and as a conscience, whether recognized or not, on the conscious level of awareness.

All gems with a **Saturnian** affinity are miniature foci of intense, internal discipline manifesting on all levels. This intensifies the quality to be stimulated within the mental consciousness of the individual who has the need.

#### VENUS

Sister and morning star to Earth, Venus stands at the head of the fleet as it spearheads the evolutionary movement of all kingdoms and assists this sphere in every effort towards growth. Its energies reflect the aspect of divinity allied to wisdom, the principle of impersonal and universal love, acting through the practical aspect of wisdom attained from that of the buddhic level. From this level of unmanifested form, intuitional love calls forth from the soul the attributes of divine compassion. These energy patterns are called upon to reflect the evolutionary archetype that will evolve out of the Martian impetus presently prevalent on Earth.

Minerals and gems ensouling this source of energy work directly on the astral bodies of mankind dealing them the emotional development of the higher bodies and transmitting from one level to the next. They reflect the attributes of the heart and mind in a composed and functioning level. It is the reflection of the highest expression of fidelity, love, loyalty, compasion, etc. This energy has a great deal to give as it softens the experiencings of suffering on Earths present spiral by spreading softer, mellow understanding for easing and balancing. Mars can be considered as a subsidiary of solar energy, a direct force of physical energy stepped down and operating on the physical and the **etheric** levels, relating specifically to the bloodstream. It acts as the Sun circulating more as physical prana of an aggressive, identifiable source of stimulus spurring individuals on to motivational activity. This releases instinctual patterns from the consciousness at all levels manifesting them as effects to be worked out. This would apply to health as well as wars between nations or the sexual function between male and female polarity.

**Gemstones** with this influence are to be regarded as stimulants for their energies are direct, impelling and swift. For identification purposes they are known as of primary, positive, male polarized frequency.

#### JUPITER

As **Saturns** energies contract, so **Jupiters** rays expand and allow room for searching and seeking. **This** manifests through all the personality levels circulating as a free agent in the human kingdom as well as in all other kingdoms of nature equally. Jupiter also **aligns** itself with the Sun but on a free, more "expansive" basis, sending currents of inspiration to the various **levels** as necessary.

This reflects in the mineral kingdom as a trinity working through a duality of expression using the Suns rays and Venusian principles and uniting them into one form of manifestation and expression. A gemstone of **Jupiterian** energy is a lifter of the mind and heart due to the generosity of outlook that this vibration brings with it. Over enlargement of this virtue is the only negative that could be reflected here.

#### MERCURY

In genstones, the energies of this planet work through the focus of the lower and middle aspects of mind, aiding thought processes and giving intellectual stimulation. This depends to a degree on what it is linked or combined with, as energies alter according to the various other gems or metals utilized with this planetary influence. The neutral aspect of this energy mixes well with almost all others and it can be quite "content" by itself also. Other planetary influences can give depth, width and breadth to its energies again depending on the particular combination. Earth as a planetary forcefield does not conflict with the cosmic energy flow, only does it act as a necessary anchor at the present time.

Mercury is the mental **hold-on** for mans modification of intellect and intuition and this energy serves as a bridge between the two if understood wisely. When some of the most evolved gemstones are affected by Mercurial energies, such as the Sapphire, it takes on additional dimensions of mind quality and can travel through planes that rise as high as man can **soar**. Just as the mind of man is elusive, so too is the quality of mercurial energy within the mineral kingdom.

#### NEPTUNE

This outer planet is now coming into the field of expression where the atmosphere within various portions of present humanity can begin to respond to its frequencies. These frequencies are connected to the spiritual archetype of the planet Venus. The ray of influence is attached to the little known but recently recognized law of universal sacrifice, a higher octave of the expression of Venusian love. This is turn is connected to the higher principles in mankind that are slowly becoming stimulated with the coming cycle and aquarian dispensation.

The Neptunian energy patterns can be responded to either extremely negatively, or in a positive manner by those who can handle these frequencies on an integrated and liberated level. Gemstones containing Neptunian frequencies predominately will aid in aligning soul qualities and attributes to areas of development such as increasing the capacity towards unselfish dedication to another, or to a cause, and in the re-development of mans sixth and seventh sense powers on a yet higher spiral of practicality and function.

These "watery" planetary energies move and slither undulatingly within the kingdoms they influence. It is subtle and can be divinely impersonal or totally subjective and self-deluding. The extremes of lifes pendulum can be epitomized in Neptunes arc.

#### URANUS

Here again we have an outer planetoid which acts similar in manner to a bolt of lightning working with clarity and stunning brilliance in as much as intuitions and perceptual capacity is concerned. Gems operating in this force field are highly charged and active within their own auric field and so have a great deal to offer in terms of synthesizing movement and activity on the inner planes where such energies extend themselves.

This planets electrical charges bring with it the possibility of de-crystallization which the gemstones belonging to its orbit can definitely help to discharge into the subtle etheric levels that are vulnerable to its activity. One cannot say that this influence is either positive or negative because all that is activated by Uranian energies in the lower realms is meant to cause change through new growth and understanding. Though these gems work on subtle layers they eventually make themselves felt down at the physical consciousness level of activity.

If an individual is not propelled or influenced by this outer energy very much, it will do its work on the inner planes where often nothing is noted. All of these gems of the outer planets are unknown qualities unless one can instinctively feel drawn towards and compelled to wear, meditate, or in any other way, focus their imagery into them.

#### **PLUTO**

Pluto at this juncture may be likened to a volcano that is about to erupt and explode matter and material everywhere without any great selectivity. This is exactly what it is doing regarding responses from humanity in the now which is barely able to recover from the regenerative force that this planetary body throws out and through the Earth. Mankind is not yet able to gauge or to judge the dynamics of Plutos operation, whose frequencies are so disturbing, as they cut through so deeply that instead of elevating, they can reap tremendous destruction at present. (The Shiva aspect). However it is necessary for the mass consciousness to awaken and **respond** to produce the purification that will allow the master plan to flow along its pre-ordained path. Consequently the gems involved in Plutos orbital consciousness, whether on the periphery or directly within, will serve to tear down barriers not only of the mind, but also of the emotions.

As the outer planets operate in a trinity, the operational function of Uranus is to decrystallize and shatter for Pluto to regenerate upon a newly laid and born foundation so that Nepture can love and sacrifice in joy and freedom. This outer trinity is like a cosmic clock that tears down only to build up and raise the consciousness of all things in every kingdom of Earth.

Pluto can combine with other planetary energies in gemstones as can Mercury though each has dominion over very divergent activities. The key word for gems with Plutonian energies is regeneration and transmutation. This planetary energy holds part of the secret of alchemical mystery that will clarify as humanity travels upwards into spiritual knowledge.

#### VULCAN

This is another outer cosmic visitor which will indeed modify and deal with the ideation that man is a perfectable form of animate instrumentation. These energies will come into active focus many cycles from the present, but since it is a burgeoning element that is beginning to affect certain gems, we are inserting it within this work. Those gems that are porous to Vulcans forge can and will take a more active role in stimulating the higher bodies and extra sensory perceptions that are flowing into an explosion of uncertainty and varigated uses currently. These will deal only in the specialized forcefields that consist of active crown and brow center development for the future and for a small but growing minority on Earth now.

Vulcan, being the higher octave of Mercury, is able to trundle between all layers of mans mental consciousness whenever called upon acting as another arm of Saturn, pulling closer the active participation of the mental and creative faculties of higher and lower mind.

As these outer energies continue to bombard and permeate the crystalline gem structure evolving on this plane their power amplification and magnetism will gain in stature and the ability to affect man and his bodies thereby aiding his ongoing in the upward spiral.

## Their Attributes

#### ALEXANDERITE

On the upswing in its earthly evolutionary pattern, this little known gem is just now beginning to be utilized by mankind for its regenerative powers. This Pluto oriented gemstone operates purely on the regenerative forces, inner and outer, from the physical level and on up into the higher bodies. Though less available, it can serve in a similar manner as Garnet.

At its present stage of development it has the ability to work with the direct link between man and his higher aspects, the crown chakra, to help bridge the obvious gaps in **existance** today. At the peak of its development, after a large block of Earth time has lapsed, the Alexanderite will become quite powerful and function similar to the Diamond in its power aspect, except that it will remain regenerative in operation and not a physical healer in the usual sense. This gem will have the peculiar knack of pulling the sacred fires together and keeping them stabilized and functioning properly from the point of the crown chakra, which at that point in time will be open and actively operating in the majority of mankind.

#### AMAZONITE

This gem will become an important contributor to the Earths evolution at the time of the coming sixth root race of mankind and will be used much more extensively than in the now. The color will stabilize as a beautiful green-blue hue similar to Turquoise but crystalline and chatoyant giving a lovely gem of quiet lights and rhythm. It will grow denser in structure and more able to be utilized for art objects and sculpture. This gem is not noted for healing significance at this time except that it is soothing to the nervous system.

#### AMBER

The exudation of the various saps which make up the composition called Amber is a more than interesting substance upon the planet as it serves to polarize with healing magnetism that which it contacts and which contacts it. Like the Topaz and the Magnetite, this beautiful "wet jewel", because of its peculiar origins of organic vegetable matter that has become mineralized and fossilized, holds a key to the Earths stability. It acts as *a* grounding and an anchor that helps keep the axis of the Earth rotating in proper order.

If consciously working with the positive and negative forcefields, Amber harmonizes the yin — yang principle, the male-female elements that comprise the soul as it separates from its divine nature when it makes the **descent** into matter of earthly **manifestation** for the cycle of **physical** duration called life.

The ferns, flowers and insects, often found as inclusions within **this** material, add their own patina of frequency which is an addition rather than a negation because of the alteration of molecular structure. This is much the same as wood altering its whole essence when it becomes petrified or mineralized. The **un-interrupted** flow of life forms which are trapped within the sap that is molten Amber before it hardens becomes a living testament or monument to the electrical impulse and the "Miracle" factor always present in the dream-wish world of man's mental imaginings. This is one of the reasons humanity prizes those with these additional characteristics.

Amber with or without any entrapped archaic life forms will work effectively upon the electro-magnetic wave lengths emenating from the separate individual brain cells and centers of the physical and etheric body. This has a direct connection to the endocrine system which helps to stabilize the spleen, heart and base of the spine centers, which in turn leads to the opening of the channels and the correct raising of the serpent fire.

Concerning the efficiency of the different color spectrum of this substance, the highest magnetic flow emenates from the clear of the honey, golden and reddish shades. The more solid and opaque colors do more to actually heal the physical centers for they are stepped down in capacity and are not as highly charged with the clarity of the light.

The yellow Amber coming from the Russian regions of the world operates on the frequency of Mercury where it deals with the intellect again attaching its functions more to the physical level. As regarding the reddish shades or cherry Amber, you are dealing with Saturn-karmic-responsibility and Pluto-regeneration, the healing of the energies pertaining to the serpent fire and other like functions. Mars is the active energizer in as much as it is a pass-through energy, but acts neutral much as Mercurys role with Topaz.

#### APATITE

Within the next Earth **milennium** this gem will become an exquisite example of a Mercury energized gem with a pure lemon yellow hue. This will be able to clear confusion within the mental stratas from those oriented to this spectacular energy patterning.

Other colors seen now will almost disappear as only the yellow shade of the spectrum will be of any real earthly value. The refractive index will also get relatively high competing with a good many other on-coming "smashing" beauties that will be evolving right along with it.

## AQUAMARINE

Developed here on Earth, yet not belonging to Earth, this beautiful mutant Emerald Beryl is in the act of becoming a higher frequency emissary of the Neptunian energy of love, being on a higher tonal frequency even than that of its sister Venus.

Though this gemstone will be replaced in a few hundred thousand years, it works well in the now with all three levels of mans physical trinity in balancing out imbalances wherever found in the individual. Its ability to zero in on the subtle process of impressions that operate on the feeling level of man is what this gem does so well. In addition to being a stabilizer, it should also be regarded as a filter for some of the **dross** that **man** accumulates, working on this quietly and unobtrusively. Though not as powerful as the Emerald, it is a purifier par excellence.

It is of particular benefit, before the wearing of it, to charge the Aquamarine in direct sunlight with copper around it for a period of 8 to 24 hours. This amplifies its activity as the added copper frequency imbedded aids the filtering process for each individual.

#### AZURITE

After large blocks of Earth time have transpired, this copper ore mineral will become the jewel of wisdom, the major gem of a pure indigo crystalline composition that will replace the Sapphire on the evolving spiral of the planetary chain. Its potential is enormous for it belongs to the **karmic** Lord Saturn, containing within its attributes, the **key** that unlocks the kingdom of heaven. It will be the incoming representation of the second ray, as the Sapphire currently heading the gems belonging to this energy grouping.

Azurite is an alternative of a small elite group and will have the ability to restructure molecules which will respond to it on the physical plane. It will operate almost like a radio-active isotope on diseased tissue and in a manner of speaking, "burn" away the unwanted structure. Another ability of this material when utilized properly is its essence which can expand and build grey matter, vitalizing parts that may have become damaged in the form of being the instigator, the giver of impetus, the supplier of a missing element, the lost chord.

This crystal when developed to its fullest potential will also work with the Lords of Karma on the inner planes in building new human bodies while they are still in their embryonic state. This will help the incoming races utilize the tools of their sixth and seventh senses in a more expanded fashion.

This mineral will be utilized more by those therapists who will understand and be working with the mineral kingdom in the field of healing and human development rather than being worn in the personal sense of most gemstones. Once again the tools of the mineral kingdom shall come forward at the appropriate moment in aiding the developing human evolution upon this planet.

#### BENITOITE

This mineral speciman will undergo many more drastic changes before becoming finalized into its evolutionary purpose. As it stands now, it is unlike any other combination of minerals and shall remain unique. This clear crystallized mineral will become a mellow looking rainbow optical effect that will entrap the entire spectrum of light within its core system allowing gems to be cut and faceted that will look just like miniature rainbows much as those seen now in the sky after a hard rain.

The refractive index will not be high or pulsating but none the less its power will lie in its ability to encompass the entire astral light within its earthly form giving tremendous healing and esthetic aid to those who will be drawn towards it, and very few will not be, at that point in time.

#### CACOXONITE

**This** mineral is part of a general group that in time will **disentegrate** into a total alteration or changeover from one family of mineral to another. Within the next **milennium** of Earth time this will begin to form a **stupendous genstone** currently unknown to man and will be utilized as a psychological tool helping to stimulate mans image making capacity.

#### CHRYSOCOLLA

Though still in the becoming, this gem will replace the function of Turquoise, for it is on a far higher spiral of evolvement, though it is not yet common knowledge. The qualities of this material work well in the lower and up into the higher **forcefields** and dimensions of the trinity causing a reactive vibratory concussion up towards the monadic or highest planes of consciousness. This very attribute, which will be perfected by the sixth root **race**, will inspire those whose energy quadrants harmonize with it. This will aid in balancing the higher bodies with the lower bodies already expanded in usage of the sixth senses, thereby facilitating clear seeing on the astral levels for the neophyte.

**Chrysocolla** carries the planetary influence of Uranus and is compatible to all of the elements except Earth, if a preponderance exists, which can deaden or cover over its basic qualities. When the gem is worn it filters up into the mental strata of the auric field via the solar plexus and helps alleviate personal fears and guilt, harmonizing this center in particular. It can help prevent ulcers and digestive tract difficulties from setting up housekeeping in ones body, for where there is little emotional congestion there is no fertile ground for symptoms of this variety to exist.

Chrysocolla belongs to the second and third ray aspects in particular. It will become far more widely used than it is today as there is still little acknowledged about its potential properties. Much will be "discovered" regarding its use in cancer therapy, especially that of karmic origin.

This material when soft and not **gemmy** enough to be worn can serve in another important manner through its preparation as an elixir or tincture. In this state it can counteract body calcifications such as arthritis, etc. For details, see section under heading of "Gemstone Elixirs."

In the future there will also be much use of this healing tool as inlays with other precious materials in building construction such as was used in ancient temple friezes, furniture, etc. The **consistancy** of this material will alter, become denser akin to the Emerald in hardness although aligned to quartz on a continuing basis. It is this uniting with quartz that gives us the gemmy varieties used today, as the taking on of additional silicates adds more luster and depth of coloration capable of making breathtaking gems. The softer varieties used in other forms of healing will also always be present.

#### CORAL

The jewel of the sea, the gift of the cosmic ocean mother to the children of Earth is the eternal foundation, the skeletal statue that lies behind all life and living manifestation. The essence of Coral is form, its activity to build and the purpose is so as to perceive and understand the flexibility and continuation of that which is built and re-built, for substances can ever be renewed by the life principle that sustains it. Although Coral lives and breathes underneath the ocean, its roots are anchored to the earth in the message it propagates to those that hear. Neptune and his watery trident share energy with its earthy cohort father, Saturn, so that it would be particularly **effacious** for those who harmonize well with either frequency or both in as much as personal **attunement** is concerned. Yet the basic healing and balancing factors can be used by all on any ray and sign so that Coral should be considered a universally owned and operated concretion. Its efficiency will depend upon the persons predisposition towards this substance.

Coral does have properties for which it has become **reknown** but also, due to **superstition**, has been very over-rated in ages past and needs to be placed in clearer perspective. In its qualities as one of the fourth ray gems we have the principle of harmony through conflict stemming from the **fluidic** source. The storm of emotions battering against the battlefield of the mind is one of the corresponding foils for this **particular** gem emphasizing the crystallizing power of Saturn and the dissolving factor in Neptune.

Taking a look at its colors, the darker red of fine quality is a stimulant and tonic to the bloodstream of the body of those who are in harmony here. The lighter or more commonly called **"Angelskin"** variety has the most to offer the physical as well as the astral and mental bodies, for this particular Coral is the kind that creates a holding or stable vibratory rate conducive to keeping the forms that one thinks of intact on all of these levels, as in meditations and visualizations. This kind is also the type that helps dissolve calcification in the joints and bones where they exist as a condition of rigidity causing pain. This stone is an alternative to others also able to aid this condition again depending on the individual receptivity towards these elements.

Black Coral, being of an absorbing nature as well as a transmitting one at the same time, needs to be dealt with cautiously for it is capable of holding patterns of negativity and imparting this to the individual holding whatever limitations or crystallizations that may already be in the mind and feelings. This is not a gem to wear for luck, etc. In the past its usage was on the lines of negative magic and ceremony for these **properties** were recognized and used extensively in the areas of its founding. This was the old fetish or object of importance in the Shamans bag or pouch in Tibet, India and other middle eastern countries during its popular fashion. It has been on the downgrade since Atlantis where it was also misused and it is still utilized today in areas where low order energies and motives hold form and formulas.

#### DIAMOND

This mineral has reached the outermost limits of the evolutionary arc within this planetary cycle and as such is a representative of the pure focus of energy **emenating** from the Father or will aspect of divinity. The responsibility that anyone **incurrs** for the energies raying outwards into the atmosphere picking up the frequency of both the wearer and the aura of the environment is in direct proportion to the size and clarity of the gem itself.

The whitest and clearest hues belong to all but are owned by none. Therefore all twelve manifestations of divinity are entitled to the benefits offered by the wearing of it, yet some will be drawn more often to particular shades being perhaps more bluish in **cast**, or **yellow**, or green, etc. The Diamond in general is under the **rulership** of the planet Saturn but subruled by all and in close conjunction with Venus which aligns itself with the heart. When combined and perfectly harmonized, the heart and the will close the trinity of perfect man, when linked to divine mind.

Of the seven rays or aspects of life presently in **existance**, the Diamond belongs to the first, the will and power aspect. In their many life cycles on this plane each individual works with different rays, sometimes one, several, or even all during a single lifespan. Though the soul responds to a basic ray type, all seven rays blend into the cosmic unity of the One at the end of the great cycle for each individual. Just as the Diamond has merged within it all of the attributes and qualities collected during its **slow** progression towards the state of perfection in the mineral kingdom.

To put this gem in proper perspective it can be said without hesitation that the psychological ramifications and effects of this powerful force field, again dependent on size and clarity, are far more dangerous than anything that might occur because of a faulty metabolism or liver, for instance. For it is here that the very purpose of the Diamond comes into play in the development of mans consciousness concerning possession and the lust for power and greed that has so overwhelmed mankinds motivations up till now. It is from these levels that the Diamond can kill or cure or cause cankers which can fester into cancers and other interesting disease symptoms which modern man is heir to from the psychosomatic viewpoint.

Right here is the major causitive factor that man brings towards himself that tests and ties him to his very limits as this is not to be gone over lightly, but needs to be brought to the forefront of realization so that the Diamond can enter the "light of day" and function from the role that it was intended to play. This does not mean that one should be afraid of Diamonds or have nothing to do with them. The Diamond is simply the trigger. Man is the weapon. It can now be understood that this gem is not a **preventative** in any manner. Rather, it can be said to serve as a catalytic agent.

The Diamond must be considered the highest potency gem alive and its powers unsurpassed in many levels of function. Therefore the Diamond does its work from the highest frequency ethers rather than down in the dense physical plane. Diamonds can be of great benefit but anyone wanting them on a large scale should check their motives for having **these** powerhouses of the mineral world. If one can bear the responsibility that the radiations of the Diamonds give off into ones auric field, then tremendous charges of brilliant energy flows unimpeded and unobstructed into the dense and the finest particles of mans bodies creating a protective field that nothing can undermine.

To bear responsibility should not incite concern as much as it is to be aware that the degree of personality allowed to enter into a project can and will affect the results. For instance, if one is directly motivated to indulge or to buy substantial Diamonds either for investments or for profit, motivations could muddy the project. Of course this **should** not be considered **verboten** from the worldly standpoint as what may be decidedly unhealthy for one level of consciousness may be perfectly correct for another. One must always decide these finer more **subtle** points for **themself** and act accordingly. No one will die of Diamond poisoning. It is the poisons already within the mind and the heart that can cause the catalytic and sometimes catastrophic rebounds that are heard and read about. **This does** not threaten in any way the individual who wants a Diamond for the sheer beauty and delight that looking at the radiations can bring. It is extreme negative thinking and activity that warps the energy flow and creates the **symptons** mentioned above while the positive and nonpossessive attitudes create its polar opposite conferring untapped resources within the Self that can be drawn upon and magnified by the mind and feelings of man so as to cause growth, upheaval and an enormous vortex of activity on the inner levels of the ethers. This brings what each ones thought patterns cause to manifest holding true for negative ideations as well as positive ones. Therefore the acquisition of a goodly amount of Diamonds will only guarantee the owner to be firmly rooted into what he already is and will not dispense any magical formulas for power or **spiri**tual perception.

On the plus side, the involvement with Diamonds that is generally sought is of great benefit. When worn in combinations with other gems the Diamond enhances and aids their action. There is no such thing as a "bad" Diamond for even the broken, chipped and discolored with inclusions stones work for the wearer but in a stepped down manner. For all intents and purposes one is generally led to the "right" stone which will bring optimum energies according to the individual needs and abilities at that moment of time.

Regarding the various colors within the spectrum of this carbon group, these rays of varying strength gather their affiliations with the planets consorting with Earth in this solar system and also from those other so-called visiting spheres which enter into the range of the present operational solar hierarchy such as Vulcan, Pluto. All outer planets are involved. In **particular**, those Diamonds with a yellowish cast are under the influence of the planet Mercury, those with yellowgreen cast are under Neptune, pinkish cast stones are under Mars and Pluto, the white, blue-white and blue stones retain **Saturnian** rulership with the co-host Uranus opting for the lighter to middle tones, the brownish cast staying with Saturn and being particularly adaptable and harmonious to those manifesting Capricorn traits.

The alteration which changes a hunk of carbon into a carbon Diamond is an intense and almost un-explainable process subjecting this element to supersonic buildup that reconstructs each molecule within itself to make out of the carbon a source of eternal shining light that ascends the scale of vibrational frequency not known to any other evolving gem grouping as of yet. It is actually a nuclear process occuring only as a natural planetary activity which is the essence of creation that can be compared to the spark of light that enters into any form of matter giving it an evolution of its own as a part of the grand plan.

This is quite different than man-made diamonds formed under laboratory conditions which do not carry the same energies to any degree. Even natural Diamonds when artificially colored by man through nuclear bombardment and other techniques can be denuded of their original intent by more than 50%.

#### EMERALD

This genstone represents the divinity potential not yet manifested upon the planet Earth. Its energies and frequencies touch upon the building aspect of the trinity, the consecration of will and wisdom, and is aligned to the devic orders by form and intent. The Emerald is the very essence of the fifth ray of healing and science and was brought to the Earth in a minute seed particle by the Lords of the Flame from the planet Venus. Though not indigenous to Earth it still represents it, especially in the fulfillment of its eventual perfected archetype. Thus the Emerald is an attunement and an inspiration to those who are in need of the balance, healing and infinite patience which are given off by it at all times.

The entire beryl family was seeded onto the planet Earth, however the different mutations that have been found within this mineral grouping, such as the color ranges, all reflect different faces and aspects of the Emerald. The development of this group has been and will continue to be somewhat diversified becoming one with the vibratory rate and consciousness of Earth. Consequently, the various different color sequences that now manifest in the beryl family such as the Aquamarine, etc, are stepped down Emerald with other added qualities for various purposes discussed individually in this book.

The Emerald, like the Diamond, works well and harmonizes with all rays and almost every zodiacal sign equally being equated with the harmonization and gain of physical, mental and emotional equilibrium. Depending on the individual, his ray, sign and **evolvement**, the Emerald can ascend into the highest levels of consciousness on its energy spiral. This renders this gem intimately connected to deep meditative focal exercises giving a stability and serene inner foundational lift to this consciousness when utilized.

This gem was not meant to act as a purifer, but more the exact opposite as its work begins after other gems or other energy sources have transmuted the necessary elements and prepared the readiness for its benefits. The prime purpose of this green beryl is to inspire and to balance the evolving man and to cool down the lower bodies preparing them to once again climb the ladder of the next stage of de-crystallization and transmutation. Its frequency can never be harmful or irritating to anyone for its message is divine order, building and form. Indeed, anyone urged by an inner compulsion to wear or meditate or in any way have Emeralds around them are taking a pause that should be refreshing.

As a general rule humanity is not yet able to take full advantage of this activity and it will not be until the sixth root race is well under way that we can, but the benefits constantly given to the children of Earth are great, though almost totally on unconscious **levels**. There are just a few isolated individuals who are intuitively aware of the life within this gem.

It must be stated here also that none of these facts, or at least none of the more enlightened utilizations, can come into being or effect until some form of conscious awareness is made either by the wearer or by the healer or clairvoyant specifically devoting time to the transmission of said gemstone. This holds true for any given gem. Therefore the more ones conscious awareness is placed on a co-contributor from any natural kingdom to serve, the more they can and do serve. There are notable exceptions of course as each kingdom has purpose and function beyond what man can impregnate his imagining about.

Regarding zodiacal influences and energy patterns prevalent today, the Emerald finds an affinity to the signs of Taurus and Libra in particular while dividing equal benefits among the rest with the exception of Capri**corn.** This is not to imply harmony or conflict as Capricorn has another role of equal responsibility to play with the gem Sapphire. The planetary **rulership** of the Emerald is Venus and in its higher octave, Neptune.

The force field of this gem is quite effective whether in their virgin state or if faceted to reflect light. The exception is the opaque variety which is stepped down considerably in its frequency and is better used for treatment rather than for mental or emotional **attunements**. A carved design on an Emerald sends out lines or points of energy into a particular sequence of mathematical and **geometrical** areas of reference different in purpose and utilization according to the inscribed symbol. It will make manifest upon the astral layers of the ether the essence of the carved symbol and will emit its essence and contribution if any.

To speak of color, the light but clear greens and even the extremely pale greens of excellent clarity are valuable in meditative work as well as healing depending upon the affinity of the individual involved. Certain zodiacal signs attune more readily with the lighter tones than others, Pisces being a good example, while the deeper clear tones attune well to Taurus, Scorpio, etc. Another way that the Emerald may be useful is detailed in the section of this book entitled, Elixirs and Tinctures.

It has been very popular to combine the Emerald with an eclectic mixture of different precious and **so-called** semi-precious **gemstones**. However each admixture creates a circle of varying energy patterns that may or not cancel each other out. This is much the same as when certain vitamins should not be taken together because of the elements that neutralize the effects of each other. A notable and common neutralization of energies takes places in the mixing of the gems that should be considered the Four Horseman of the Apocolypse in light of the consequences of work that is being undertaken by these families of initiated gems, the Emerald, the Diamond, the Ruby and the Sapphire. Generally speaking, these gems serve best when worn individually or with Diamonds. There can of course be guided therapeutic exceptions.

#### ENSTATITE

This mineral and also Diopside, from the same general family, are disintegrating manifestations of a mineral taken from the lunar chain and brought to the Earth early in its development. Once again this shall crumble into the dust from whence it began and be no more for it has served its purpose.

Its de-evolving and involuting frequency and vibratory rate need not really be cultivated and mention is made of it to place it in the proper catalog of function.

#### FIRE AGATE

This gem is not actually an Agate at all regardless of how technical material may classify it, for Fire Agate must be considered as one with the Opal family and most specifically in the octave range of the Black Opal. The agates inclusion, known as Ammolite, is the essence that comprises the fire and purpose of it. It carries roughly the highest form of Black Opal frequency rendering it a **marvelous** partner to be regarded with equal respect. The association with the protective quartz in no way hinders its emanations.

As the Black Opal manifests the divine hues and fires of the Uranian messenger, the Fire Agate is an attunement to the cosmic fires of creation, the destroyer Shiva, the element of fire within the bowels of the Earth, the seventh principle of man, the perfected soul carried on wings of joyful sacrifice vivified and glowing for the service of humanity.

The Fire Agate — Fire Opal is now actively working with man's crown and brow centers, if the response is equitable, for this gem always stands at the ready to bore right through layers of density surrounding these just-burgeoning centers to help energize the partial flowering. At the same time it also works with the solar plexus and spleenic centers equalizing and eliminating different degrees of imbalance which may be affecting these open centers in man, playing havoc with his ability to keep a sure footing around the temptations of Earth.

This gem is a definite aid to meditation in the linking of the higher aspects with the lower bodies. If one is inclined towards the karmic disfunction of diabetes in this Earth period, this gem is an excellent assistance to eradicating these tendencies. There is a limit of effectiveness here as certain energy patterns are more conducive to its function, fire and air being the most suitable, water being least so and earth dependent on other modifications.

For further insight it is suggested that the section on Opals be referred to.

## FLUORITE

This mineral has the distinction of being disintegrated in certain aspects while continuing to manifest physically and to evolve in others. Only certain shades will continue to evolve becoming harder and more refractive for its role as a catalyst when combined with other metals and it will become a transmuting agent much as Amethyst is today. The purple will be the color that will strengthen while all other colors with the exception of green will phase out.

Its job as a transmuting agent will be to ground excess energies being created at any given moment which will aid the individual to operate at optimum efficiency while handling enormous amount of frequencies in the physical vehicle. This will be especially so when utilized with copper and silver.

## GARNET

The different groups of Garnets, according to energy patterns, each serve another purpose and operate differently with some exceptions. Considering the pyrope cluster first, these come under the planetary rulership of Mars and correspond to the physical circulation and energy principle, or hemo-globin factor in the bloodstream. They help energize and bring the circulation level to normal if deficient. This cluster also works with the generative system and stimulates the hormone aspect of the sexual function, enervates pertinent organs and correlates the body chemistry relative to these areas.

This grouping is tied into the physical manifestation of the kundalini fire along with the two sub-groups of Hessonite and Spessartite Garnets which belong basically to the same function but respond to higher frequency wavelengths. The lighter the Garnet shade, the more light that will pass through it and the higher the frequency will be for its effectiveness on atomic and sub-atomic matter in the sub-planes of atmospheric planetary layers. The integrating fire is the aspect of the function within these gems that assist the kundalini into the proper grooves in the pathway up mans spinal column.

This gem is of little value to one who would use it to deliberately try to induce activation of this force, but to those whose sacral energies are already flowing freely and under control it will keep the flow and the forces humming along at their own good rate. In most any instance where indicated, the Garnet is a cooperator with man and a diligent dray horse of the gemstone family. The darker the Pyrope, the more earthly or basic its vibration is on the physical level of the human triad, and regardless of scientific or technical jargon those reds that range from the very deepest brown-orange to the clearest and lightest, belong to this first grouping of Garnets.

The second grouping is the pink-violet-red Almandine cluster that is directed and ruled by the Plutonian sector of the galaxy. This fuscia, magenta and pink-violet color section works completely on lines of regenerative and transmutational energy focusing its positive efforts directly on the physical and etheric web of humanity. This is not so much a balancer as it is a diffuser of regenerative forces and acts as Plutos emissary and regent in the lower atmospheres. Again linking the human reproductive system to those of the mind, it makes Mars a co-worker in the level of this particular scheme. This group is primarily concerned with the little known Rhodolite Garnet that has not been terribly important or utilized in the now.

The third group discussed is the Grossularite Garnets, the green, yellow and other paler tints not in the red spectrum at all. The ramification here is such that the coloration serves as a direct balance or complement to the red tones. Alone this grouping is of no great consequence being that it is a mutation of the color spectrum in order to be used in regenerative therapy. When a green Garnet is used in conjunction with a red Garnet, or in fact other red colored stones, it produces the effect of physical polarization, the yin-yang in either males or females. When this duo is fused into activity with the powerful frequency of a Diamond one receives not only im**petous**, but a whole new dimension in a forecast of what is to come by way of utilizing gemstones in the reconstruction of the Earth and its lower planes.

When worn as a healing instrument or when used for projecting energies to one in need, this red and green Garnet combination can be used to good advantage in all degrees of polarity problems. Green Garnets put another aspect of Plutonian power into operation which works to modify and transmute distorted positive energies traveling up and down the spinal column while the red Garnet works on the transmutation of the negative energies traversing the opposite length of it. In relation to one another **they** give the potential of again inter-relating and altering an incomplete energy direction which makes possible the re-orientation of one who, for instance, has been given a female body to operate with yet function on all other levels as a male and vice versa.

The Rhodolite Garnet hues and those with bluish, purple cast are the choice reds for this purpose. Though Garnet is the most suitable energy wavelength to accomplish these balances, if green Garnet is as scarce and as expensive as it is currently, green Peridot can render much the same service. In general any combination of a red and green gem will play a similar role but in a different manner.

As a rule, the Garnet works very well with all afflictions that need tremendous light and heat wavelengths to modify their structure such as rheumatism, arthritis or in fact any calcification that causes swelling and **inflamation** of the joints. You might say that this category of human ailments is the specialty of the "house" as well as for prostitis and other imbalances of the generative system. The best colors to obtain remedial results in the **de-calcification** realms spread between the deep glowing reds and the light, lively orange-reds, depending on individual response to the variations.

The Garnet is a classic example of a mineral that must be cut and polished before it will deliver its potential for an uncut crystal is of little or no value towards any of the above.

Planetary affinity changes with the color spectrum; the deep red and those of a lighter orange hue belong to the energies of Mars, the deepest and densest reds come under Saturn and Pluto while the pink-violet shades belong to Jupiter and Neptune.

#### **GOLDEN BERYL**

The entire Beryl family has a great deal of changing to go through with some varieties phasing out and others, such as this Golden variety, continuing to evolve. It does not work on the physical levels of matter nor does its range extend beyond the mental plane. However, at that very level is created a balance into the consciousness of man in the intuitive process rather than in the concrete level. The mineral content and subsequent development alloted to this fine crystal will have enormous implications in mans eventual development of the intuition and what is considered the sixth sense. To combine and bring into smoother manifestation the wisdom aspect of mans presently overdeveloped intellect will be the major task of this gem mineral as it has a heavy part to play in influencing the merger of these mental energies with the intuitional ones. Those who are particularly attracted to this gem need its predominantly mercurial orientated energy, of which it is a fine contributor.

#### HIDDENITE

This gem will continue to expand, develop and evolve into a rather forceful gem of a mental and emotional capacity here on the Earth as well as becoming transplanted into a residency of the planet Saturn where it shall meet the future needs on that old but ever-growing sphere also. It will always be a grade higher than your present Emerald and shall remain a deep hued green of comparative clarity and beauty. The Mohs scale of hardness utilized today will be meaningless when confronted with the evolving gems of the future. Hiddenite, for one, will manifest a different chaining together and become so hard and unbreakable within a **nucleous** of its own density that it could not be measured today.

Presently on Earth, though this green gem has barely begun to hit its stride, its color and mineral content can be worthwhile for those who are drawn to it. It exerts a balancing influence over the plexus areas of the body while in a non-conflicting manner acts as a stimulant for the liver, gall bladder and digestion.

#### **IVORY**

Ivory is not to be considered a gem but rather as an extension of the animal who produced it. None the less many beautiful objects are made from it and for those who may be interested or concerned with the vibration frequency belonging to it, let us say that it belongs to the attractions of the third and fourth root races of mankind and that the usage for its original intent has outlived its day. Ivory still has appeal to those who can respond to its peculiar magnetism. Those of the fifth root race and various sub-races in between are overlaps, so to speak, on the ladder of progression and so it is still quite prevalent and in popular use.

Although the Pearl and the Coral are also considered to be a part of the animal kingdom, they are to be equated with the attributes of the mineral kingdom instead for the essence of incubation makes it so. Nothing of earthly animalism penetrates the material from which it is constructed which is the difference separating one category from the other.

Ivory when used as a fetish is mostly connected to astral phenomena and the desire nature. It creates an attraction to the physical element of the individual wearing an object, stimulating it to the degree of its capacity which renders a somewhat negative aspect to the whole subject.

All things being good in their turn, this very trait can render a service if used for integrating a type of animal magnetism if, for example, an ungrounded individual is suffering from tremendous and constant inertia on the physical planning. However there are cautions here as to a sensitive individual this might cause conflict and emotional disturbance. Certain races seem to harmonize with its wearing more than others.

#### JADE

As ancient as it is modern, this gem will have to be considered in the same category as the Diamond for its overall beneficence. This ancient "Prince of Peace & **Tranquility**" is like the Pearl of Great Price doing its quiet act on the stage of human development as a consciousness raiser at the mass level.

Jade can never harm any human being wearing it or owning carvings of it for it does not absorb negative attributes of any nature. Rather it dispells negativity by the constant emission of soothing and cleaning vibrations. It also establishes a cohesive link to the different mental layers of the operating trinities in intensifying the intelligence potential. Eastern civilizations have been aware of the attributes of Jade for thousands of years but much has been warped or lost in the shuffle as ages went by.

It responds well to the planet Neptune and many water sign souls are particularly attuned to it because of this frequency that can also be deceptive. However it is universal in its harmonization with all the known earthly elements for it is a gem stone that is meant to be handled, fondled and utilized by all who are drawn and attracted towards it at given times in a life cycle. Jade works on the feelings and emotions indirectly for the law of sacrifice and duty (a Neptunian concept) has to be aligned with the judgments of Saturn and the stability of Venus thereby producing a slow but **consistant** and penetrating effect over long periods of Earth time. From the same mineral family but of different composition the two basic types of Jade, Nephrite and Jadeite, are similar in effect with minor differences. The Nephrite is in a stage that will alter and it will develop a hue of palest azure blue which will be prized as the imperial green hue is today. Jadeite also will alter but rather than color, the degree of **translucency** is the aspect of change. In a future time cycle the finest **specimens** will be transparent and colorful as the clearest rock crystal with unusual tensile strength, fragility and beauty.

The colors of Jade vary extensively and each has different **aspects** to offer. The color will affect the optic nerves and through this will massage the central nervous system accordingly, while at the **same** time doing numerous little melodies on the mind each a slightly different tuning.

The very light tones of white or cream with minor **streakings** of various veins **has** particular value for those of the zodiacal signs of Cancer, Virgo and Capricorn. It **tends** to soothe the eyes and general nervous system.

The pale mauves and lilacs are quite suited to the expression of the Libra, Taurus and Sagittarius as the spectrum hits the heart center reflecting there as a balancing and calming agent to the emotions.

The deeper greens are sometimes found quite attractive by **Scorpios** and other signs that may be addicted to Jade while the more discriminating Scorpio and the Pisces person will prefer the realm of the imperial green tones.

The yellow-brown and jasper-red type Jade belong to the affinities of the **signs** Leo and Aries. This is not just for their propensity of color alone as the slight variation of mineral content blended into the structure of the Jadeite or Nephrite helps soothe the nervous system through the liver, no less. These "rind" type Jades were and still are much prized for carvings and should not be underestimated for their beauty. They more than once were just as costly and on the same level as the imperial green and exquisite mauve and even today should be considered valuable and indeed be cultivated for the sun signs of each. A piece of this type may prove very healing to the emotions and could be researched.

The **unique** qualities of Jade have allowed exquisite forms to be released from the "unformed" through the artistry of carvers and their tools. Other beneficial energy manifestations in the form of healing await the artist with the tool of understanding. Jade also is not of the Earth but is a mutation from a planet outside of this solar system. **Thusly** was it formed and it is still **forming** today.

#### KUNZITE

Although de-evolving, it serves as a balancer to the **mental** and emotional bodies of those attracted. A stepping stone factor that lends to the mind the qualities of tolerance, receptivity and acceptance.

#### LABRADORITE/SPECTROLITE

This ongoing and evolving member of the feldspar family is continually increasing its linkage with the outer planetary influences of Uranus, Neptune, Pluto and Vulcan, the higher octaves of spiritualized energies. It cannot truly come into its fullest expression until the mass mind has become more vitalized by another fourteen year Plutonian cycle which will further alter frequencies now paramount among men.

Labradorite, also known as **Spectrolite**, will become a definite aid to the illumination of consciousness and the realization of the one reality and it will be as a symbol of the opened third eye for the future sixth and seventh root race of mankind which has yet to manifest.

As it ascends the ladder of growth it emits stronger light and power not only of inner depths, but of a **regenerating** capacity enabling it to alter the processes of mans higher bodies to better align with his gross physical concepts allowing for faster understanding on all planes. Operating through the higher mental or Buddic force fields, it renders easier transmission to the physical level of intuition and inspiration. This gem will instill in whosoever is drawn to it an attitude, albeit sub-conscious, of perfection in all that one is capable of at any given moment. It helps change from personality subjugation to being inspired, motivated and directed by the Source or Higher Self.

The healing aspects of this gem work in the general area of auric balance by putting certain elements and colors back into a deficient or leaky auric field, and can be worn as a protective seal against these openings. Labradorite tends to polarize both the pineal and pituitary glands which aid stabilization of sexual **deficiences** so common in this still very transitional phase of Earth experience. When utilized by sensitives and clairvoyants it can amplify their fields of endeavor and open further doors. Its growing **forcefield** is especially effective to the spleen and sacral centers lending more grounding and stability to mans rapidly expanding consciousness.

Other ongoing and evolving gemstones in the now are serving as good conductors and vivifiers of those of mans force centers which need the most emphasis and working. Some of these very same gems when passing through a particular stage of their own evolution paralleling mans growth will then alter and expand the areas of ability. For instance, the Labradorite which now activities the spleen and sacral centers will, within the next great cyclic energy transit and shift, be enabled to deal and work with the brow and crown centers respectively. These basic statements merely point out that because of mans inability to respond to gem energies above the solar plexus, that these gems correspond to mans most dire need in his path towards perfection.

This gem will be known as a seven ray special as it will operate on all of them simultaneously according to need rather than function from a limited energy focus. Regardless of mans soul or personality ray, or planetary energies, this stone will do what it is meant to do for one and all. This will become true of many gems as the importance of their ray structure diminishes in the face of that which really needs amplification. In the mineral scheme of things, Labradorite is just on the first lap of its journey onwards.

#### LAPIS LAZULI

As the Alpha and Omega, it was utilized in the beginning of Earths creation and will be used again in the end of this cycle of physical manifestation for it is a universal building block, creator and co-creator of this and all universes. Take for instance the coloration of the Lapis which is the royal blue or what can be considered to be primary, and to be primary us to be first but also last, Alpha and Omega. The primary tones in the spectrum reserve a portion of their energy which is periodically **released** much as in a modern day time release capsule thereby building throughout and is a cornerstone block upon which the mineral kingdom rests. Lapis encompasses the universal principle of absolute light as emitted by our sister star, Venus, from whom this mineral radiation comes and was thus given to the Earth by the Lords of the Flame. This gem is one of the cornerstones of Atlantis upon which was built the largest dynastic civilization since the inhabiting of the Earth plane and it still resides as a venerated and respected tool used within the temples of Venus and in Shamballa as well.

To explain in a manner that might be inclusive of what mass consciousness can accept in a more impersonal way concerning the mutation and origins of Lapis, one can bring, or attempt to bring, understanding concerning a group of beings that have evolved into a hierarchy of extraterrestial intelligence that continually aid their sister planetary sphere, the Earth. One does not need to go exclusively devotional to get this concept across, yet the principle in itself does need to be clarified for the average and not so average layman interested in expanding his or her knowledge about this kingdom, or indeed any other.

For purposes of clarification, the term "Earth Man" is a purely relative one denoting the fact that when the unit consciousness known as man arrived on this sphere to take what is known as an Earth vehicle or body the stage of evolution reached was perhaps one full lap behind in development, let us say, of the units of consciousness of those of Venus or Venusian origins. To correlate, those of Venusian evolvement have at their disposal the sixth and seventh senses in full operation. Those of Earth are still playing with **attempting** to perfect the fifth sense of mind and are just now going into the possibilities of the dormant sixth and really have no idea of the seventh sense that is to follow that one.

There are also lifestreams on this planetary sphere that come from other galaxies but man little realizes the multi-faceted assistance he is receiving from so many sources at his doorstep, nay at his very disposal.

Lapis Lazuli in ages past and in ages to come will always be performing miracles of service to those that seek. It strikes at the very heart of love and beauty harmonizing that which exists in the inner as well as the symmetry of form on the outer. Truly does it live in the zodiacal hierarchy of Taurus and Aquarius, the restrictors on the inner translating into the building of structure, foundations and forms of any archetypes that burgeon into manifestation, yet expanding mans horizons on the outer by the efforts at building through these very crystallizations the essence of brotherhood, cooperation and the ability to produce abundance for all of mankind, a point of evolution still to be reached with glimmerings of same just now beginning to be seen by some.

This makes it an anchor of a peculiar nature for it stabilizes human vibration in order to gain sustenance from the Earth in which this vibration is anchored. Both zodiacal signs fulfill their inherent purposes, one in the long dead past and one just coming into activity. The Lapis is part of the second ray aspect, the illumination of mind in man.

Lapis can be used to excellent advantage during contemplation or any form of meditation exercises. This is not a startling statement as this has already been established by other channels, Edgar Cayce being just one example. What has not been said is why this is so. Those whose physical and etheric bodies respond to the Lapis for opening the vital E.S.P. centers can do so because of the sensitivity and the **correspondance** within these vehicles of the base minerals sodium, aluminum, silica and sulphur. These minerals in this specific combination and the environment evolved in, act as "atomic sensors" or stimulants to the major glands and by reflex on the whole endocrine system from the mental level aiding and assisting the imagery and process of psychic **unfoldment**.

This acts much the same as one taking medication to stimulate the thyroid gland mechanism to act on the blood and the metabolism by either speeding it up or slowing it down. Now this is just one example of the specific mineral combinations that act as triggers for various manifestations possible in utilizing these aspects of the mineral kingdom. That is also why in physical therapy it is possible to make remedies with the gem material itself. In a soluable element under heat and pressure the contents may be unlocked to work on the physical bodies of man including those who would not be totally **susceptable** to its attributes in its original gemstone condition. (Refer to section on the making of gem remedies and elixers).

Colorwise, those with deep luminosity, the brighter, more brilliant and exotic hues of blue are the more useful to the aspirant in general. The indigo shades are closely interwoven with Saturnic or karmic gate situations in any individual that is drawn to them. The darker and more unlovely shades are more useful for medicinal purposes even though those who cut and polish these shades think of them as exquisite gems. Pyrite inclusions common and indigenous to this gem can add a positive note if the individual wearing the gem is in tune with this substance. If not, it can exert a miner negative force field or in extreme cases neutralize the effects of the Lapis Lazuli emenations for the wearer.

#### MAGNETITE

Although not specifically a gemstone, this lodestone with its naturally formed magnet abilities needs to be included in this focus of understanding as it is one of those quiet minerals that help to sustain this planets gravity field and is valuable to those who can use those same factors on a more personal basis.

When worn on the person in the form of a ring or pendant or if utilized separately, to further affect its polarity and purpose it can be placed in a pyramid structure or enclosure for a period of between two to eight hours. The resultant effect can actually be felt on the physical level by many as a drawing and pulling sensation as it energizes and eliminates, etc. Healers experimenting with Magnetite instead of ordinary magnets of iron ores find it can be utilized almost three times as effectively and especially when used in conjunction with pyramid energies. This was well known to the ancients and is now being brought into the light once more.

In the Pythagorean school, the pyramid triangle is put to applied practical use basically explaining and reconstructing his theorems which were taken straight from the inner secrets of the then noted ancient **mys**tery schools down through the ages of this planet and are tied up with all of the mineral and gemstone "magic" discussed throughout this study.

When utilized by a healer, the directions for placement upon the afflicted organ or area will depend upon the guidance received from within. It grounds, anchors and pulls many afflictions from the physical, etheric, astral and mental bodies working at all levels available to mankind as well **as** throughout the planet itself. To give a specific example, when a healer has the ability to project and utilize the **forcefields** that can be created consciously, if a cancerous condition is found in the mental, astral or sometimes even the physical realms, though best results are with the "**pre-cancers**" or **pre-physical** manifestation, these Magnetite energies can draw out and dissipate some or all of these conditions. When used in conjunction with a pyramid containing the individual, it is quite effective.

When the Magnetite is utilized in conjunction with other gems it can amplify the benefits. This should be guided also as in the instance of a Garnet or Ruby you have a negation of benefits and sometimes a reversal of the **forcefield** which can bite the hand that tries to feed it.

#### MALACHITE

A secondary copper ore, this green gem is still in the process of altering and growing towards its **unmanifested** zenith of development. Its softness and botyrodial qualities will transmute into crystalline translucence and while still retaining interesting patterning, will become on a par with what the Emerald is today.

This will perform feats of alignment to the crown center, the pineal and pituitary bodies of the sixth and seventh root race of man. It will serve the physical as well as the inner eyes of man, becoming a divine balancer on the chromatic scale of color and be well known for its value to those in emotional imbalance.

Malachite, its blue associate Azurite, and also **Chrysocolla** will eventually take their rightful place amongst the intergalactic federation gems into which they are not yet evolved. Even at this stage the planetary rulership belongs to Pluto as it is a regenerative factor but on another scale of being and particularly so with the centers mentioned.

These gems that are in the "becoming" are to be considered as master keys to the future healing and balancing techniques that will be common usage in, let us say, a projected earth time of 500 to 700 years hence. The transmutation and regeneration of Pluto will no longer be as shattering for higher principles will be opened up slightly more by then in the majority of mankind. However the attributes of Plutonian regenerative function will be equally as powerful in the corresponding kingdoms in nature also. The plant and vegetable kingdoms will produce a finer variety of effects on a higher frequency spiral just as the gems and minerals, and all will have rarified potencies much as is regulated by homeopathy today.

In the field of healing there are many alternatives, as there are as many practitioners as there are ways to do the job. All of the kingdoms are interchangeable to the degree that an individual can respond to the same frequencies in either the herb, the fruit, the vegetable or the gem that is aligned to the same combination of energies. In some cases the utilizations of all available materials can amplify the effects that a healer or therapist wishes to produce.

At present Malachite has a basic affinity with the water and earth elements and first ray aspects. When worn physically it causes stimulation to the optic nerve and visual producing chromosomes of the body as well as aiding and abetting the functions of the pancreas and spleen. Additional ways of physical aid by Malachite can be found under the section heading of gemstone elixers.

#### MALACHITE/AZURITE

As separate minerals Azurite and Malachite serve indispensable purposes, but in their combination or fusion an entirely different and more powerful work is accomplished. This combine creates a force field of ultrasonic, radio-active power. Unlike other types of harmful radio-active materials this is relatively harmless and can be tolerated by the human organism. The activity and **conductability** of these copper ore gem products are serving a hidden purpose beyond the knowledge of those who even suspect the potential of these and other like precious stones. In order for mankind to fully open all of his psychic centers and thereby activate the highest principles yet to manifest on the physical planing of Earth, more radioactivity needs to be withstood and tolerated by the human organism. A positive aspect to the fear and harm of radioactive fallout and overexposure is the beneficent service of causing these needed tolerances to become developed within humanity.

At present, when worn as a gemstone attunement, it affects the mental thought processes and helps purify the dross of illusions on the mental levels. In essence, it superintends benefits related to the crown and brow centers as it allows a mental flow that can aid in **decrystallizing** mental habit patterns that are already outworn but still in tact.

In ancient civilizations major degenerative diseases, similar to our modern day vehicle killer, cancer, were treated with this gem. The mineral combination gives it properties that act as a deterrent to the abnormal cellular growth process of cancer. Any malignancy, melanoma or manifested **karmic** disease of this type responds to the use of this mineral when applied in the correct manner. For details of one form of application see related section under "Gemstone Elixers".

The only time that any tincture or remedy whether of this variety or any other would not work is when the individual has not the permission at that time for a physical healing, perhaps needing to continue with a condition physically that serves an educative need and thus must remain active, or is not allowed to continue upon the physical plane.

However spectacular this blue-green gemstone looks with its sometimes almost garish beauty, its activities match it. The fusion of the mineral molecules of Malachite with those of Azurite set up a subtle nuclear combustion device internally that activates this form of fission enabling all the aforementioned activities to take place. As an evolving mineral it will be even more powerful hundreds of years hence. At that time the human condition will be much better adjudged by the healer-priest and it will be quite common in analysis to determine the exact nature and measure of assistance that is required by a person requesting help. The accuracy by which diagnostic remedies can be effective will be nothing like the hit and miss techniques now in full usage by most.

Today there are no other combinations of minerals that are quite in this category though others similar will exist in the future. Any type of human can benefit by the proximity of this gem combination especially where first and second ray influence are needed together. In time it will reach about 8 or 9 on the **Mohs** scale of hardness, the colors and patterns will stabilize and it will then act as catalytic agents for many undertakings.

#### METEORITES

Not much can be said of these visitors from outer space which drop down to annoy the layman and fascinate the scientist in this treatise, for they cannot be classified as gems even though some are cut, polished and worn by the curious. Their sometimes unusual composition however does offer a unique manner in which interplanetary frequencies can be emitted to this planet, benefiting mankind without conscious knowledge.

## MOONSTONE

This entire grouping is distinctive and promising as this ancient gem of importance and spiritual significance is continuing to expand with this planets need. The spiritual aspect is one of inner growth and strength as its subtle actions deal with the inner planes and the soul connection between man and his higher bodies. This soul connection revolves around regaining when lost, or maintaining the astral vehicle or desire body in a state of balance. Mans tendancy to over-react to emotional and personal situations is much lessened by contact with this gem on a regular basis. One could compare this gem to a cool, soothing balm on an inflamed open wound.

This grouping should be thought of as a conscious, as well as an unconscious spiritual tool, to be used in the maturation of mankind on this evolutionary spiral. Regardless of what stage of development a man may be, if he desires to wear a Moonstone however insignificant, it will stimulate the pineal gland which is connected to the soul essence to assist in the growth process as a quiet boost to the working inner forces.

Here we have a basically seventh ray stone with overlap of the sixth as it is connected to the emotional bodies and the heart on the astral realms. Having attained a high evolutionary status back in time, it has been used as a physical remedy working through the etheric level. It also deals with mild endocrine imbalance in females and can help clear the lymphatics when in a congested or blocked condition.

Colors of these stones matter little except to attract certain persons according to their needs, but the clear, finely polished and flashy gems serve best. Paying **allegience** to Neptune and Venus it will also bring the presently unknown factor of Vulcan into play. Moonstones are very well suited to those with watery elements in their nature with air and earth elements gaining almost equal benefits. Persons with strong fire elements can neutralize some of the effectiveness unless utilizing a gem with extra strong blue flashes which can give a chance to the harmony of the volatile water and fire elements. In this manner this gem is not closed off to any man needing its properties.

#### MORGANITE

This pink variety of the beryl family will not colorate further and as such will not be considered that it should be improved upon. Therefore it is in the process of being "phased out" as there are other more powerful gems already doing more than is necessary for its contribution. The reason for some mineral combinations being phased out is dependent upon the color-light frequency that passes through that particular mineral formation and its probable benefits in allowing it to evolve into a definite contributing entity as a gem. **Goshenite**, colorless beryl, is also phasing out along with Morganite, neither of them being necessary to the development of any scheme on this planetary school be it vegetable, animal or human in nature.

#### **OBSIDIAN**

A volcanic glass, this material is and will remain static in its present state for another cyclic block of time. It is in period of total rest, a void, a cooling off time as so much of it has been utilized for the lower forms of magic that it is impregnated with thought forms of like magnitude of negativity about it. Yet the potential for its growth is such that there lies the seed that must wait for the right hour to develope safely, slowly with positive and amplified power.

#### ONYX

Still early in its evolving ongoing, this material will never gain a stage of what can justifiably be considered gemlike. It is a porous and absorbtive type stone, not a receiver, that can take into itself, or handle, a lot of negativity and at the same time pick up positive frequency. Its inability to hold these absorbed energy vibrations for too long is the reason that there is not too much harm or good that can accrue from its use. Its low level frequency serves the human race in its need to stabilize to the Earths atmosphere, however there are other gems which may serve the same purpose better.

As Onyx develops it will overshadow the marble in use today for it will become stronger, more translucent with a rather prodigious variety of colors. It will be well placed as building fronts, interior and exterior decorations and in art and sculpture.

#### OPAL

It is only the fiery quality of the medium of the best grades of this developed gemstone that we will deal with as the milky type without fire serves differently and not at all in the same manner even though the basic mineral derivatives may be alike. The flashes of opalescent color and fire duplicate the astral spectrum, as closely as it is possible for an earthly object here on the physical plane, which can be utilized in reaching the highest spiritual levels of sight above the astral regions. As the spectrum of light goes beyond the astral realm it becomes even finer and the frequencies are charged with matter of particles even more subtly and exquisitely hued.

In its own fashion Opal can do this for mankind especially when working in transmitting color therapy and in working on all of the spinal force centers of man. Opals have the distinction of being able to work on more than one force center at the same time with some black Opal varieties being able to work on all of the centers at once equalizing and balancing as necessary without man having to consciously know or direct this functioning at all.

Taking the centers individually; for the crown **chakra** the flashes of golden orange, green violet and blue fire on the darkest grounds of black Opal serve as an opener. Black Opal is a most highly illumined and developed type of gem and it is the blues, violets and greens that mainly turn on the brow center. The throat center is stimulated by the green and gold fires particularly. The lighter ground of Opal, white with orange, red and green flashes stimulate the heart center, while the solar plexus center is stimulated mainly by the blue and violet type that is paler in intensity. The **spleenic** and sacral centers respond well and quickly to what it known as the best quality of golden red fire Opal, good quality brilliant cherry Opal and also Fire Agates with red-orange lights. Oddly, this Fire Agate with Opal frequencies is another that works on the crown and brow centers.

This entire gem variety is a mutant that will continue to develop spectacularly so that the informed of Earth can utilize it for the benefit of mans sixth and seventh senses and to aid the building of the bridge between mans ordinary waking consciousness and the eventual awareness level of cosmic import, that links man to his highest bodies even when manifesting on a planet physically in dense and gross particles of matter. Therefore there will be less separation from what is now called the Earth or lower vehicle and the eternal light or soul body.

The use of Opal in its various forms serves this unification and aids in its formation, though not by and large felt by the majority of mankind attracted to this gem. Here too is a gem that will be of even greater usefulness in the future when it will be worked with consciously. The process by which one has to work with Opal is of necessity a more delicate proposition on all levels. Its nature is such that it can shatter very easily, especially where one does not know how to care for its porosity in the handling of it. It requires attention and knowledge to get the best from it for it does, to a certain extent, absorb human duplicity and dishonesty. This then works with the **karmic** law of returns and therefore its sometimes stigma of being unlucky which is nonsense as it is never the fault of the gem, but that of the wearer.

To classify the colors with the elements, fire Opals in the blue, green, violet categories up to and including the black grounds serve the elements of air representing **Aquarius**, Gemini and Libra, for they serve as catalytic agents in the three layers of mind upwards to the highest levels. This intensifies and eases transmission between these signs of those who have the task to teach, to judge and to harmonize these elements of man. The air element allows the colors to remain volitle and to flow more freely.

The milky, opaque and shimmering varieties serve the element of water in Cancer, Pisces and Scorpio in soothing the emotional and mutable qualities inherent within the natures of these signs. Not all persons within these elements are able to properly respond or utilize these **forcefields** of energy. Within the realm of **Neptunes** locker these fiery flashes need to soothe as they ripple for as much as the three water signs are different in their mode of expression, so too can the various fixed cardinal and mutable watery energies respond on all the levels. However the Plutonian Scorpio can definitely wear and utilize the deeper and brilliant shades of all types of Opal. Moreso if one is aspiring to gain a foothold in the intuitive realms of understanding. The individuals representing the fire element upon the Earth and pledged to serve and sacrifice selves on the altar of matter in order to grow and become co-creators with the God-head are fit to use and wear all forms of the fire Opal as well as the fire Agate as symbols of their mission.

For those of the element Earth represented amongst men sufficient modifications are important factors relating to the harmonious utilization of Opal within their overall energy patterns. Generally this element is not attracted to Opal at all but this can be dependent on the element balance in the individuals chart.

#### LOSS OR CHANGE OF OPALS COLOR

The changes or the leaching of color out of an Opal, or any **gemstone** being worn, is a phenomena that is attached to the density and strength of light waves being emitted by the person from their collective higher and lower bodies. These emanations are constantly varying but the person who is basically a combination of, for example, the fire elements that are being manifested in a given life cycle will always tend to drain and transmute matter more than any other variety of elements in mankind.

Other elements such as water will blend harmoniously with **certain** colors and deepen them in what is considered their original state, while the airy element will pretty much leave the gemstones as they are taking only what is needed from them but allowing the physical particles of the gem to remain unchanged. The earth element, if predominant in man, may inhibit electron flow and depress the gem itself from transmitting. This is especially so if there is severe blockage and resistance within an individual of this basic element.

Again, a gem stone particularly suited to the earth element would override this tendency and do its work regardless. It would be other less capable stones that would be left standing in the lurch, so to speak, and that is why so many Earth gems are in the process of being developed for Earth mans highest development future.

Generally speaking, persons of all elements may with good results wear and utilize the Opals special talents. However it is best to try to obtain for each individual the type that their physical, astral and etheric particles would respond to without draining the color spectrum out of it. The biggest offenders in this category are the very strong fire sign people as they literally squeeze the gem dry and then it needs time to recoup its color forces once again.

There is no other gemstone that can be depleted like the Opal but there are some that can be transmuted. The Amythyst, for example, will automatically work on the energies of the wearer while retaining its own integrity. Its color has been known to alter into a bluer or pinker shade but that is about the extent of change again depending on the electrons being emitted by the wearer at that particular time. The only other exception of note is the Turquoise which certain individuals cannot wear without changing it from blue to green, but this is almost as much the fault of the gem as it is the chemical balance of the wearer.

#### THE STAR OPAL

Peeking into the future beginning with the seventh root race of mankind, there will be developed an **asterism** of Opal which will flash into an organized structure such as the Star Sapphire of India today. The play of colors should be so blinding and spectacular as to boggle the senses, both inner and outer. This will be a mutation based upon presently existing Opal of a fiery and colorful nature.

This dynamic gem from out of the mineral spectrum of active workers can only be utilized by specifically trained individuals who will have been used to entering extreme highly charged, high voltage frequency force fields. This is due to its ability to clarify and intensify mental integrity to a level unconceivable to man today and will be able to teleport the consciousness consciously to points of destination bridgable and spanable by mind rather than bodies of a physical nature. It will be among the inter-galactic communicable devices.

This gem mineral is to be progressed far longer and higher than any given thus far and will have added to its basic composition additives from outer space at specific times which will make the necessary molecular alterations raising its powers and its protective principles. This will be found not only in the Opal fields of Australia, but also in South America, Mexico and areas in the southwest United States where Turquoise is presently being hacked to death. The Star Opal will help amplify the race consciousness to hitherto unsuspected levels of efficiency and complexity combined with inner know-how on the on going spiral.

#### **MISUSE OF OPAL**

Ironically Opal is grossly maligned and mistreated by the colorful combinations of other gemstones that they are inflicted with in expensive jewelry settings. The purpose of Opal is obscured by the inharmony of less worthy or incompatible gems surrounding them which can neutralize or cancel out the Opals effectiveness relegating it to the bottom of the gem field rather than its rightful position at the top. As mankind rises in understanding he will automatically be less and less attracted to erroneous, sometimes garish combinations of gemstones in jewelry. This has already begun to be felt, wondered and commented about in jewelry trade journals.

For those who need a fairly accurate guideline, the only basically compatible gems that may with impunity be combined with gem Opal of any description are; all colors of Diamonds, Labradorite/Spectrolite and quality Moonstone from the feldspar group, pink, green and blue Tourmalines and occasionally, under direction, a violet Amythyst.

The most common error in the now is to combine the Emerald, Garnet, Ruby, Sapphire or Lapis Lazuli with Opal and these fine gems simply cancel each others effectiveness. At a point later in time many developing gems unfit to use in combination now will have reached the approved category here.

#### **OTHER UNDESIRABLE GEM COMBINATIONS**

Opal is not the only important gem being offended as the next largest Earth problem in the jewelry and artiste area is Jade. The usual occurance with gem quality Jade is Diamonds, Rubies, Emeralds, sometimes Sapphires and other odds and ends of the mineral world. With the exception of the Diamond, all other gemstones when mixed with it reduce the stability quotient and inherent contribution of fine Jade to the level of colored glass. Its greatest benefits are dispersed when it stands alone. Quality gem material from the Moonstone group can also be a problem unless **supported** by proper harmonious gems and the Ruby is not one of them though quite often used. The Diamond is acceptable with most all gemstones but the Moonstone does have a basic affinity with **Sapphires**, **Amythysts**, Olivines, pink Beryls and the phasing out **Kunzite** through compatible tone levels.

Lapis Lazuli is another **popularily** butchered **gemstone** of antiquity. This gem can be beautifully reinforced by the addition of the Diamond and **also** Chrysoprase of fine quality. Other gems in combination tend to reduce the power and worth of this ancient and modern blossom of beauty. The green Chrysoprase in combination with the blue Lapis was well used before and during the Atlantean time sequence by the **hierophants** in their work. Other gem combinations used then often do not serve in the now due to the continuous change of Earths energies.

Now a combination that seems undesireable and is not commonly utilized because of the supposed softness of the resin involved is fine quality Baltic Amber and Diamond. Yet the importance of amplifying the power of this valuable resin should be stressed, explored and experimented with especially in the combination of the white, yellow and brownish Diamond colors. The combination creates a dynamic healing field almost **un-parallelled** by any other gem combination utilized today. The created magnetic absorbtion and the ebb and flow with only positive results cancels out any residual that other types of gem therapy may be associated with even inadvertently.

#### PEARL

This elemental jewel drawn from the depths of Neptunes larder brings with it a mixture of attributes when worn or utilized by man. It has definite curative properties which can capitalize on the calcium and generally highly evolved mineral and protein content indigenous to the material out of which it was originally formed.

As concerning the spiritualization of this jewel, during the Piscean age it was an important and critical factor, you might say a representative of the coming of the disciple Jesus, initiation, and the process of reaching that level of attainment. It was not just a symbol of his mission and teachings during this last two thousand year cycle, rather it remains a visual-physical reminder of sacrifice and the achievement rendering the heart and mind as pure as the practice of love can make it. The Pearl is also intimately connected to the work and ministry of the mother, Mary, to lessen the suffering and agonies of unredeemed mankind through the application of **karmic** law. Therefore, even today Pearl stands as a perfect representation of the inner attainments derived from an almost total perception of the Neptunian law of sacrifice and higher love when tuned into the responsibility and directives of Saturnian might.

Like the **Diamond**, the Pearl requires a commitment to responsibility according to the understanding of its wearer especially paralleling the operational aspects inherent to the law that it is the "seed" germinator of. The destructive effects of the Pearl of course will not be felt in the same manner as the Diamond, but the negative energy patterns are directly absorbed into the jewel by whomever wears it which impregnates the Pearl with a force field that is capable of causing extremes in mental and emo**tional** reactions. **Moreso** for those who have a preponderance of these negatively polarized force fields as the Pearl is a holder of this, and **boome**rangs them back unto the wearer. This can go on at totally **un-conscious** levels. Though seemingly negative, this in one sense aids development through self applied confrontation.

The Pearl with the most potency along the aforementioned lines is the totally sea-made object with top quality cultured Pearl running a close second. The coveting of these so-called "Pearls Of Great Price" in past days as well as in the present, is only again re-paying these individuals with the retribution of natural law working within them. The contribution of this jewel from beneath the sea is to make a reality of how mental and emotional crystallizations can shatter so that man can be inwardly free.

Irritation, the **causitive** seed of the Pearls development holds the clue and the key to its divine purpose of transmutation. Its humble beginnings serve as a mystical example of how high an insignificant element can rise no matter how it is oppressed. The struggle of each human in its unique road of achievement can be likened to the Pearl in its oyster, growing under pressure, discontent, self preservation, and under concealment. This gem deserves to be worn with respect, carefully and with pleasure.

Regarding cosmic influences, the Pearl expresses itself through Neptune sharing honors with Venus and the Moon. Reflecting the more physical and temperamental elements dealing with emotions and the patterning of these emotions, places the Pearl into a category for therapeutic use aimed at alleviating negativities in those who are susceptible to these instabilities. However when used in this way, care must be taken not to hold what is absorbed but to clear the jewel so that it can be re-used for it can be an incredible tool when utilized in these instances. One form of tool may be found in the section called gemstone instruments.

Those whose zodiacal signs are of the three watery elements could find themselves peculiarly susceptible due to their characteristic emotional intensity. In the field of the earth signs the qualities of the Pearl could crystallize weaknesses native to these. Within the three air signs the Pearls energy could excite the central nervous system sometimes contributing to emotional irritation. In the fire element this gem finds conflict and a large amount of steam building up. The combustibility of the element fire can easily distort itself when contacted by the principle contained in the Pearl which could lead to self opposition and obstruction in the use of the will. These examples, of **course**, are only partial indications of expression and serve only as an example of many possibilities.

Some gems used in combination with the Pearl can, to some extent, neutralize the negative force field that the pearl alone would ordinarily create. Some combinations can be most devastating such as the Diamond and the Pearl for neither one can neutralize or cancel the other out, but instead feed on the deficiencies of the person wearing them. Working on the principle of the Hindu goddess Shiva, the destroyer, fulfilling a necessary function for **mankind**, it sometimes seems to be a destructive one. However, anyone drawn or led by desire to wear this combination or one similar to it is lead by their own souls guidance to quicken the action of **karmic** law in purifying their own negative **crystalizations**. Therefore if anyone so wants to use these jewels it is because it is necessary to their evolution at that moment. The popular usage of this combination indicates a generalized need and desire for this activity to take place as frequently and as subtly as it does.

The Emerald and the Pearl are also often used together and this combination maintains and amplifies whatever negativity is held by the Pearl through the wearer. In one sense, this can through negative feedback erase certain lodged resistances and pre-conditioned responses by the over magnification of the same energies held. This is similar in process to Homeopathy. In this combination the Emerald feeds the already engorged negativity of the Pearl. This makes it more uncomfortable to the wearer though not reacted to consciously for the most part, but frequently reacted to in ways not even noticed by the self. One might say that although the ramification of this mixture is quite negative, its overall results are on the positive side.

#### PERIDOT

This is a gem that has received its glory and fame in ages long past when its popularity was most distinct as it emits a soft glow rather than a harsh glare. It was used in Atlantis, early Egypt, and the Aztec, Inca and Toltec civilizations, where it served well as a calmer, purifier and balancer of the physical organism that man wears at this, his basic level of being. It was used extensively because the high content of yellow within this green gem was a necessary adjunct to the stimulation and development of mans mental equipment in that realm of the evolutionary arc, as well as supplying balance and emotional tranquility. It was and still is to be considered a double duty gemstone. Because evolution overlaps so much at each new turning of an age this gem is still operating much as it used to by persons requiring its specialized tasks.

It also aids in the absorbtion of foods undergoing digestion, is a **dis**tinct aid to inflamed and ulcerous conditions of the bowels as well as easing constipation of the emotions. The **spleenic chakra** is a specialty of the house and also in disturbances of partial retardation due to chemical or emotional congestions. Peridot has an affinity with Venus-Taurus and reflects the muted, therapeutic antiseptic cleansing effects but as a quiet member of a subsidiary group.

Peridot should be considered a tool for further expansion and enlightenment of the physical burdens especially when utilized by the clairvoyant or trained healer. This gem will come into its own once more when the use and application of all gemstones is recognized as valid and beneficial. One other manner of recieving aid from this stone can be found in the section called Gemstone Elixirs.

#### PYRITE

This crystallized mineral, as that is what it technically is, will again become transmuted into an ongoing metal composition but will not come into its own for another time cycle. Although this stone should not really be considered for actual Jewelry, tempting as some shapes may be, it does have a healing and beneficial aspect similar in strength to that of Lodestone. Instead of being worn it is of value just sitting on the shelf but can be used in particular through understanding how to project it, mentally and otherwise.

It can be of aid in clearing the oxygen in the blood and in strengthening the entire circulatory system. It also can aid the grey matter of the brain in tissue repair from birth defects, etc. In conjunction with certain other gems it can be used as a powerful transmitter when projecting towards persons with these specific needs.

### THE QUARTZ FAMILY

Commonest of minerals, Quartz can be divided into two groups on the basis of its appearance, crystalline and microcrystalline. The crystalline group is often made up of large well formed, colored or colorless crystals which we shall consider individually. The micro-crystalline group is called Chalcedony which is made up of the various agates, jaspers, etc.

#### CLEAR QUARTZ CRYSTAL

The varying geological climates, altitudes and differentiated topography during the various epochs of **pre-history** before the dawn of man upon this planet all contribute their special factors in the essences derived from the substances called gems. Though the termination or other minor differences in the shape of a given crystal make no change whatever in its effectiveness, the areas in which they have grown and developed do create divergencies of energy patterns. For example, the huge quantities of clear Quartz crystals found in the Arkansas territory have enormous currents of energy frequencies issuing forth, **moreso** than many other areas where Clear Quartz is found.

The unadulterated clear Quartz provides an almost limitless field of function in **itself**. Depending upon the clarity with which a crystal is blessed is also the range of its total operation. Internal fractures with prismatic color **effects** can be an **amplifier** to this gems work.

The size of the crystal utilized does matter in that each has its parallel and corresponding tone with which it can be aligned. A symphony of tonal sounds within the inner planes can set the energy patterns to vibrating especially if a healing exercise is in progress. The really huge specimens of clear Quartz are of themselves a force field of light or energy which can be used as a sonic protection against negativity. This field exists according to need in all crystals including pocket size specimens which the Indian and many others today do carry with them at all times.

This clear form of Quartz can serve better than any other mineral alone or in combination to balance and heal the aura of those mental and emotional aberrations which can and do occur with frequency, even among the very tender in Earth years. The passage of ions through the molecular structure of crystal makes it of value, besides working with individual auras, to larger areas where atmospheric conditions need to be cleared and neutralized of negativity, etc.

As one of the best over-all balancers in the mineral kingdom, it lends itself to de-congesting the various force centers that the human being activates and stirs up from time to time. It works especially well with the sacral centers and in cooling off prematurely stirred up and erratically moving **kundalini** forces that so many misguided spiritual aspirants think is the doorway to inner and outer power.

The refraction of a clear Quartz renders it active as a personal healer for the body as it works directly with the separations of the layers of disconnected mind, attempting to re-integrate the levels of consciousness. This then becomes an excellent tool for use with aberrations and **possessions**, psychic attacks, etc. whether on the astral or mental realms. A tool that could facilitate this work can be seen in the section called, "Instruments for use with Healing".

Regarding zodiacal influences it is predisposed to work more in harmony with the water and air elements but like the Diamond can be well used by all. Its affinity is with the planetary consciousness of Uranus.

## AMETHYST QUARTZ

This purple Quartz gemstone belongs to the divine order of the Flame of Transmutation. Its infinite variety of tones and shades are due to the mineral Manganese with others. On Earth, Amethyst is the gem that represents the process of alchemy be it of physical, emotional or spiritual nature. It is utilized for molecular and cell alteration of organic substances, plant, animal or human, because of the ultra violet spectrum contained within that is brought into physical manifestation. Amethyst is a powerful energiser as far as transmutation potential is concerned because it works on the triune level of mans consciousness, assisting the transformation of decrystallization in habits, speech, thought processes, emotional feeling etc.

Amethyst can be classified as a cleanser as well as a spiritual stimulant. It has the contributing power to disinfect certain conditions of the central nervous system when used in conjunction with other forms of therapy. This gem is well used by the healer who can project **its emenations** or who can utilize violet light projection. This aspect is aligned with color therapy, yet augmenting it because of the value of the natural combinations within the gem crystal itself. Its benefits can also be derived through the focal point of a gem remedy which is described in the section of this book called Gemstone **Elixers**.

The processes of ceremonial magic and the manipulation of large areas of magnetic forcefields can usually be augmented by the addition and **use** of good Amethyst. It is a powerful and vital "thrower" rather than an absorbtion crystal. Being in the ultra-violet spectrum, it works along with the ultrasonic wave lengths of sound in the fields of music therapy and medical surgery as well as on levels not seen by the five senses of man. In a yet undetermined future time the Amethyst will be a tool utilized in sonic surgery, operating a bit like the laser beam used now but with much less destruction attendant on its use.

It follows then, that certain frequencies of this gem may be extremely disturbing to a person with severe neuroses or Psychosis, yet in the realm of catatonic and maniac depressive problems this frequency is soothing and healing. But those with a chemical imbalance in their bodies tending **to**wards the more schizoid forms of behavior including paranoia would find this gem quite disturbing and contrary to their needs as too much of an opposing force.

It is not the issue here to go through the whole list of mental disturbances but to give one an inkling of where this stone's capabilities lie. It is to be considered a stimulant even when acting as a nervine, for where it quiets or pulsates towards activity, it does so with a high density vibration.

Amethyst has a zodiacal affinity with the fire elements and in particular Sagittarius and Aries. The air and water signs can be served differently and well while more resistance is encountered with the Earth signs though not in all situations. The planetary body ruling Amethyst is Jupiter with Pluto and Uranus co-hosting.

The very deepest shades belong to Pluto, especially those with a violet or red tinge, these being the most powerful transformers of the group. This also correlates to the red and purple magenta being the seat of sex polarity and the kundalini which works as a stabilizer and energizer for this force at different stages in different times of development. When used in healing it can balance and offset imbalances in this area of sex differentiation.

Those stones that are quite deep and have great depth of tone without any red shading but do have what is known as a bluish cast are in reality the Royal Stone spoken off in ages past. This belongs to Uranus and works at diffusing crystalizations in persons, atmospheres, environments, etc and is related to the central nervous system in man. This shade was also used in religious ceremonials and is the devotional stones utilized by the clergy.

The lightest lavenders to the most popular intermediate shades of variable tone almost up to but not going into the depth of the other shades are the Jupiter gems. This energy works upon the lowest triad of mans nature and though it is the most diluted in effect it should never be **under**estimated as it is quietly beneficial much as the nature of Jupiter. They can be used to great advantage by devotees and mystics for the serene brilliance that can fill the aura while meditating with one.

The reason for the Amethysts very profusion on this planet is for the obvious and necessary process that this planet is undergoing in the spiral of its evolvement. It therefore requires as much aid in alchemical transmutation on every level that it can obtain, the Amethysts being so far the best and least expensive source. Remembering also that too long or too frequent wearing of these frequency gems may provoke too much of a good thing and should be put aside for a time, when indicated.

#### CITRINE QUARTZ

The type of Citrine known as Smokey Quartz has been much misunderstood and de-valued regarding the element within it that goes towards rendering it a useful instrument. But those who serve as care takers in the wisdom tradition of this realm must realize that it operates as an atomic cell. Much as the neutrons are used to bombard gemstones so the neutrons contained within the smokey coloration act upon the psyches of man, these neutrons having a common atomic and cosmic source. This irradiation quality that is indigenous to this form of the quartz family is one reason why its scope of healing is limitless as it works on all the bodies of man.

Back in the Atlantean era it was utilized as a focal point of energy especially by those being trained as trance mediums in the giant healing temples. It was used with a form of hypnosis not now in general usage but slowly returning as an advanced form of mind control. Hypnosis as we understand it today is not really hypnosis but is more closely attuned to a method of magnetic transference which is a dependency mechanism that eventually will be abolished and transformed into a more useful form of healing. Man has to learn to shift levels of consciousness for himself and this gem can help sedate the lower vehicles into obeying the behests of the higher will.

Morion or Cairngorn, as the Scots and Celts so named this Smokey gem, emits an ultrasound frequency that creates tremendous healing at the etheric and mental levels where it works like an invisible laser beam cutting through much of mans density. At the same time on the physical level, it is acting as a sedative and **relaxant** to all types and natures. That is why it is so often used and by so many. It is an invaluable aid to man by its very availability and by what it can do for him in the now. The Celtic races always had the distinct advantage of instantly recognizing a mean-ingful piece of physical matter and utilizing it. However unconscious this process still is with many of them, the average **american** and european still use this stone for the very same reasons of old.

One of the first ray stones, the planetary energy patterning is **Satur**nian in frequency lending more stability and responsibility to its use than formerly thought. The alternate planetary energy it is charged with is Plutonian for its atomic ultra-sound source. When seen by eyes on another level, this beam of sound shatters density within particles of etheric and mental matter rejuvenating and recycling, as it were, on high frequency levels.

The golden variety known as Yellow Citrine is another entity. It is a direct stimulant to mans mental bodies and serves to aid in opening the bridge span between the higher mental and the lower, and on up into the intuitional levels of the mind that relate to what is popularity touted as "Cosmic Consciousness." This acts, of course, as a stimulator and not a generator.

On the physical level the lighter, pale and straw shades are especially prepared to work with the colon, gall bladder, liver and the entire digestive tract, disinfecting, purging and eliminating toxins and other undesireables accumulated in this area of the body. This works its inner and outer "magic" again on a sub-conscious level of awareness. It does promote clarity within the thought processes on a mundane level which is why it is so largely used by so many. When projected mentally expressly for the purpose of healing and purification it is well utilized, as when ever any gemstone is purposefully projected by the thought power of man, it is amplified to the zenith of its capacities.

This yellow Citrine serves on the third and fifth ray of life and its major planetary energy comes from the influence of Mercury.

The type known as Maderia Citrine is the deep fiery, orange-red-wine member of this group. It needs to be re-classified and also re-named if possible as the frequency and vibration range which it possesses does not come into any of the others in the Citrine family. The closest one to it on the vibrational wavelength within the quartz family is the Amethyst. The Maderia shades should be considered in the fiery elemental range and therefore basically is working along transmutational lines, only less so than the Amethyst and in a very different manner.

It can in truth be called "Fire Quartz" and belongs to the magnetic field associated with the solar plexus force center in mans higher and lower bodies. This stone can work upon transmuting fears on an emotional or mental level and pulls out these thought forms from the solar plexus unblocking any congestions that may exist including inherited ones.

In fact it is of invaluable aid in the popular sport known as Exorcism today as it really does its work when it is called for. This sixth ray gem has a Plutonian frequency and is amplified on the physical plane by Mars.

#### **ROSE QUARTZ**

This is a stepped down version of what any pink or red variety gemstone can do. In this instance it is soft and useful where strong frequency is not desired as it might conflict with other things. However on a physical level it does treat certain organs of the body relating well to the kidneys.

It is another calming agent as is Smokey Citrine but on the emotional or heart center in particular. This is especially so if one is led to it. The Rose variety will eventually be phased out due to so many more effective varieties in other mineral combinations that can take its place without loss. As nature is not wasteful, when something has outlived its need or usefulness it is eliminated, period.

#### **GREEN QUARTZ**

This Quartz family member will become an entity unto itself, more clearly defined and quite nice to look at, but will not be considered special until large blocks of time have elapsed.

#### **BLUE QUARTZ**

This variety will do somewhat the same as the Green but will have the advantage of developing more rapidly and gaining recognition sooner. It will become quite clear with a large gradation in the color spectrum giving it some interesting qualities. Though sooner, it will also require large blocks of time before becoming useful.

#### **RUTILATED QUARTZ**

Here we have an additional factor with which to consider as the element Rutile contained therein gives facets of power and transmission with an even greater intensity than its more clear and passive brothers and sisters. The Rutile which is entrapped within the Quartz crystal structure bears cross currents of electrical charges that pierce through layers of almost inpenetrably thick density much as jolts of high voltage being pushed on and off when playing with a light switch.

No matter which color the basic Quartz crystal may be the electricity that this additional factor brings towards the gem in question makes it more powerful, more magnetic, which amplifies that particular healing activity. It has the additional property of never wearing out thereby remaining a constant to be taken advantage of by whomever is in need of these properties.

Rather than considering this an undesireable inclusion within a given crystal, it is the exact opposite and needs to be ranked with the top priority gems of the most valuable order in this capacity. The needles of Rutile when oriented often form symbols of triangles, crosses, etc. within a cut gem which is one of the outstanding features prevalent here. It does indeed reflect many additional aspects because of these additions.

Rutilated Quartz, when projected into the mind layers of consciousness on an individual who has severe disturbances of an endocrine-sexual incapacity, can release energies that can be quite effective in adjusting these types of physical wiring errors. It is also quite penetrating and of benefit when used to project its electrical energies into an infected organ of the body. These **rutilations** are useful in holding magnetic **forcefields**. It can even raise the body temperature temperarily because here **is** another tool that can reorganize cell structure.

This process is alchemical in nature as it transmutes disturbance and leaves a foundational structure upon which can begin the building of healthy tissue and cells. Again the key lies in the electrical current which jolts these cells on the etheric level and filters it down into physical manifestation.

#### TOURMALINATED QUARTZ

Clear Quartz with inclusions of black Tourmaline crystal needles are combined to give mankind a tool to use in magnetizing the forcefield dealing with the universal law of opposites and does some really interesting work on the inner planes in the higher vehicles of mans consciousness. This is an aid to eliminating many conditioning patterns that have been crystallized and destructive to further progress and growth.

Because of the earthly opposites contained, they implement lessons that many humans have to learn. The imbalance in any one instance that an individual may suffer can be put into better alignment by projecting this type of crystal within their mental and astral auric fields which will act as an instrument of automatic adjustment. Both **Tourmalinated** and Rutilated Quartz with their interspersed crystal needles act as light bringers to the astral sheaths in general and are good tools for projecting practioners.

#### TIGEREYE

The fibrous inclusions within this aspect of the Quartz family will go through many more stages before hitting the peak of its development. It will alter and transform itself into a much more refined kind of gemstone, lovlier in every way than the current popularly known yellow-brown-gold variety.

The eyes and asterism will remain even as the density changes while clearing and turning more translucent and crystallized in nature. In time a natural blood red color will be added to its varieties as well as some of the greens and blues which are currently artificially derived.

At this present point in time Tigereye works primarily on the physical level as it is not a spiritually refined gem relatively speaking. It works on the large mass consciousness presently utilizing it as a mental disenfectant helping to separate false desire from need, and it attempts to aid in the purification of the bloodstream and visceral organs after overindulgence in items well known to pollute the human organism. However, it does not have the strength to always be listened to effectively.

#### CHALCEDONY: QUARTZ AGATES AND JASPERS

This enormous grouping of Quartz has unparalleled opportunities to serve mankind in a multitude of ways. Let us begin by saying that all the varieties in this huge family which are fit to be used as gems in any manner whatever are extremely valuable. We repeat, valuable, as these stones affect the physical body first at the densest levels and then picks up the layers and levels of some of the higher bodies as well, depending on the particular quartz that one is focusing on. In its present stage of development it works from the lower bodies upwards but not from the higher bodies downward as other more evolved gems discussed in this work.

In recent times these gems have been down-graded, taken for granted or totally ignored except for the hobbyist or faddist. In long ages past however, it was recognized for the values now being reinstated and used very effectively. It is misunderstood because it is so common a category, yet it is uncommon to the extent that very few can forsee or even imagine the wide variety of physical ailments that it works on subtley and sometimes dramatically if one can feel the harmony of the mineral kingdom at all.

Some ongoing Agates are altering, some are being "phased out" and others will remain much the same within their own already stable structures. Acting as mans significator in the mineral kingdom and aligned with mans progress in his evolutionary spiral, Agate follows him growing and working with him till the very end of the cycles set for this planet, until the next greater cycle.

As man evolves, so too does the quality and variety of Agates that grow with him. Each individual is a reflection of certain combinations of Agates which would be in harmony with his physical body type or mineral content. Therefore what one would find appealing and necessary, another would merely discard. This is a process similar to natural selection.

One can then consider that we are each of us an Agate in one form or another for this substance is like the basic amniotic sac of fluid from which life emenates, is actually a key to the evolving life on our world as it exists and should not be under-estimated in any way. For as we have our existance on the physical plane, divine mind sees to it that the correct substances are given to balance our inequalities while undergoing the vast rounds and cycles of experiencing this realm. What better gift from the powers that be than the easily available and beautiful Agate that holds life in its very molecular structure and transfers and transmutes its qualities to man when he wishes to respond to them lying there waiting to be utilized.

The color variations within the various agates are based strictly upon the minute and often undifferentiated inclusions, trace elements, etc, within the stone itself. Personal choice or preference of agate colors again reflects upon the individuals own unique combination of minerals, their distribution, balances and imbalances in a given physical vehicle, as what may appear restful and soothing to one person can be quite irritating or disturbing to another.

Another facet is the very significant and meaningful symbolism that is often found in patterns, colors and forms of these varieties of Chalcedony which are more enhanced with proper orientation. This is seemingly accidental and at random and in a way it is, but in a more universal aspect, it is not. Actually the whorls, ridges, eyes, circles, crosses and indeed even pictures of landscapes and scenes are a representation of the macrocosm, in the microcosm of the mineral kingdom. They all have their part to play in the drama of the coming New Age and cannot be overlooked in importance and relevance to what man is doing here.

The more highly polished and beautifully executed a piece of agate is, the more reflection to the beholders eye of clarity of expression and understanding which that precise piece of agate may have to offerits owner. The more outstanding in artistic composition and balance a piece is cut and polished, the greater the chance of it performing **beneficiently**. In as much as the more simplified and crude form of mass tumbling is concerned, this can produce some exceptional pieces. In general, however, the level is not as high nor need it be pursued by one who truly loves the value and meaning of this mighty and unique category. The overall shape of the finished **gemstone** is again symbolic and produces its own contribution to the already existing force field. For example a triangular stone will manifest aspects of the trinity, a square for balance and foundation, the round for eternal life, and so forth.

This broad classification of stones is in a category almost by itself as a key to evolution and growth spiraling upwards, just as man is spiraling upwards, both affecting and being affected by progressive development. This puts it in a unique position that other gradations of gemstones have already passed through. For instance all of the so-called precious, on-going groups of accomplished, spectacular and fiery jewels of the mineral kingdom can be compared to having gone through various selected initiations of their own order while most stones from this group as well as mankind as a whole have yet to accomplish this in order to go beyond their present kingdoms.

As to planetary influences, let us again bring you the mainstream of thought and say that all agates are part of the Earth and thereby are under the dominion of the Earths magentic force field and its auric envelope. Outside influences of other planets can coordinate but will not drastically affect them. This then is the gem of the Earth. Other accomplished minerals as stated have other masters, so to speak, but Agates arising out of Earth will always be the special product of this planets atmosphere even though they too will take other initiations and travel back and forth as required to other planetary schools during many future roads of evolutionary rounds.

Combination of the advanced species of initiated gems with the various forms of Chalcedony brings in an additional factor which helps manifest even more its attributes to the wearer. However it behooves the one doing the combining to see to it that the combinations are harmonious to the individual needing the boost, as it were, else the Agate or Jasper would be nullified or overridden leaving only the "power gem" operating as a contributor.

## CARNELIAN AGATE

This fully evolved form of quartz is a highly rarified type of gem and carries a similar vibration to Ruby, Garnet and the more orange forms of Tourmaline. Unique among the Agate family, especially when deep and clear, it is electro-magnetic in properties and if in tune and harmonious with the radiant energies of the individual wearing it becomes a functioning gemstone as powerful and as energizing as those most wanted by man for their supposed powers. **Carnelian** can deepen the powers of concentration and harbors the mental ability, if one is drawn in its direction, of recycling past life experience and serves to remind one as to the state of the soul and what its present tasks and lessons are.

It is not accepted as a valuable or expensive gem, casually being considered semi-precious in the now, and so it shall remain for a time. However discerning individuals will bring forth the truth of this matter within the next century and then there will be a feverish interest reawakened regarding this valuable aid. It was every bit as effective during the days of Solomon when it was worn on the breast plate of the high priest as it is in the modern world except that today many more super-stars of the gem world have taken center stage leaving this glowing and powerful beauty too long neglected. Aside from the Amythest and Rock Crystal varieties of quartz, Carnelian is in fact one of the most valuable quartz aids.

As a major gem of the fourth ray energy manifestation, it also works with the first, second and seventh rays simultaneously. It was sought after and utilized by those professing understanding of the laws of nature back in the transitory stages of Earth known as the dark ages, when the world was in a state of incubation. The few who maintained the light during this period were highly aware of the value and benefits of Carnelian and took full advantage of its properties in white magic and ceremony.

It is an ancient and well used tonic and works especially well when projected into the liver, gall bladder and pancreas stimulating the flow of enzymes during digestion and in general keeping ones filtering system fit. Its ability to energize the bloodstream and pull positive magnetism from an individual was well known in bibical times. This gem indeed does good things to ones body just by wearing it as it feeds energy molecules directly through the skin just as one can breathe in prana by inhaling air. If ones elemental nature is attuned to Carnelian a feeling of well being and inflowing power can be experienced.

This is one of the few gems that harmonizes effectively with the elements of fire and earth today. Amber is another one, and can be well utilized by the watery elements also. It is essentially in tune with **Mars-Pluto** but before the present age, was known to align only with Mars. Actually all elements can profit by its use but especially those who are harmoniously drawn into its orbit.

#### SARD

Sard is the lesser sister and brother of Carnelian but coarser, more porous and not as well evolved or generally useful. It is considered the "poor mans" Carnelian as it works on the same basic principle but stepped down considerably and merely begins to initiate the same work. This can serve well if more strength cannot be tolerated by the individual.

#### CHRYSOPRASE

This superlative gemstone will go on for many Earth centuries developing into another level of **translucency**. When large quantities are discovered to have a quality of even color and constitution it will replace green Jade as far as objects and carvings of beauty are concerned.

Chrysoprase, like the Emerald, is on a high level of development at present and is in fact an excellent balancer of the physical, mental and emotional bodies on the physical plane of existance. It can have a sedative effect acting as somewhat of a tranquilizer to one who wears it or has objects made of it. Those with neurotic patterns of behavior, superiority or inferiority complexes, mild hysteria and other **self-enclosed** modes of being all can respond to this stones serene emenations, for it is a valuable tool for use with these disturbances. The light frequency that it emits is especially conducive to being absorbed by the optic nerve which in turn leads to the mid-brain where it relaxes and enervates the pituitary, **hypothalmus**, thalmus and other emotional factor glands controlling this fine balance within mans physical vehicles. This influence when absorbed physically through the etheric level will affect the astral and mental levels of the auric field creating a more purposeful and complete circle of balance.

The mineral composition of which this gem is derived and has its essence has an able affinity towards homeopathic preparations if the actual gem itself is not available or cannot be used. The therapeutics of mental asylums and hospitals for schizophrenics and paranoics would be aided with the use of varying potencies of these preparations which would do far more than much of the artificial medication that constitutes so much irritation.

The frequency of the lighter shades of this gem are not as powerful as the darker greens but still emit the same steady serene flow of light. Chrysoprase has a particular affinity towards the water and earth elements but is also compatible with the air and fire though less so. The planetary allegiance is towards Venus also blending well with Neptune. At a much later date when completely metamorphsed into its structural capacity, its influence will change and fall under the **rulership** of Uranus.

#### MOSS AGATE

This category of Agate is as beautiful as it is reduced in vibratory efficiency because this particular form is following the downward path of the evolving trend within the mineral kingdom and therefore cannot be considered as a major or an on-going gemstone. At present it is a gemstone attunement for those who till or work the land agriculturaly in particular for it picks up the vibration of the land and helps the individual who wears it to fertilize his concept of agricultural growth.

It is not a physical healer as such but does have its roots in the Earth and is a part of Earth having a **low** basso **profundo** frequency which is not at all hampering to any who possess one. It is utilized and effective by those whose physical vehicles correspond to it or are in tune with it at any given moment. It merely remains neutral if looked at by deficent parties.

This applies to all colorations of this form of Agate which are presently at the peak of their beauty and just beginning their 500 to 1000 year period of decline eventually to be phased out of existence. Another alterations of the quartz family, Dendritic Quartz, (see next gem heading) will change even more to finally become more effective and far more spectacular than this whole group is at present.

#### DENDRITIC QUARTZ

This is the alteration spoken of above within which the forms, scenes, etc., will become even more defined and authorative. This gem will eventually replace the Moss Agates in all aspects such as symbol, frequency, etc is concerned and as a replacement will have the inate capacity to include as aficionados all elements that individuals have in their unique **patternings** on Earth and thereby reach a wider segment of mankind too.

#### **BRAZIL AGATE**

This area is and will continue to be one of the strongest producers of

well developed varieties of gem Agate because the conditions of **atmos**pheric pressure, density, etc. are just right for their evolvement. Both the south and north american continents are major contributors of fine Agate and infinite varieties of each are in common usage daily.

## JASPERS — IN PARTICULAR

This category of the quartz family is in the process of evolvement and only certain varieties are indicative of the future of this grouping. Although this family will never be crystalline in effect or nature, it will develop into translucent varieties as well as having chatoyancy and other optical effects that will be startlingly exquisite.

In the present stage of this grouping certain mineral combinations are solidifying and separating into various categories with just a few reaching beyond the physical level of assistance to mankind. After a time period of approximately 500 years there will be more varieties that will work into the higher mental and astral levels of mans vehicles and work from there.

The fact that this group of stones is at a very porous stage in its general development is not to be criticized for its very porosity is useful presently and will remain so to some extent. This aids in its quality of **absortion** allowing the vibratory frequency to pass through it and into the vehicle being used with little or no interference. The muddy colors of several combinations will eventually disappear as they evolve into various clearer shadings that are just now beginning to be seen.

#### BLOODSTONE

This variety of jasper is not only useful but powerful in its own right as a physical healer and a mental balancer. This could be said to be the finest of the presently evolving jaspers but it too will proceed further and become even more beautiful to look at because the dross is still being filtered out of it.

Bloodstone was well known in ancient times dating back to Atlantis where it first came into use. Though quite effective in the now it will continue to grow even more useful as it evolves into more of a major gemstone.

Having definite properties of a physical healing nature, it works universally regarding persons of all four elements to balance out deficiencies of the mineral iron in the bloodstream. Due to its transmittable qualities because of its reverse force-field setup, shared by other gems as well such as Carnelian, Topaz and Tourmaline, it can emit directly into ones physical vehicle.

Bloodstone is not confined to the elimination of this particular deficiency as it gives to those drawn towards it, and in need of its attributes, a peace that reaches into the mental and emotional realms also. The mental stimulant comes from the ability of this gem to vitalize brain tissue and keep the oxygen circulating because the iron content is being poured into the etheric body or web, enabling absorbtion to take place quickly and effectively. Therefore it gives rise to another good quality of aiding the attunement of the physical vehicle to concentrate and meditate properly.

One cannot with impunity assign planetary rulership to this gem as it belongs to the domain of the Earth as do all jaspers. There are outside planetary influences which from time to time bear support and give it an extra attribute by which it can be utilized. For instance a beginning **Pluto**nian effect due to its deepness of green picks up the regenerative aspect of this planets energy. This effect will increase and alter the gem for future usage in other millenia unforseeable currently by man.

#### **RED JASPER**

The plain red colored jaspers are an excellent panacea for those who can absorb its frequencies especially towards clogged livers and bile ducts. For those who like and are happy with the red color vibration it adds a certain energy stimulus that enters through the solar plexus and sacral force centers. On the whole this is a tool with limitations working only on the densest levels as it is a lesser developed gem than jaspers such as Bloodstone, for example.

#### **GREEN JASPER**

This stone carries a good balance for those who are drawn to it by the very quietness of its frequency. Like the red, it has not cleared sufficiently to really be of the service that it will extend at a later date. It will always be known for the Earth feeling that it carries with it.

#### YELLOW JASPER

Though still evolving also, this color contains sulphuric oxide which on the etheric and physical levels creates a forcefield that works as a disinfectant. This particular stone is to be considered effective on the physical vehicle only and when used in conjunction with other gems or therapy of a physical nature it can give aid towards disenfecting the bowel, colon and the intestinal tract.

#### **BROWN JASPER**

Again the question revolves here over coloration specifically rather than named types of Jasper as the Earth frequency will encompass all of the varieties. The brown and cream essence is the Earth-Saturn ray of energy that will open the gates of mind understanding or reflections that man will bring forth in the effort to de-crystallize conceptual illusions.

#### **POPPY JASPER**

This form of jasper is one of a different mettle as it is a developing and evolving entity on its own much as the Bloodstone already is. Made up of various combinations of the solid colors it becomes a powerhouse which sometimes appears strange as the individual colors have a much lesser effect when used alone.

In its ongoing it will alter its structure becoming more translucent and continue to grow more potent. At its present stage it is best utilized on a physical level through the etheric body or web. It is able to aid vital energies in a positively polarized manner in mans energy centers whenever needed just by its wearing, or in the projection to the area in question.

Predominate red color patterns give a Martian influence and suit-

ability to the fire element but it still will bear the stamp of Earth. At a much later date the planet Vulcan will enter into its ongoing development.

#### **PICTURE JASPER**

This entire sequential area of gemstone is tied up and linked with the unique developmental pattern- that the forcefield of Earth gems are building for themselves. Those who say that the Earth planet is basically an **unspiritual** sphere will be put directly in their place, so to speak, as this is a contribution that this sphere has to make in this system. It will be seeded so that it can be carried off to others as the symbolic and cosmic artistic palette which Mother Earth has at her disposal.

This is no mean feat of accomplishment and is indeed a wonderful thing to behold as this is, and will be, THE earth gem of unique quality and worth that someday will rank with the precious type of crystal gem currently sought after by mankind. Its variety of symbol and scene will be endless and grow ever greater in abundance thereby dwindling the demand for it at first. At a later date the clarity, delicacy and cosmic understanding of the symbols and landscapes will reach a recognitive factor in the human mind. Then the demand will far exceed the supply.

#### RHODOCHROSITE

This will become an important major gemstone not only to be worn by individuals but also to be used in healing and other allied aspects by those with the necessary understanding and knowledge. Basically this gem is another almost universally beneficient combination which will increase its already existing property of conducting energy and light without the aid of metals as a "direct flow" between the gem and the wearer or healer.

Rhodochrosite will not have the ability to transmute but will be able to hold and direct its energy. It can immediately magnetize and hold any force field whether it be of another person, or persons, or a particular area, or space in the landscape. Its great value lies in the ability to work in the physical trinity or lower triad wherein man operates during his sojourn on this planet. Working in detachment on the etheric and mental realms it integrates this physical, mental, emotional triad for those drawn into its orbit.

The use of precious metals such as gold amplifies the force field even more and especially with the use of "pink" gold or that karat gold that has a higher content of copper within it. This holds true in many ways for other red gems such as Ruby, Amythest, etc. which though serving entirely different purposes are augmented with the use of higher copper content, or "pinker" golds.

The planetary **rulership** of this gem at this point in time is in Jupiter which reflects the expanding power of its mineral composition to hold force fields of indeterminate length, breath and width in a positive non-destructive manner. However within the coming cycle of this gems importance, Pluto will come into the spotlight to firmly wedge its energies in there along with it. Rhodochrosite affiliates well with the fire and air elements in particular but is not limited there depending on individual patterns.

The swirls, circle, lines, etc. which emenate from this gem symbolize, as they do in all materials, the hidden understanding behind the "seen" and have a special effect on individuals. In the future evolvement of this stone there will come an even greater significance for "ceremonial eyes", circles, etc. as they are used at that time. It will take on a startling palette of pinks and salmons that will be truly marvelous. The opaqueness will solidify harder and denser but will not turn translucent as much as sparkle with a luminous color and some will show a strong play of chatoyancy.

This will be one of several key gems that the devic kingdom can assist humanity to work with as it is they who hold the key to what can be done with force fields and the activation of them. At a future time this aspect can be expanded and clarified for even greater utilization and understanding.

#### RHODONITE

This is a gemstone that is on its way to being eliminated as an important contributor to the field, for although it is harder than **Rhodochro**site it is not as beneficial or as beneficent. During the time of the civilizations of Atlantis this stone served a similar purpose for which the Rhodochrosite is presently intended. However misuse of the beneficent force fields at that time made this gem improper for additional development and usage at this time. Though commonly utilized today it is in a state of "stasis" and can be likened unto a "sleeping beauty".

#### **RUBY**

Ruby is of the corundum family of minerals, but the aluminum oxide fixing the color with its infinite variations from light and shimmering pink to blood red of the darkest shade is an important factor to content with. This makes a great variation in planetary rulership, affinities of zodiacal signs, etc, not only within its own spectrum but of the tremendous differences that exist in other precious stones in this grouping. For instance, Sapphire does not touch upon the same levels or serve similar purposes as the Ruby yet the mineral basically is identical.

To tabulate planetary rulerships by color, note that there are two rulership categories for the pink and two for the red shades. The deepest Siamese or oriental pinks come under the sponsership of Venus while the lightest and brightest are attuned to the rays of Jupiter. The deepest blood red is completely held by the regenerative energies of the outer planet Pluto, while the clear and scintillating vibrant tones of red belong to a well defined and constructive Mars.

It should be repeated here that when planetary or zodiacal affinities are spoken of, one needs to re-define these analogies for otherwise it would limit the worth and the application of any significant, precious gem variety. These planets and signs are part of the universal energy patterning setup of this cosmos and because these minerals are living pressurized elements themselves they partake just as every other kingdom in being affected by these frequencies. This makes it simpler to relate to human mental understanding but it remains important not to attempt to deify or to restrict or constrict any gemstone just because astrological analogies have been given which still are only a part of the greater whole.

The Ruby as a general classification is equated with the bloodstream, the circulation, the heart and also of devotion commencing the transfiguration of divine love into divine will. Note that the description being used is transfiguration and not just transmutation and for this there is a reason. As the devotional aspects of spirituality are goaded and channeled into impersonal service to the one unity in existance, this merges into the Father or the first ray upon the step of emotional conversion (transfiguration). Therefore the symbol of the Ruby as the heart of spiritual love and devotion is a true fact.

The Ruby belongs more to the fire elements than any other signs but when other signs require its use to obtain certain results it will always blend well. The fire inherent in the Ruby of brilliant repute is deep and ever glowing and quite literally warms the heart and intensifies the energies coursing through the circulatory system of those disposed to its charms. In the sign of Aries it helps determine the development from the ideal of service to unselfish devotion terminating in selfless sacrifice to the divine will resulting in the uniting of the heart of Aries with its head or will.

In the sign of Leo, it directly attacks the heart center leading to the will by way of compassion and personal love turning into impersonal love embracing all of humanity. This is culminated in placing the Leonian also on the alter of divine sacrifice to the creator by the process of unification described for Aries initiation.

The fire sign of Sagittarius finds the Ruby magnified and expanded by Jupiter into a broad spectrum of practical and energetic service given for the love of truth and wisdom, (the Holy Grail). As when the seeker of truth finds the Holy Grail he too is transformed and by Jupiters beneficience is transmuted into the heart of divine wisdom.

Now because these fire signs have a built in barometer of like elements does not mean that other human beings with widely diverse energy patterning will not need nor want to use this gemstone, as was stated earlier. However the intensity of its mineral nature will tend to reflect an enormously wide range of emotional and developmental situations that can occur within the spectrum of the desire nature in man. The material given concerning the three fire sign elements is the idealistic example of what the gemstone called the Ruby can accomplish along the lines of its own evolutionary path. This is not a limitation and the Ruby can and does go visiting to wherever these idealistic concepts must be transposed onto any patterning that is equipped to handle it for the Ruby most certainly is meant to deal and cope with the transfiguration of humanity in general. If we continue our astrological analogies even further, there is no one that does not have some of every zodiacal and planetary energy within them at any given cycle of incarnation.

Consequently to try and box in any gem because it has definite propensities towards certain known energies is a grave error. It behooves mankind to think more in terms of concepts than in separate little compartments or comparisons that these gems have in their essential order.

The opaque or semi-opaque varieties do not have the potency of the transparent crystals but serve well as a stepped down function in the astral realm. Here it acts as an emotional stimulant to a minor degree and also aids in cleaning current emotional impurities out of the bloodstream and maintain proper perspective along these lines.

The lightest and brightest shades available to the user would affect the higher bodies immediately so that in this instance energy would circulate freely not allowing any congestion and blockage to build up within the astral vehicle. The etheric body or web surrounding the aura of an individual bathed in Ruby light would quicken and come more alive and vitalized with globules of salient energy pulsing and shooting through **this** part of man.

The darkest, yet still extremely beautiful Ruby contacts the physical heart and generative system relating to the pituitary gland and the central point in the mid-brain. A most powerful ally and an equally powerful foe, if misused.

The responsibility of one who would wear a good sized quality Ruby or of a healing practitioner who would project its qualities is great, as this is one of the very few gems that (like the Diamond) can and does create a dangerously negative force field of activity around the individual whose motivation is less than philanthropic. The Ruby energies when misused can cause a rent in ones auric field opening up the possibilities of many undesireable manifestations. This rent becomes possible through the affinity and alliance with the eternal fire that resides, vibrates and projects from the Ruby of potent hue. The element fire is the purifier in the universe, hence it can open, destroy and part the ethers on whatever plane it is used on, reacting to the pressures in the magnetic field of man. The purification purpose behind the Ruby makes it possible for this dross that is being burned away to become turned onto anyone whose negative impulses get away from them and becomes self-centered and power oriented. So like the proverbial scorpion, they can sting themselves to death by the Ruby lights which can burn a hole in their etheric web.

Inordinate greed, for one example, has caused this gem to indirectly contribute to crimes of passion and jealousy, all factors unsuspected by mankind regarding the "innocuous" Ruby. The negativity which this one gem can cause to manifest is like no other gem on Earth. Its action directly corresponds to the destroyer or Shiva aspect of divinity, again linked to the element fire and the forces of purification.

The Ruby is linked up with the **Karmic** Lord Saturn, as are all major gems of importance, for the gates of consciousness expansion are under the direct supervision of the highest tribunal of the Saturnian Council. However the focus of the Ruby is through the amplification of the expression of love (heart) from the personal into the impersonal via the development of the will or first aspect of the known divinity of this world completing the circle of service and keeping it whole but raised another notch on the spiral of the Earths plan of evolvement. Sun-Saturn energy is the mainstay here.

#### RUTILE

This mineral will eventually be used to magnetize and bring down to the Earth plane energies and forcefields necessary to equalize imbalances in individuals needing this particular therapy. It will not particularly be a gemstone per se, but will be used extensively as an electrical tool for healing and balancing on the etheric levels. Black tournaline crystals will operate in the same fashion and can be interchanged.

#### SAPPHIRE

Here we have a gem of almost unknown quantity as in reality much that has been spoken about it has been in the realm of conjecture and fantasy. As a member of the corundum family this gem too belongs to the kingdom of Saturn, the divine law giver and dispenser of hard won wisdom and so must be considered anchored to the forces and energies of the second ray aspect of the logos.

In fact, the entire corundum grouping manifests **Saturnian** energies and attributes along different lines of purpose due to the **multi-dimens**tional role that these particular kinds of energies play on the musical instrument called Earth. This in fact is the dominant theme of a symphony which is coming to a climactic finale in the current age of mans growth, the turning point of transition that makes man aware that he is on the threshold of his own divinity.

As the Ruby deals with Sun-Saturn **energy**, so the Sapphire deals with Saturn-Mercury energies which **enables** those aware or unaware, to raise the consciousness another notch by using its energies to this end. According to the spectrum which includes the indigo ray, here consists the ultimate attainment of will-wisdom activity with which this gem can correlate to the degree of the individuals capacity to grow.

The color of the deepest Sapphire, which is indigo, has up till now remained hidden in **the background** of other more spectacular and brilliant looking gems of different lineage. Its vibratory rate is almost **imcomparable** as to the amount of inner plane blessings it can bestow on the mind levels. The indigo ray has the power to sweep all confusion and unnecessary structural illusions away from the intellect and reason to bring instead to the inquiring soul, the light of pure insight and the benevolent intuition of instant knowing. Therefore the penetrating quality of **Saturns** indigo ray illumines and enhances all activities of the wisdom manifestation.

To clarify this mysterious indigo ray energy, one can see it as the link to the cosmic mind, the heavenly bridge builder to the layers of consciousness which show mankind the way to the intuitive and thusly the direct clairvoyant perceptions necessary for receiving truth and differentiating it from astral trivia that is often hailed as a gift of God. The perfect gift of the Gods is mans ability to bridge the gap between the planes of matter and illusion that is enthralling as well as it is confusing and misleading. In the indigo coloration of corundum lies a task force of creative mind energy that can lift the atoms and molecules of mental matter assisting those who prefer the light of knowledge to the glamour of lower psychic phenomena.

Rather than working like the violet ray of transmutation, the indigo ray works on transfiguring the different aspects of mind bridging the gaps between the forms of concrete thought and abstract concept. The energies of the Sapphire work through the higher particles of matter in mans atmosphere and filter down only into the lower mental realms but do not get involved with the astral layers of matter at all as does its sister gem, the Ruby.

The Star Sapphire group, caused by inclusions of another mineral, are stepped down transformers more subtle in operation for those who prefer it. They work well on the mental body aiding the building of thought forms and bringing about capacities for manifestation on the physical level. However the black Star Sapphires are strictly an Earth vibration which relate to a negative Saturnian vibration. These can easily constrict thought or crystallize certain thought patterns rather than elaborate upon them. As the wasp is a mutant bee so the black star is a mutant Sapphire whose sting can be depressive behavior due to the retention of a negative magnetic field. This type of energy can be utilized by elementals in a persons auric field to indirectly influence them destructively.

Rather than be concerned with that information take note of the availability and common usage of these black stars which do serve and indeed serve well. For with all the talk of evil, the only evil that exists is from the ignorance of mans own nature. Therefore these negative energies are a tremendous boost to the growth process of mankind as it makes it possible to overcome and rise above the resistance and obstacles that these forms of energy superimpose on mans environment. As there are two sides to every influence, obviously both sides are doing a necessary and vital job in humanitys progress towards himself.

The clear or colorless member of the Sapphire group is a gem that serves as a transitional stone to those who are drawn into its orbit, for although it retains the essence of the **corundums** energies it is watered down so it cannot present a strong statement. It is, however, considered a quite efficient and perfected "mind filter".

The light blues or cornflower blue members of this grouping have their own type of "magic" as they cannot be considered to be merely watered down versions of the indigo shades. These lively and bright blues have their own song to sing. The mental particles of matter are very much lifted and raised to a peak of serene optimism as this is a "mood gem" extraordinaire and an extremely valuable assistance to meditation if this shade turns one on.

The yellow Sapphire can be utilized by the lower mental stratosphere of mans aura for the cleansing of impurities as it is still sustaining a mercury energy but of a grosser sort and as such can be contacted by man at that level of his being.

Parti or multi-colored Sapphires are another form of mutation that together do not operate as efficiently as if they were separate.

Zodiacal affinites are rather like the Diamond, belonging to all rather than a particular sign but it diffuses itself in a smooth and flowing energy stream directly through the signs of Libra, Virgo, Capricorn and Gemini respectively.

#### SMITHSONITE

This up and coming "youngster" will develop into one of the Earths most exquisite marvels that will be almost as breathtaking as the Star Opal. It will evolve into a composition and refractive index similar to that of the present day Diamond and have a power and responsibility equally as great.

Looking today at a perfect blue, rose or pink colored Diamond will give a hint of its future use and beauty. It will also develop a strain of violet. This gem will not be called Smithsonite in the distant time ahead as these evolving gems shall be considered to be brand new discoveries so shall be given new names and cataloged accordingly.

The reason that these children of the gem world are less utilized in their infant healing capacities is due to the legions of more powerful developed gems currently involved in healing and readily available to those drawn to this field. Later on this will be a key gem for the replacement of the function that Aquamarine currently offers to humanity with the added bonus of its own special qualities. Like the blue and green Beryls, this gem is a mutant from the planet Venus and takes its vitality from the Sun. Eventually it will belong to the first ray of life and also be active on the seventh ray as the form and symbolic significance of these presently operating rays will emerge into new and more effective dimensions of activity.

#### SODALITE

This evolving mineral will not reach its zenith or point of fruition in this time sequence. Being still too dense in construction it cannot be considered as a meditative, reflective or spiritualized gem. Though it is utilized to some extent as a decorative stone in jewelry, in carved objects and so forth, its only real present purpose is within the physical plane as a conductor for repairs of certain organs and glands.

If one is drawn to this stone it is mostly because of physical deficiencies within their body and Sodalite can help achieve a better balance within the glands emphasizing metabolism. It aids in the balance of the Islets of **Langerhans** which control the manufacture of insulin. Sodalites powers can be amplified when utilized in conjunction with another more powerful gem of parallel wavelength.

Ultimately this stone will become similar to the very finest Lapis Lazuli and in fact parallel it but not for some time even though it works similar to Lapis now but on a denser scale of function.

#### SPHENE

Within the next round of time this material will develop into something different and unknown to present concepts. It will have a dual participation within its own evolution both as a gem with a shade of brown brilliance and also entwined with an essential metal mineral group where it will be used together.

This combination will continue to develop on the Jupiter round and be utilized by a race that will not need physical bodies. Its high point of development will never be seen by earthly physical eyes for it will evolve into an altogether different grade of matter.

#### SPINELS AND ZIRCONS

Though widely used in jewelry with undefined types of gemstones, these two beauties are still in an ongoing, evolving or "unfinished" state. Therefore they do not have a proper contribution or impact to make in the frame of reference being currently discussed here.

#### TEKTITES

Similar to Meteorites in that they are not of the Earth, this material which is ejected from the heavens is pure and simple cosmic debris which is of no value other than psychological to the researcher.

#### TOPAZ

The Topaz has several distinctive qualifications placing it in a separate category of function. It gives emphasis in many areas, depending on what is required, for the electrical currents that flow through this gemstone, regardless of color, are aligned with the second, third, and fourth rays of life. The creative energy flow that is often the inspiration of the artist, writer, scientist and even the political statement is intensified by the wearing or the projection of the Topaz into the mental circuitry here for it charges electro-magnetically the three bodies or basic triad at every level, making it easier to grasp abstractions and trend innovating projects that put **impetous** to the culture of the modern day world.

This gem operates as a "magnetizer" in a similar manner to Amber, when working on polarizing force fields, and shares **rulership** with Saturn, Mercury and Uranus. Here again the diversity of this little known but much prized gem leaves much information in the fables of conjecture.

Topaz works on the mental and physical vehicles of man as well as having an important effect on the other kingdoms in nature. This gem crystal works in the vast network of devic builders but not of the human archetype form. Instead it works with building the fascinating and beautiful forms that nature displays in the plant and vegetable kingdom such as **flowers**, trees, etc. Even while still underground and as they develop, these crystals are working members of the team to build and to progress the kingdoms of nature to which every living physical manifestation belongs. This is a most interesting stone from the view of being in such harmony with the natural forces of the universal essence, in that is seeks to magnetize and polarize everything that it has its "crystal in".

Topaz can be considered to be an electrical coagulant. The heavy electrical charges set off by this crystal warrant some explanation here as this jewel, like the Tourmaline and the Amber, is magnetic and electrical. Due to these propeties they create voltage throughout the bodies of man consciously aware or not. The charges from the Topaz stimulate rather than sedate one and it is of excellent benefits in cases of nervous exhaustion and prostration or when recuperating from the effects of a trauma, or even a nervous breakdown as it is popularly called.

The Spinal column and especially the spinal fluids within are affected the most by the use and projection of this crystal. It also tends to integrate the solar plexus force center due to the balancing affect on fears and shocks that the nervous system can sustain and at the same time is a valuable aid to vivifying the spleenic and sacral centers reducing possible congestions. The triangle of the solar plexus, spleen and pancreatic areas is one of the main battlefields in today's confused man. This is due to the inharmony and conflict arising out of the desire bodies, the purpose they serve versus what the personality thinks it needs, and so forth. Topaz can also deflect emotional spasms in the astral body if consciously used with purpose by the sensitive or healer.

All of the existing Topaz colors function similarly except for minor variations. Only the clear Topaz bears a keynote of isolation. This crystal can be utilized in similar manner to clear Quartz crystals but on an even higher spiral, for it is stepped up in electrical current capacity and is an especially effective transmitter-receiver for this planetary sphere. The clarity of individual crystals reflect its capacity to electrify for each flaw makes transmission a little retarded in effect. The clearest and best specimen should be used for healing effectivenes.

Its energy flow is much like that of Mercury in that it is neutral until it comes into contact with a specific combination of forces and then takes character from those forces and electrifies same. This gem is a neutral principle or energizer unique in quality and aspect in that it is tolerated by most all and that is why it is such a versatile and relatively harmless yet potent source of electro-magnetic energy for so many specific purposes, and why it is one of the gems bearing top responsibility to the evolution of this planetary world.

#### **TOURMALINE** (in general)

Of all the crystals mentioned as having properties of great benefit to the human mind and body, here is one such crystal that might be considered to be almost unsurpassed in what it offers to those who are attracted by it. This gem is growing and evolving but is already a major contributor to this planets magnetic field. There are many gems that offer their energies and other factors to enervate and balance polarity but none that surpass the Tourmaline for this job on most all levels. It is a most versatile gem and is to be noted that no harm can arise from its use or its projection for this crystal family does not absorb or hold negativity. Its emenating frequencies that have already manifested are well in advance of the fifth root race of mankind now playing in the theatre of Earth.

#### WATERMELON TOURMALINE

Of the many individual colors discussed here the most fascinating, exciting and if one would like to use the word, "romantic" variety of Tourmaline can be epitomized by this bi-colored crystal so named for the cross section slices having a green "rind" and a pink core. Stones in this category perform a threefold function.

They act upon the metabolism and the endocrine function of mankind keeping these areas of energy on an even keel and balance according to the individual needs adjusting itself automatically to the need.

They act upon the wearer as a polarity balance for the energies flowing keeping them in their "proper grooves" and helping redirect energies that may be in the process of getting congested or obstructed. Because the transition of this earth planet is intimately involved with the polarity and sexual balances of mankind, there are large problems stemming from the introduction of New Age ethics in the matter of elimination of misunderstanding, intolerance and bigotry still rampant over the roles of the male and female and the ignorance concerning the functions of each polarity. Imbalances and guilt are the seeming common denominater. The forcefield that this gem surrounds man with is indispensable to many so called aberations of male-female function for it helps ease the transiting frequencies.

They act as instruments for sensitives when used for healing projections working directly with the devic builders of form on the inner planes. This presents a picture of an element that is able to work with the unification or matter before it becomes matter. The Watermelon variety has the ability to aid in altering cellular structure not only in the normalized, fully mature individual but also in that of the just forming embryonic essence.

This variety serves the fourth ray energies of the cosmos as well as the third and the fifth. But its importance lies in its ability to balance the conflicting forces flowing through mankind and the planet itself and har**monize** them by its superior ability and capacity to adjust these flows. The fourth ray energies have their basic function through conflicts that eventually result in harmony within all of mans bodies. This works through all of the creative art forms currently in **existance**. The third and fifth ray energy patterns respectively link up the mind and its development through the sciences to change rigid concepts for further expansion.

The Watermelon variety is a complete entity in itself and symbolizes the pairs of **opposites**, the yin and the yang or whatever one can call these esential and immutable principles by which we are bound in the physical universe. Therefore this also can be considered a form of cancer preventative in that the continuous balancing **emenations** can stave off irregular cell growth, or carcinomas, of most any description. Note that this is not to be considered a cure, for it is not that at all. But it can be utilized as a hedge or preventative by all especially if family genetic patterns indicate tendancies along these various lines of occurance. This particular preventative role is brought about by the raising of vitality in the individuals ductless gland balance.

Indeed all Watermelon Tourmalines are possessors of the quality of the "Ring Pass Not" which affords a protection to its wearers. This is in direct relation to the degree of strength and clarity with which the pattern circulates around the gem.

#### BLUE AND RED TOURMALINE

This **bi-color** combination serves basically the same function as the green and red watermelon type, the deciding or critical factor here being the preference of the wearer. The spectrum deviates according to a persons affinity with the auric spectrum that may be lacking in their bodies. Again this would be an automatic adjusting mechanism which is a property of the gem.

#### GREEN AND COLORLESS TOURMALINE

Here we have a bi-color variety that does not operate in quite the same manner for although the crystalline composition is the same, the coloration of this gem creates another kind of entity. This then comes under the jurisdiction of balancing to the brain and the nerve fluids, harmonizing through flashes of stimulation which act as a calming sedation. Again, for the healer who wishes to project from this gems center, one has the potential of reducing inflamations, headaches and can even reduce the potential severity of epileptic seizures.

#### **RUBELLITE TOURMALINE**

This solid color variety containing the deep red, pink hues and rarely even purple is one of the major contributors of this spectrum towards mankinds benefit. It can be thought of as the queens diadem of the Tourmaline family for it belongs in a category by itself. Working in the sixth ray of life and also the fourth ray, it is a powerful influence to whomever is drawn into its special feeling. The validity of relationship between the sixth ray energies and the Rubellite needs explanation for these energies are of an emotional nature that lead from the heart of man, strengthening resolve and the will to love and to sacrifice. **Rubellite** acts as a balancing agent for this center in man as well as increasing depth of insight and perception stemming **from** this aspect of mans development. The devotional urges and impulses become better directed and intensified with the use of this gems steady charges.

Here we have a major keynote for balancing the heart center, as with the Ruby, but on a less dramatic, more subtle level of function as its activity tends to bring will-wisdom into play and erases some of the terrible conflicts that lead men to even take their own lives out of personal despair and fear of failure. This is the warmest hue and the least demanding but with the fastest results for again it is an automatic adjustment mechanism.

The pink Tourmaline is especially compatible to those persons aspiring towards the pathway of the devotional yogas for it is attuned to paralleling the effects of the Neptunian ray or the higher octave of the law of personal sacrifice and detachment.

#### **GREEN TOURMALINE**

The green variety, **showing** a great many shades, is a gem that is quietly unassuming in some aspects but dynamic in others. Utilizing this gem brings first ray energies to mans bodies. Each of the twelve signs of the zodiac has a particular aspect or shade that can be utilized to balance the earthly personality and help clear certain blockages from the physical vehicle. This is linked to the Venusian energy ray running along side the earthly forces anchoring the soul to its task during its temporary visitation on this plane.

The green shadings reach implications of will-wisdom that balance out the nerve fluids in order that each emenation of man from the twelve distinct divisions for energy passage receives the bounty of magnetism that is the Green Tournalines to offer. The mind is quieted via the nervous system so that it can create new grooves of direction to run in and expand the developing will. This flows into recognition of the right use of directed will and eases the conflicts brought about by the gaining of these attributes.

As green is natures coloration of balance, so too it should be applied to man as he too is a part of nature and is susceptible to its effects the same as a flower or a butterfly. The chrome green shades offer the highest therapeutic value but this balance comes in a multitudinous array of shades and subtleties of shades to suit the most discriminating individual and each person is automatically led to the right shade for them. Therefore it will, according to the degree of intensity, do the work that is intended for this gem.

This Pluto oriented gem, acting as an instrument of regeneration, realigns the mental bodies of mankind shattering and leaving no foundation to build from thereby making man start anew. This is a delicate, touchy and subtle process yet very effective and potent in its own right. Its ability to help clear the cobwebs of confusion from mans mind allows it to be considered as the surgeons scalpel to the brow and crown chakra in the same way that Rubellite is to the heart.

#### **INDICOLITE TOURMALINE**

That variety which is blue or indigo is linked to the ray of Saturn and to the higher octave or expression of Venus. An unlikely combination, seemingly, yet when the two rays are overcome on the lower levels you begin to see manifested the Christ consciousness relative to the energy pattern in this mineral. This then is the mystic marriage of Venus-Saturn.

The Venusian energies combine the mind and the heart into a deeper blend capable of acting as a pivotal point for the three bodies of man yet going up as many octaves as mans trinities permit. For this gem carries with it the Divine Mother principle in cosmic ideation and is a representative of it. Dispassion and impersonal love **emenations** which no longer confine or inhibit mans expression of the "Divine" are personified by this gems very **existance**.

Therefore the marriage between Saturn-law and Venus-love is given **impetous** and smooth function without blockages common to this combine of adverse conflicts which truly portrays the accomplishment of higher or Christ consciousness. On the other side, the misapplication of these twofold energies can create the extreme of self-enclosed isolationism that creates fanatics and other garden varieties of human pests.

The implication of this gem is of prime importance and interest to those whose auric fields need sustanence and support from a flow that produces unified activity. The frequencies that this gem emits are so fine and so high that although not everyone will be drawn to it, it does fulfill a most specific need in bringing this principle into more active manifestation. In this sense it is a purifier extraordinaire but without the scalpels edge that the green color is denoted as having. The energy source here is mostly the second ray aspect and applicable in some cases to the sixth ray also.

#### **BLACK TOURMALINE**

Because of the ability of the Tourmaline as an electrical transformer and **magnetizer**, a wholly different aspect is created in the issue of using and wearing a black gem. As far as looks go, sleek black is sleek black regardless of the excitement or lack of it that this non-color can elicit by way of a reaction. However the quality of this black gem is such that it handles negativity by deflection rather than by absorbtion as other black gems tend to do. Therefore more than any other black gem the black Tourmaline is to be considered the most beneficial and necessary especially for those whose job it **is** to work with negativity and also for those who feel they are more susceptible to negative energies and tend to be victimized by them.

This gem can be worn by all who are drawn to it and is like having a shield of sorts around you. However again a reminder that this gem cannot ever be considered a substitute to replace the building of mans own discrimination-awareness wherein all forms of negativity will be automatically handled without external aid.

Black Tourmaline when coupled with clear Quartz crystal, called **Tourmalinated** Quartz, is a powerful combination giving a combined wide range effect of deflecting and eliminating negativity from most any source This combination is significant in its portrayal and function in the physical world of the pairs of opposites that many are afraid of due to conditioning and lack of understanding. There are negative energies just as there are positive ones to be taken in hand and realized for what they are and the purpose they serve which is towards the evolution of this planet and indeed any others on which **cycles** of life are contained.

The ray force **emenating** from this black gem is of the first and the seventh respectively while the planetary energy is Plutonian. There is also some **Saturnian** influence but only through the **forcefield** of Pluto.

#### **CATSEYE TOURMALINE**

The **catseye** effect in Tournaline of any color or combination of colors creates resistance of energy molecules and covers up light waves. Caused by inclusions within the crystal, its operational affect becomes tenderized so that it becomes a more devious worker rather than an obviously persistant instrumentation. However the slower manner of this form of Tournaline is better accepted by some who are attracted by its quiet demeanor.

#### "OPALIZED" TOURMALINE

Gems with the opalization affect within them do the exact opposite of the catseye material in that it steps up the Tourmalines function considerably and holds electrical impulses to the same degree. In fact the Tourmaline becomes quite extra-ordinary for they attune to all seven of mans energy manifestations and become especially valuable in aiding the utilization of the frequencies carried by Neptunes cosmic output into this sphere. This also applies to the Suns globules of vitality which makes this gem effect an invaluable tool for the healer.

The added flashes of color which sometimes are spectacular within the gem can be utilized in the now in a similar fashion as when the day arrives that man will be able to work with the Star Opal and all of its ramifications. Spiritually, mentally, physically and emotionally finds no separation in this type gems capacity to re-organize and re-group at every level of rnans consciousness and being, for the energies given off interpenetrate matter in such a way as to re-assure one working with these gems of their extended ability to perform.

This effect within the gem is due to the extra fragments of color and light flight refraction from internal fractures) and also sometimes from fluids or additional mineral deposits present during the crystals formation. This unleashes an added force center to the gems potential by bringing into play the outer planetary energies in a stronger manner to blend with the energies already present within a particular gem. This affect can also be found in all other crystalline type gemstones which when present adds extra dimensions.

#### TURQUOISE

Turquoise has long been deified and held in favor by mystically oriented persons all around the Earth not only for its beautiful color, but also for the representation behind that color and the properties indigenous to it. The inner symbolism to the Atlanteans, the later American Indians and other groups of people was revealed upon the wearing and use of Turquoise that it held the atmosphere surrounding the Earth, the sky, and in worshipful reverence was a giver of life and breath. Turquoise and the symbolism of the sky still signifies mans origin as a creature of Spirit rather than the flesh.

This was amplified by its color of course but even the properties con-

tained therein were useful in remedies dealing with the lungs and respiratory system. Because of the intrinsic factor of copper it was then one of the best conductors of healing known to man.

Being a gem of universal conceptualization it still today is one that can be worn and utilized equally by all four Earth elements. As much as it represents the sky it also finds itself at home on the water, caught and held in the dry crevices of the Earth, as it were, and purified by holy fire. Fire is the only element that can fade or transmute it and some may experience dissatisfaction in wearing it, but the healing factor is the same regardless.

With Turquoise comes a Venus-Moon influence. This is especially so because before the earth chain became firmly established this mineral existed in large quantities on the moon chain and became transplanted here. A mineral similar in composition to Turquoise exists now on the physical planet Venus.

Though Turquoise is enjoying a revival of interest and with silver being heralded as the last word in fashion, it is in reality a dying fancy for it is a gem that is finishing up a long cycle of service to this planet and will eventually transmute itself into other areas of application. It is no longer as effective as it once was due to the ever higher spiral of mans ability to withstand energy impacts from without. Turquoise was originally geared to a specified need and frequency and at present cannot promote its original intentions. Up and coming gems that will be replacing a number of different gems functions will be geared to the newer frequency rates that are now being absorbed by man. Chrysocolla is the beauty that will take over the role of Turquoise, in a manner of speaking.

Today most persons do not require that much Turquoise around them but to the vestige of individuals who cling to their past soul memories, it still retains a modicum of effect. This is more in a nostalgic sense resulting from prior extensive use in other times, cultures and civilizations, as the developmental arc is drawing away from this mineral combination rather than towards it. The fact that so much Turquoise is currently available allows its use to continue on specific levels in specialized manners. Additional applications can be found in the section entitled "Gemstone Elixirs".

#### VARISCITE

This material serves purely on the physical level at this point in time to help balance out the visual purple in the optic nerve and to soothe the central nervous system for those who may be drawn to this subtle stone. It will finally develop into a harder material not worn as much as it shall be used extensively in building and architectual design much as marble is used today but will be far more lovely to look at.

## 1. Metals Used With Gems

Metals that are to be fused in any way with either a healing instrument or a piece of jewelry support and hold the frequency rather than alter it, as the idea of metal is as a conductor in the first place. The various combinations of metals will of course vary depending on the usage but in general, Silver takes a passive vibratory rate and augments in a more negative manner than Gold. Copper is also a negative conductor but has an entirely different frequency rate. However, Gold, Platinum and Plutonium are positively polarized and conduct accordingly.

When combinations of metals are used such as Gold, Silver and Copper, the proportions will vary according to the polarization balance needed for that particular situation and purpose. The widely used karat golds are already combinations of these three plus small traces of other metals. These will suffice most needs but intunement is paramount in healing instrumentation.

Essentially there is no difference between the use of melted and cast metal as compared to drawn wire and piaffe. It is the same common denominator, once the molten molecules have re-settled themselves, for they do not alter. They merely rearrange themselves causing no difference in the results of their usage.

#### GOLD

The precious metal Gold, as an earthly element, is an ancient mutation of a sort that traps the qualities of solar energy and vitality like "cosmic breathing". In the many milleniums that this planet has been evolving the suns vitality has been collecting within the appropriate nooks and crannies throughout the layers of earthly crust, storing up cosmic energy brimming with powerful forcefields of a positive nature that we can wear and use.

Gold is directly oriented to the first aspect of the Solar Logos and as such is an entity unto itself within the framework of manifested universes and comes under no authority other than its own. The responsibility of man towards Gold parallels that of the Diamond, for no other metal or gem has been fought over with so much destruction, misery and greed activated than that of this irreplaceable element of the mineral kingdom. The misuse and misapplication of the power structure belonging to the element Gold has still to be understood in the perspective of it as an element which cannot be subverted. Only does man subvert himself and his unredeemed nature with its use, as Gold will always remain Gold. Man places his desires and his transient needs for it above the, just being discovered, real benefits of the Sun-Gold.

As a source of vitality and illumination and as an example of the

alchemical divinity of the intelligent creation behind all universes it remains to be respected and used freely but with non-attachment. This is the ultimate spiritual lesson in Gold as it is with so many other major precious gemstones.

Gold, which is a magnetic conductor of the highest degree and with the most structural integrity, was given to the children of Earth to aid them in their growth, as were" all others, yet thus far most of its use has been confined to personal abuses. Because Gold is polarized positively, it can affect the head center and cause disturbances common to present mankind who is still overly involved with greed and other sense gratifications. That is why so much negativity has been attached to Gold from even beyond the present era.

Gold needs to be regarded as a purifier in that it connects with gem abilities to assist the dross in the minds of men to regenerate itself and allow the smooth operation of the evolutionary spiral. In the form as it stands Gold is really a minor miracle by itself. The very greed it incites and engenders in the hearts of those who seek it for power or other reasons is a form of practical therapy, in that is produces the venom which turns into the cure.

In truth, Gold is a universal element and on other galaxies and star systems a type of Gold is much revered and utilized. Many other systems utilized Gold in far greater quantities much as the ancient Peruvians and Aztecs did and without the greed motivations that desiccated human growth potential in various epochs of Earth history.

The purest worth of the essential solar metal, 24 karat with no additives, will of course conduct the easiest and with the least obstruction. However for practical purposes it must be strengthened by alloying with other metals to various karat formulas depending again on purpose and need. Basically the color of the Gold does not affect or reflect the purpose for which it was intended though it can be personal and significant to some individuals. White Gold combines the two major lights of cosmic energies, the sun and the moon, which can heighten the power to act as an integrated whole for the purpose of conducting certain subtle energies to the body or even to places.

With regard to planetary affinity, Gold relates particularly well to the energies of Mars, Pluto, Venus and Jupiter, but primarily to the sun.

#### SILVER

Silver is also an outstanding conductor of energies whether transmitting alone or in combination with gemstones. Certain properties that Silver contains may not be compatible with every man due to the influences that gravitationalize this element. The magnetic pull between this metal and some of humanity is almost non-essential in some instances and this is demonstrated when an individual will not wear it under any circumstances. It cannot harm one, but is totally ineffectual when not needed.

Yet Silver has a definite pull and magnetism for those attracted and drawn by its frequency for it can restore emotional perspective to a person, if their energy pattern is in harmony with its use. The moon as a reflective energy is regarded as the epitome of the sub-conscious within man. It does its work on the instinctual levels even in conducting and augmenting a gems energies that is set with it. This at times is why one may be guided to wear Silver without gems which helps quiet the heart center.

Where the Sun is tied intimately to the energies of Gold, it is the Moon that influences Silver sharing overtones with Mercury. For purpose of understanding, let us example a person with a strong Moon-Neptune energy pattern in their makeup. A Silver influence would only emphasize more of what is not required and consequently be repellent to their nature. This is how this principle works for anyone in the case of Silver versus Gold. The more the moons energies are at cross purposes with each other, the stronger the pull towards Silver.

Silver especially enhances the agate family and some of the crystalline quartz varieties because it stimulates physical alterations more readily and can be utilized at the developmental level of present humanity on a larger scale than even Gold could do in this instance. Because the Moon deals with the emotional sub-conscious within man and the agate is the personification of the Earth vibrational energies, when in combination it acts as a counter balancing force in nature that stabilizes those chaotic force currently circulating throughout mans consciousness.

Physical healing that can be promoted and augmented from a stone that is then sent coursing through this metal can produce quick results if consciously understood. However it is best not to place the more powerful or mentally oriented or extreme high frequency gems into Silver as Gold serves best in these categories.

#### COPPER

Copper as a metal is a commonly known garden variety of mineral that is found extensively throughout the planet for more than the usually understood reasons although its conductability is well recognized. In the future age of gem therapy it will become an invaluable element for healing and in gem tools. That this metal will eventually transmute and become other than it is should also be mentioned in a work of this type.

Copper is a conductor of the highest level as it carries electrical impulses from the gem itself through the metal form and on into the wearers personal **etheric** and physical force fields. This works particularly well when larger amounts of copper are mixed with Gold to create "pink Gold" when this is combined with Rubies and stones of that caliber with red overtones such as Amethyst, Garnet, Topaz, Tourmalines and of **course**, Diamonds.

#### BRASS

This metal should not be sought after by those wishing to obtain dynamic assistance from the mineral kingdom. Those currents which flow so easily through Gold, Silver, Copper, etc., are lowered and deadened in this lesser conductable metal. Though this may be of benefit in some circumstances, the lowering of gem vibratory rates makes this metal one to be avoided as an incipient ingredient of gemstone therapy.

#### **URANIUM** — PLUTONIUM

At a much later stage of mankinds evolutionary development the more

radioactive metals such as these and others will be tolerated by the human organism in a greater and non-destructive way than is possible in the now. In combination with other metals they will be able to magnify and amplify **gemstone** energy in a specialized manner. When the sixth and seventh senses are manifested and anchored into the physical level of humanity, this additive can be dealt with without undue harm and will be as necessary as it will be useful.

#### LEAD

Lead is one of the heaviest and densest metal elements that man uses. In certain instances it can help man as there are individuals who are terribly insecure in their hold on the physical level of being. Their energies are lacking in Earth anchors and may not have the necessary pull to help sustain their earth function. Lead in small, almost microscopic amounts, helps anchor "all around function" to the individual who may be lacking enough "ballast".

### 2. Gemstone Elixers and Tinctures

From the beginning of time mankind has turned to the basic elements of his physical being, the mineral kingdom, for sustenance, healing and aid towards his continued ongoing. Though now nearly lost in time, he did succeed in ages past to unlock many secrets of natures kingdom which were then utilized as mundane tools of daily living. Much of this ancient wisdom has been hidden from our "modern" civilization and is just beginning to be brought back into use via breakthroughs in understanding by both psychics and scientists. Great interest and readiness for insight into a variety of so-called phenomena is evidenced in bookstores around the globe.

With this presentation it is hoped that its "seeds" will cause even greater breakthroughs of understanding and individual experimentation. No one claims any of the following formulas, recipes or statements to be cures or miraculous potions of any kind. It is to be understood that these are given as they were received inspirationally, with little "scientific proof" at the date of this printing. They should be considered as alternative vibratory aids that can help to balance out a stricken or imbalanced area. This allows, or facilitates, the normal functioning of said area to once more take hold and control. It is hoped that each individual will follow his own inner guidance to healthier living. The individual gemstones discussed here can be seen in greater general detail in other parts of this book. Physician Heal Thyself!

#### AMETHYST

A tincture **can** be made from this gem that will be of aid to ceremonial meditations. Place an unset piece of highest quality into a clear glass bottle containing two parts distilled or spring water and one part regular grain alcohol. Cover with cap and charge in maximum sunlight for not less than five hours total time, less time giving less benefits. This can be used to raise the efficiency and magnitude of the individuals transmutational fire, hastening receptivity. This charged solution can also be used as an internal remedy for parasites of many descriptions, due to its inherent ultra violet rays.

#### **CHRYSOCOLLA**

This material when soft and not quite **gemmy** can serve in a manner of a tincture irradiated in water or in alcohol depending on the purpose and on the individual. This then will counteract bodily calcifications and tend to eradicate them wherever present.

The elixir to be made with water requires a goodly sized piece of totally clean gem material which can be reused. This is then placed in a

#### LAPIS LAZULI

Healing aspects linked to the pituitary gland and endocrine **bodies** on all levels that man responds to can be utilized with this **gemstone** in a variety of ways. First, the coloration of the individual gem determines the use of it as the most brilliant, exotic hues are not to be ground up, steamed, or placed into solutions of elixirs. The best color for this usage is the darker, less lovely shades even though many prize these shades as gems. Small amounts of pyrite inclusions are allowable if present also.

The first physical recipe given is to put a nice quality darkish blue ringstone size piece of Lapis with one to two quarts of distilled or spring water into a covered glass or enameled pot. Put the Lapis into the pan after bringing the water to a boil and then remove from the heat. Sizzles of activity frothing around the Lapis will be seen. Allow this to continue until it ceases and the solution cools down. This particular process irradiates the water and creates an elixer or solution that can be used without fear by those with pituitary, thyroid or any endocrine gland deficiency. One half ounce of this liquid per day is all that should be necessary.

To make an alcohol tincture, a sample of good solid blue rough is ground to a powder. One half ounce of this powder together with six ounces of at least 180 proof grain alcohol is placed into a dark amber glass bottle with tight stopper and set in the sun or in a sunny place for at least six weeks. This can then be strained and used with a dropper where no more than ten drops should be taken daily. Because of its potency, this form of tincture is best checked individually for dosage. When utilized correctly, this can be an aid to the male and female reproductive systems in normalizing almost atrophied function. It will tend to stimulate from every level to allow for natural augmentation along with other measures if they are being utilized. This will not increase hormone levels but can help stabilize activity where it no longer exists, relatively speaking, and can be conducive to dynamic activity where a condition is dormant but still workable.

Another manner in which the more scientific or metaphysical minded individuals can cooperate with gems present day usage is through the use of homeopathic pellots which can be made up in as many frequencies as are indicated.

For a special meditation aid, take a small glass vial or container containing a super fine fiery piece of polished Lapis and place into direct sunlight for two to four hours. Do not remove stone but take the vial wherever it is needed, for this will charge up whoever is using it at that moment to meditate with aiding in swifter connection with the inner or source self. The super charged electrons will not harm the stone nor can it hurt the user, but the gem should not be removed from vial for six to eight hours in order to allow time to de-charge the gem.

#### MALACHITE

When worn, this gem causes stimulation to the optic nerve and vision producing chromosomes of the body while also aiding the functions of the pancreas and spleen. This gem can be utilized in the three ways discussed so far, elixirs, tinctures and in homeopathic pellots. All of these remedies support the integrity of the retina and vision areas of the brain, and assist in combating cataracts. They also have a dual role in combating the tendency for diabetes and associated malfunctions of abnormal blood sugar levels.

pyrex or enamel pan of boiling distilled or spring water and then taken off of the heat. This will bring the frequency of the gem into the water and diffuse its essence to those that require assistance in this way. It is a milder version of the tincture of alcohol and should be stored in an amber glass container with tight stopper. One to two ounces of this may be used daily without harm, or follow guidance.

When preparing a tincture in an alcohol base the ground material should be placed in a darkened area, preferably damp in nature, for four weeks prior to making this formula for it already contains sufficient sunlight. More would be a deterrent as you are stabilizing the critical mass of the gem that you are grinding in this way.

The ratio of ground Chrysocolla is 2 ounces to 5 ounces of at least 180 proof grain alcohol which together are placed into a dark green glass container where it should sit for at least two more weeks before it is ready for use. Seven drops of this filtered solution is all that needs be taken by anyone in general daily usage and it is better still if one is individually checked for dosage.

Homeopathic pellets may be utilized here also and the specific frequencies that can be made will be particularly effective in the 6X, 12X and 30X range. An attunement with the lower bodies rather than the higher bodies is required, so the higher frequency range would be relatively useless.

#### EMERALD

In addition to the actual wearing of this gem, it can be used not ground up, as some have done in the past, but irradiated in a mixture of water and alcohol which is simmered down until a tincture is evolved. Two parts of distilled or spring water to one part of 180 proof grain alcohol and any hard good colored rough Emerald crystal will suffice, making sure that there is a good ratio to the quantities. To an 8 ounce fluid measure of liquid two carats of Emerald should be the minimum considered for a physical remedy and eight carats should be the maximum which gives a general idea of what is absorbable for usage here. The mixture should be broqght to a boil and then simmered in a glass pot such as a pyrex coffee maker with cover for thirty minutes. When cooled it is put into a clear glass bottle with stopper and placed in the bright sun for at least four hours. Then it is to be stored in a green glass stoppered container.

The average dosage for males is from four to nine drops in any form of liquid that is preferred to dilute it with. For females a slightly smaller dosage of two to six drops in any preferred solution. Higher dosages should be guided though no harm can come to anyone with its use.

Tinctures go particularily well and effective if taken with a good quality white or red dry wine. However any liquid would do if alcoholic taboos are reinforced by anyone undergoing a discipline at a present stage or cycle of their development.

The reason for this remedy is to use it as an earth balancer on the physical, mental and emotional levels. If there was one to consider as an overall general tonic for man, this would be it within the gem world and it is especially fine when the heart, spleenic and sacral centers are out of balance. In the higher view it acts as an internal tranquilizer and stabilizer increasing the potential for the task of understanding and perceiving earthly realities. To prepare a tincture, a ratio of two ounces ground Malachite to eight ounces of at least 180 proof grain alcohol is required. The gem material needs exposure to the sun in association with copper wire or tubing in a clear glass container for two hours a day, four days running. The sun charged material is then mixed with the alcohol and allowed to remain in a green glass container for one week whereupon it is transferred into a blue glass container there to remain for two weeks more before it is ready for use. With a dropper, no more than four drops should be used without specific determination.

When homeopathic tablets are being utilized, the strength can run anywhere from 6X to 100X and in some cases even higher depending on need. Malachite is particularly effective in this type of application.

#### MALACHITE/AZURITE

Due to the combination of these two minerals this material has properties that can act as a deterrent to abnormal cellular growth of any malignancy, melanoma, or manifested **karmic** disease when applied in the correct manner. This remedy can work internally upon the organs and body tissues much as the very dangerous and destructive cobalt and radium therapy currently in vouge in modern hospitals, but without any of the danger. This is meant to be an analogy rather than a substitution.

In making a tincture, the gem material which can be of specimen quality should be ground fine making sure that the quantities of the Azurite and Malachite are fairly equal. This is placed in direct sunlight for charging through a solar prism or prisms, clear quartz crystals, for at least eight hours before placing into solution.

The ratio here is one ounce of the powdered gem to four ounces of at least 180 proof grain alcohol. This is combined in an amber colored glass bottle with tight cap and placed in a dark place for ten weeks in order to attain potency.

A general working dosage would be about seven to ten drops in a glass of distilled or spring water taken every three to four days for a period of eight to ten weeks. Bearing in mind that most all dosages spoken of in this section are quite general and applicable to the majority, it still remains the responsibility of the healer or user to follow intuition, guidance and common sense in each instance. For those interested in homeopathic remedies, frequencies of 30X, 60X, 100X and 200X are the most suitable unless otherwise specified.

Note on Homeopathy: This method of preparing remedies is based on placing the essence of any substance into the proper frequency that can be absorbed by the bodies of man at the required or optimum level.

#### PERIDOT

The spleenic chakra is the specialty of the house here where disturbances of partial retardation due to chemical or emotional congestions can be aided with this gems stimulation through the use of the healers projections, or utilizing a remedy.

To obtain maximum vibratory rate, finely powdered Peridot is placed into direct sunlight for one to two weeks before processing. A ratio of nine carats of gem to six ounces of 180 proof grain alcohol is then placed into a yellow-green glass bottle where it is stored for a month to give it adequate time to absorb.

A dosage of three to six drops in juice or water is sufficient and can be used according to the healers **discretion**, depending on circumstances, as to how often for the diffusion power of this remedy makes large quantities superfluous. Homeopathic remedies can also be utilized here to serve as a backup to mental projections.

#### TURQUOISE

When prepared as a tincture or as a homeopathic remedy, this gem will work on the heart center **etherically** as well as in the physical organ itself strengthening and integrating it so that the blood supply can circulate freely and without impediment. It also affects memory thereby acting as a developing stimulus for the pituitary gland in a modified, beneficial way.

To prepare a tincture, place three ounces of medium to fine quality Turquoise with three ounces of 180 proof grain alcohol into an amber glass bottle for three to six weeks, depending on gem quality. No sunlight is necessary and dosage should be determined here also by guidance. As a homeopathic remedy, it operates best on a 3X to 30X frequency, generally speaking.

## 3. Instruments for Use With Healing Projection

Dictionary Definition: INSTRUMENT — "A mechanical device or contrivance; an implement; a thing with or by which something is affected; a means. SCEPTER—a wand or rod borne in the hand as an emblem or symbol of imperial power or authority".

(In the context of healing, power and authority is synonomous with understanding and realization)


The instrument, man, is a wand would he know it and placed within the breath and scope of his life is a method to operate his energy to expand, contract, inhibit, externalize, and even regenerate. Witch doctors of various cultures know the energy principle of wands but due to taboos and fear induced blockage, use it not except to pass it secretly on to the initiated.


Voodoo dolls are actually symbolic wands which have been used indiscriminately by certain individuals. They were meant to be adopted as less harmful manifestations of energy exchange to create a form of healing or accupuncture. But then the voodoo doll became the misused item of note and the downgrade became the norm. The healing became the pain and mankind digressed to a lesser condition.

"Consequently the information and use of this area of wands, or healing apparatus, is now to be unfolded gradually once again and sought only by those who would keep it hallowed. Likewise it is to be shared with caution and encased in good".

With this in mind, sharing of some of the authors experimentation with wands that fall into the "general usage" category, in that they can harm no man, follows. It is held that this newest/oldest aspect will kindle interest and activity within those who follow their own intunement.

#### **QUARTZ CRYSTAL WAND**





A — copper tubing, B — silver rod, C — tight wound copper wire, D — silver holder for xtl, E — clear quartz xtl, F — silver solder joins,


at both ends of rod, lead solder joins at both ends of wire,

Wand — 2 is a solderless version of Wand — 1, utilizing objects that can be found around the house so that anyone can make one. The dimensions and measurements are not rigid but can be fashioned to suit individual situations.

The copper wire wound around the silver rod creates a field of stabilized electromagnetic energy which augments and amplifys the energy of the quartz crystals radiations. This focus can act as a transmitter to facilitate projections of the healer.

The Clear quartz crystal is an excellent absorber of negativity and performs the unique service of assisting in the removal of its various forms from around and in an individual, a room or an area. It serves to aid in the balancing of the aura by decongesting the various force centers which can get stirred up from time to time. This wand or any object of this nature has few written or externalized instructions. Guidance for its use comes from within the seeker or practitioner with right motivation and intent. There is hardly a limit to application.

Decrystallization is what, in essence, the Pearl does silently and repetitively when worn as not only does it absorb and carry negativity, it enables many locked in negative crystallized patterns of thought and action to dissipate by the very retention of the negative force field. This, on an unconscious level, creates a vortex whereby these difficulties can alter. Individuals without these problems seldom wear Pearls. Others are quite drawn to them and instinctively utilize them.

Because of the Pearls properties mentioned here and in other chapters, an instrument can be made to help many individuals to quicken these very processes. This neptunian trident shape is an active manifestion of spiritual forces set into physical, metallic form for use in aiding energies difficult to contain and control. This is especially true in forcefields of extreme negativity which can cause so much confusion in mans emotional thought processes made **possible** by the ego and narrow field of thought **surrounding** most of mankind.

The combined energies of Neptune, which is the higher octave of Venus, and the reflective emotional sub-conscious, which is the moon, can work together harmoniously to redeem mans congested desire nature and blocked emotions of anger, hate and resentment caused by mis-applied energy patterns of these planetary frequencies. The distortions of misunderstanding that man brings upon himself **occuring** through the force field of these three planetary spheres can be neutralized effectively by the usage of this instrumentation.

A genuine natural Pearl is required here and fresh water baroques serve equally well. The built up negativity should be released from the Pearl after each working session. This is accomplished by allowing cool, fresh water to run over it for several minutes. It is also a good idea to replace the Pearl with a new one once or twice a year depending on usage. Experimentation is also taking place utilizing certain other gems in this same wand in place of the Pearl.

## Addendum:

#### THE CELESTIAL IMPRINT OF GEM CRYSTALS

the CRYSTALS, the seed of the germinated rock, the genetic pattern of the cosmic root stock,

the energies that lie hidden and trapped inside a cube or a hexagon or ortho-rhomboid aside,

the dazzling beauty of the cosmic sperm, gathering speed and sound to connect to the ovum in turn,

will bring forth the children of the universe frozen in space, so fine in their structure, so fair of their face.

Just as this planet is a being that lives and breathes, so too can one compare the vast crystalline mineral deposits on or beneath its surface as parts of a layer or layers of skin that are part of this beings "garment". These garments serve or function at levels necessary for balance, harmony and equilibrium within these garments. So the mineral envelope, particularly the crystal, can be considered as a portion of Terra's skin, some indigenous, some grafted, yet never static but ever expanding.

The mystique that ultimately lies within the gem crystal is answerable to the actual science of the atom at every level, known and unknown, to present day consciousness. As was given, each element of matter contains within its own inherent structure the microcosm that relates it to the unified and infinite macrocosm of universes and galaxies. So too does the story behind each crystal formation tell its tale of cosmic truth.

Within the mineral kingdom, as in every other, there exists a grand or ground archetype which is its particular keynote or sound wavelength. In the evolution of each crystal gem, the specific structure of its composition determines the type of energy and quality of its potential for service to the planet, the seven crystal growth systems noted in scientific texts relate to the occult seven such as the seven rays, etc. The differing types of crystal families serve to create their own unique properties in terms of energy charge and discharge. One crystal form is not higher or lower than another but should be thought of as alternate currents of consciousness. The various paths are just that, differing modes of arriving at the same central point, unity in diversity. These then are the boundaries for the limitations that exist within the possibilities of each crystal structure correlating to the planetary "beings" or influences from which each crystal draws its source of power.

The atoms, as it were in the crystalline formation of gems, reflect the frozen or "trapped in form" side of nature that adheres to the same law of refractive wavelengths that specify their function. They can be likened unto the cell in each portion of the physical body in that they live, breathe, move and react on their own plane of existence, complete unto themselves.

The development of minerals and crystals will continue at what could be called an accelerated pace. The conditions of ever increasing planetary stress and strain that are becoming the Earth and its climates, both inner and outer, will be conducive to high pressures, temperature extremes, as well as elemental erosion and explosion. This will be a wonderful seed bearing time upon this portion of the solar system, for many new improvements in gem evolvement could take place wherein some of the structure mentioned earlier in the gem text would bear positive physical fruit, being born in a new time and dimension.

The gem and mineral kingdom rapidly gains more responsibility for the inner repair of the planet. Consequently there is accelerating crystal formation and exposing, releasing and charging energy fields at an incredible rate of vibratory momentum. Diamonds are losing as well as building up energy levels, or reservoirs of power, in various centers or pockets of global locale. Existing gems already in use will become as storage batteries of even higher voltage affecting even stronger an individuals higher and astral bodies. Utilizing gems with some level of intelligence and understanding therefore could and should increase one's level of efficiency.

Irregularities in crystal formation do not necessarily mean superfluity. It can also indicate hastened evolution of a particular momentum in a particular crystalline formation due to an excess of planetary forces impinging upon that crystal or crystals. This is not to imply a "bastard" or derelict circumstance, but rather that there is "extra" or excess energy flying out from that crystal giving an additional spark to its physical expression. Now not all irregularities are positive in nature but most, such as a twinning for example, are indicative of these statements.

This phenomenon is closely akin and often very *similar* to the sperm/ovum reproduction of the human line of evolution. Yet because the atom of the gem crystal is self contained or androgynous, it "gives birth to **itself**"—theprocess just described as twinning.

The disproportionate distortions that occur in crystal formations exist for two reasons not apparent to the consciousness of mankind as yet. One, where inner experimentation of atom propulsion has created an entity or mutation of inharmony which is useless for constructive service, an improper finale to an alteration that did not quite serve, and two, where such deliberate juxtapositioning of atomic structures are created for the specific purpose of enlarging the potential in a particular gems line of evolution and/or transition from one level of achievement to another, a distinct departure for an improvement of the atomic molecules.

A right or left orientation in these instances are either yin dominant or yang dominant, as the two or dual forces existing in this are of the form side of vital matter as well.

The pseudomorph phenomenon that often results in a baroque type formation is generally the beginning of a new line of atomic structural experimentation that with time and development will result in an acceleration of certain kinds of gems. In point of fact, whenever a gem is spored in, or already developed and ready for initiation (expansion), whether from this seeded planet or from others in other galaxies throughout the universes, whatever its present state, nebulosity of formation is the precursor of drastic changes that are slated for it.

As was given before, the gem Kunzite is on the de-evolving arc upon this planet's physical plane. However this does not necessarily mean that the gem will disappear, on the contrary for this gem crystal is ready of its own initiation expansion. Therefore it is being prepared via **pseudomorphic** breakdown for another atomic set altogether, with another level of progress open to it as it begins to graduate from the limitations and boundaries of the mineral kingdom.

#### **HEALING CONCEPTS**

The reconstruction or re-integration of energy within an auric field, of course, is the major issue confronting those who are interested in the metaphysical side of illness. Developed gem crystals are able to augment and re-align vibratory rates that in turn adjusts cellular activity in the physical organism which can lead to substantial help for the human. The often asked question as to crystals being tuned must remain unanswered until the term tuning is redefined. To tune an individual crystal in order to "guarantee" a certain result is sure to fail because the approach should be placed differently. For instance the individual's capacity and level of consciousness itself is the beginning whereby that, or indeed any other crystal, will either gain or lose life force.

To understand the premise that everything in and around the universe consists of vibratory wavelengths, etc, means that every magnetic field cellularly will be affected by everything that impinges upon it according to the rate and state of **vibrational** essence that it "rubs elbows" with. Taking a rock crystal which seems to be a popular and good focus, this crystal with the seed qualities that it contains can be affected because it is a frozen but viable magnetic field acting in conjunction with whatever and whomever is surrounding it. The individuals **understanding** will directly affect the escalating magnetism of that rock crystal according to the amount of conscious understanding released at that moment.

If a scientist is aware of the power of the atom although the atoms are unseen, then anyone who becomes or accepts awareness of the living magnetic forces in and around a crystal of any type is in the same condition as that scientist. Awareness at any level becomes the instrumentation whereby the effectiveness is enhanced because of the automatic acceptance of this THEORY AS A REALITY. The secret of understanding or the accrual working with crystal instrumentation whether for healing, or for transmutational intunements such as meditations, personal growths, etc. is again the "Acceptance" on faith or trust in the **cosmically** scientific postulation of the crystals inherent value in the state that its atoms have developed into.

Again, in order to "Cure", it is a matter of the individuals consciousness and capacity to "See" the relative levels in between the physical spaces. A magnetically tuned gem cannot directly affect the physical body, but must first contact the astral or psychic bodies before resulting in an auric change that will possibly be felt in the physical structure.

#### **KIRLIAN PHOTOGRAPHY**

To observe the effect of any crystal entering an individuals auric field would be quite interesting. There would be different levels of energy force released according to need, the amount inherent in the particular crystal as well as the aura being contacted by it. If an individual is severely depressed and withdrawn, the energy exchange being charged will be lower and more gradual in output and volume let us say, than an individual suffering from extreme hyper-neurosis. That would indicate a different set of magnetic currents in operation which in this instance would bring a gradual reduction of brain waves until the magnetic structure has neutralized or normalized that pattern.

Kirlian photography potential in this field is to be very encouraged as this when scientifically seen with data taken over a substantial period of time will be part of the incoming science of the future New Age. This could and should be a part of the technology of the holistic healing processes that will be studied and formulated for generations to come. It is almost a responsibility of those who are in the vanguard of this "Crystal Movement" to elicit and obtain from it the data that is necessary to put it in its rightful place for all to see. Gaining a toehold on this medium will afford a greater peek into universal realities. When the potential of the atom and its wavelengths can be understood in terms of cellular biology and the structures within frozen energy such as the crystals, then the secrets of life itself will be recognized as having dimensions beyond what the human being can see and accept.

#### **CRYSTAL MYTHS**

The illusions that humans have concerning the powerful auras and abilities of crystals and rocks that are mystical and supposedly deeply occult with records hidden from the profane type way of seeing the egoic reflection are just that, illusions. This can be caused by misapplication of the intuitive perceptions that arise from the appearance and feeling of vibratory emanation while observing a crystal or gem. This is mostly due to the need of humankind for an explanation of the **un-explainable**, illogical and self-limiting as it may be, for why would a spiritual record of anything be kept or trapped inside a crystal natural or faceted? What would the purpose be of limiting and creating a boundary for inner plane recording?

To talk to a crystal or communicate with it is only possible through the ability to differentiate vibratory wavelengths and swim within them with the higher psychic bodies. This almost no human can really do so the word has been romanticized. Only can a feeling be transmitted which can be audible to a few, or felt astrally by sensitives. The rest is mostly human wish gratification fulfillment.
