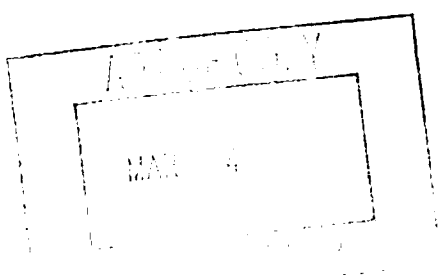

The purpose in filing this petition is to get a restraining order. Any other relief required (support, custody, etc.) will be decided by the judge that hears my case.

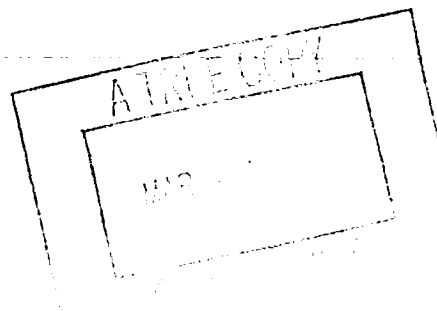
